

# Minnesota Rules: Amendments and Additions =

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION in the Official Notices section of the State Register. When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety in the State Register, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the Minnesota Guidebook to State Agency Services.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. # **Proposed Rules**

Pursuant to Minn. Stat. §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the State Register. The notice must advise the public:

- 1. that they have 30 days in which to submit comment on the proposed rules;
- 2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
- 3. of the manner in which persons shall request a hearing on the proposed rules; and
- 4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the State Register.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

#### **Rules as Proposed**

#### 7825.2390 PURPOSE.

The purpose of parts 7825.2390 to 7825.3000 7825.2920 is to allow a means by which enable regulated gas and electric utilities may to adjust for increases and decreases rates to reflect changes in the cost of energy delivered to customers that are different from those costs authorized by the commission in the utility's most recent general rate case. Energy costs included in rate schedules are subject to evidentiary hearings in general rate cases filed by the utility. Proposed energy cost adjustments must be submitted before billing to the Department of Public Service. Annual evaluation evaluations of energy cost adjustments must be are made by the Department of Public Service and others as provided for in parts 7825.2390 to 7825.3000 7825.2920.

When a utility proposes new or revised electric energy or purchased gas adjustment provisions, the proposal is considered a change in rates and must be reviewed according to commission rules and practices relating to utility rate changes.

#### **7825.2400 DEFINITIONS.**

Subpart 1. Scope. For the purpose of The terms used in parts 7825.2390 to 7825.3000, the following definitions apply 7825.2920 have the meanings given them in this part.

- Subp. 2. Annual sales volume. "Annual sales volume" is the sum of the Mcf, Ccf, or Btu of gas delivered during the most recent 12 months of the 14-month period, for which actual data are available, preceding a change in the city gate rate or end of the heating season for which actual data is available demand-delivered gas cost.
- Subp. 3. Annual demand sales volume. "Annual demand sales volume" is the annual sales volume adjusted by an average percentage change in sales computed over the preceding three-year period, normalized for weather. Annual demand sales volume shall include includes interruptible sales to the extent that demand cost is incurred to service interruptible customers.
- Subp. 4. Base <u>electric</u> cost. "Base <u>electric</u> cost" is the <u>eost of peak shaving gas volumes or the</u> cost of fuel consumed in the <u>manufacture of gas or generation of electricity</u> and <u>purchased gas or the cost of purchased power in the base period expressed as a cost per kilowatt-hour sold or eost per Mef, Cef, or Btu sold.</u>
- Subp. 4a. Base gas cost. "Base gas cost" is the cost of purchased gas established in the base period and expressed as a cost per Mcf, Ccf, or Btu sold.
  - Subp. 5. Base period. "Base period" is the 12-month period during which the automatic adjustment of charges is set at zero.
  - Subp. 5a. Btu. "Btu" means British thermal unit.
  - Subp. 6. [See Repealer.]
  - Subp. 6a. Ccf. "Ccf" means 100 cubic feet.
  - Subp. 6b. Commission. "Commission" means the Public Utilities Commission.
  - Subp. 6c. Commodity. "Commodity" means the volume of gas delivered.
- Subp. 6d. Commodity-delivered gas cost. "Commodity-delivered gas cost" is the cost of gas charged a distributing gas utility for its gas supplies and supply-related services which is a function of the volume of gas taken. It refers to the cost of gas at the point at which the distributing utility takes title to the gas and associated costs incurred to bring the gas to the utility's distribution system, including for example: gathering, transportation, processing, storing, and balancing costs, taxes, and other charges.
  - Subp. 7. to 11. [Unchanged.]
- Subp. 12. Cost of purchased gas; incorporation by reference. "Cost of purchased gas" is the cost of gas as defined by the Minnesota uniform system of accounts, class A and B gas utilities, account including accounts 800, 801, 802, 803, 804, 808, and 809 and purchased under federally regulated wholesale rates 804.1, 805, 805.1, 806, 807, 808.1, 809.1, 810, 823, 842.1, 854, and 858 for energy delivered through interstate facilities purchased, as provided by Code of Federal Regulations, title 18, part 201, as amended through April 1, 1988. These accounts are incorporated by reference. All gas public utilities shall use this definition regardless of class.
  - Subp. 13. [Unchanged.]
- Subp. 13a. Demand. "Demand" means the maximum daily volumes of gas that the utility has contracted with a supplier or transporter to receive.
- Subp. 13b. Demand-delivered gas cost. "Demand-delivered gas cost" is gas supply and supply-related service costs other than the commodity-delivered gas cost, including, for example, the fixed cost determined by contract, and other charges.
  - Subp. 13c. Department. "Department" means the Department of Public Service.
- Subp. 13d. Design day. "Design day" means a 24-hour-day period of the greatest possible gas requirement to meet firm customer needs.
  - Subp. 14. [See Repealer.]
  - Subp. 15. [Unchanged.]
  - Subp. 15a. Kwh. "Kwh" means kilowatt-hour.
  - Subp. 15b. Mcf. "Mcf" means 1,000 cubic feet.
  - Subp. 16. and 17. [Unchanged.]
  - Subp. 18. Test year. "Test year" is the period of 12 consecutive months used for evaluating a need for a change in rates.

## **Proposed Rules 3**

Subp. 19. Test year demand volume. "Test year demand volume" is the amount of demand approved by the commission and occurring during the test year.

### 7825.2500 APPLICABILITY AND TYPES OF AUTOMATIC ADJUSTMENT OF CHARGES.

The commission shall permit the filing of rate schedules containing provisions for the automatic adjustment of charges provided the provisions conform to parts 7825.2600 to 7825.3000 7825.2920. Parts 7825.2390 to 7825.3000 7825.2920 are applicable to all classes of public utilities.

Provisions for automatic adjustment of charges must encompass:

- A. [Unchanged.]
- B. Changes in cost resulting from changes in the federally regulated wholesale rate commodity-delivered gas cost and demand-delivered gas cost for purchased gas and changes in the cost of fuel consumed in the manufacture of gas or peak shaving gas volumes. This provision is entitled purchased gas adjustment.

#### 7825.2600 ELECTRIC ENERGY ADJUSTMENT.

<u>Subpart 1.</u> Computation generally. The computations of the automatic adjustment to charges must conform to the procedures set forth below in this part.

The amount of the billing period adjustment to charges must be determined by extending Kwh of kilowatt-hour sales in the billing period by an adjustment per Kwh. The adjustment per Kwh or the amount of the adjustment must be stated on the customer's bill to comply with parts 7820.3500 and 7820.3600.

- <u>Subp. 2.</u> Adjustment per Kwh. The adjustment per Kwh is the sum of the current period cost of energy purchased and cost of fuel consumed per Kwh less the base <u>electric</u> cost per Kwh; <u>except that upon commission approval.</u> <u>However</u>, a utility that purchases at least 75 percent of its annual total Kwh sales may also separately add, <u>upon commission approval</u>, an additional adjustment per Kwh equal to the difference between the purchased demand cost and the base <u>electric</u> cost of purchased demand. This purchased demand cost adjustment is to be computed annually for the previous year less the demand base <u>electric</u> cost per Kwh.
- <u>Subp. 3.</u> When adjustments calculated, applied. The adjustment to charges must be made in the next complete billing period succeeding the determination of the adjustment per Kwh, provided the adjustment has been filed as defined by part 7825.2900, subpart 4. The adjustment factor must be calculated monthly. Except, upon commission approval However, a self-billing utility may calculate the adjustment less frequently, upon commission approval but at least annually, and shall provide for a settlement procedure. The adjustment must be applied each month. The adjustment amount must be rounded such that the projected recovery is within two percent of the change in total cost.

#### 7825.2700 PURCHASE GAS CHARGES, AUTOMATIC ADJUSTMENT.

<u>Subpart 1.</u> Computation generally. The computation of the automatic adjustment of charges must conform to the procedures set forth  $\frac{1}{2}$  this part.

The amount of the billing period adjustment to charges must be determined by extending applying an adjustment per Mcf, Ccf, or Btu sales in the billing period by an adjustment per Mef, Cef, or Btu. The adjustment per Mcf, Ccf, or Btu or the amount of the adjustment must be stated on the customer's bill to comply with parts 7820.3500 and 7820.3600.

- Subp. 2. New base gas cost. A new base gas cost must be submitted as a miscellaneous rate change to coincide with the implementation of interim rates during a general rate proceeding. A new base gas cost must also be part of the rate design compliance filing submitted as a result of a general rate proceeding. The base gas cost includes a commodity base cost and a demand base cost. The base gas cost for each class is determined by dividing the estimated base period cost of purchased gas for each class by the estimated base period annual sales volume for each class.
- Subp. 3. Adjustment per Mcf, Ccf, or Btu. The adjustment per Mcf, Ccf, or Btu is the sum of the commodity adjustment, demand adjustment, peak shaving gas adjustment, and manufactured gas adjustment as computed below:, and true-up adjustment. The adjustment per Mcf, Ccf, or Btu must be applied to billings whenever the change in commodity-delivered gas cost and demand-delivered gas cost exceeds \$0.03 per 1,000,000 Btu's. Subject to commission approval, a gas utility may include in its rate schedules a provision to apply an automatic adjustment of charges to billings on a more frequent basis to reflect changes in the commodity-delivered gas cost or in the demand-delivered gas cost. If there has been no automatic adjustment of charges for three months, the adjustment must be made three months from the date of the last adjustment. Adjustments must be filed under part 7825.2910.
- A. Subp. 4. Commodity adjustment. The commodity adjustment is the difference between change in the commodity eost rate which results from a change in difference between the city gate rate commodity-delivered gas cost and the commodity base cost.

To properly reflect adjustment per Mcf, Ccf, or Btu billed, the divisor for a particular class of customer must include total sales volume <u>forecasted to be</u> delivered to that class of customer <u>over a budgeted 12-month period</u>. The adjustment must be applied to billings after the effective date of the commodity rate change provided the adjustment has been filed as defined by part 7825.2900, subpart 1.

B. Subp. 5. Demand adjustment. The demand adjustment is the difference between change in the annual demand eost rate which results from a change in difference between the city gate rate demand-delivered gas cost and the demand base cost. In the event the demand city gate rate demand-delivered gas cost does not change, the demand adjustment must be recalculated for each 12-month period from the date of the last change. The adjustment must be computed using test year demand volumes for three years after the end of the utility's most recent general rate case test year. After this time period, the demand adjustment must be computed on the basis of annual demand sales volume and applied to billings after the effective date of the demand rate change provided the adjustment has been filed as defined by part 7825.2900, subpart 1.

C. If a customer class is billed separately for demand, the demand adjustment must be computed on the basis of the demand component of the rate for that class and applied to the demand charge.

<u>Subd. 6.</u> **Peak shaving and manufactured gas adjustment.** The peak shaving adjustment or the manufactured gas adjustment is the difference between the cost of propane or fuel consumed in the manufacture of gas during the heating season and the peak shaving or manufactured gas base cost. The peak shaving or manufactured gas adjustment must be computed annually for the heating season ending April 30 of each year on the basis of <u>forecasted</u> firm annual sales volume, adjusted to the extent peak shaving gas or manufactured gas is used to serve interruptible customers—; <u>and to that extent</u> the cost of peak shaving gas or manufactured gas must be applied to interruptible customers. The adjustment must be applied to billings during the next 12-month period commencing on June September 1 of each year provided the adjustment has been filed as defined by <u>under part 7825.2900</u>, subpart 4 7825.2910.

Subp. 7. True-up amount. The true-up amount is the difference between the commodity and demand gas revenues by class collected by the utility and the actual commodity-delivered gas cost and demand-delivered gas cost by class incurred by the utility during the year. The true-up adjustment must be computed annually for each class by dividing the true-up amount by the forecasted sales volumes and applied to billings during the next 12-month period beginning on September 1 each year, provided that the adjustment has been filed under part 7825.2910, subpart 3.

Subp. 8. Refunds. Refunds and interest thereon on the refunds, that are received from the suppliers or transporters of purchased gas that are and attributable to the cost of gas previously sold, must be annually refunded by credits to bills or eheck within a period not to exceed 90 days from the date the refund is received from a supplier, provided the refund amount per customer is equal to or greater than five cents. Upon approval of the commission, refunds of less than five cents per customer may be retained by the utility and separately accounted for until such time as the balance, together with additional supplier refunds, produces a refund of five cents or more per customer. Refunds must be made to each customer class on the same basis as previously charged to customers. If a supplier refund cannot be accurately distributed to customers because of seasonal usage patterns, then upon commission approval, refunding may be delayed for a period of up to 12 months, except that cumulative refund amounts equal to or greater than \$5 per customer must be refunded within 90 days from the date the refund is received from a supplier or transporter. Refunds must be allocated to customer classes in proportion to previously charged costs of purchased gas. Within classes, the refund amount per unit must be applied to bills on the basis of individual 12-month usage. The utility shall add interest to the unrefunded balance at the prime interest rate.

#### 7825.2800 ANNUAL REPORTS; POLICIES AND ACTIONS.

All public utilities shall file annually on September 1 of each year the procurement policies for selecting sources of fuel and energy purchased, dispatching policies, if applicable, and a summary of actions taken to minimize cost <u>including conservation actions for gas utilities</u>.

#### 7825.2810 ANNUAL REPORT; AUTOMATIC ADJUSTMENT CHARGES.

Subpart 1. Gas and electric utilities. By September 1 of each year, all gas and electric utilities shall submit to the commission an annual reporting by month of all automatic adjustment charges for each customer class for the prior previous year commencing July 1 and ending June 30. This report must include:

A. the commission-approved base cost of fuel or gas as defined by part 7825.2400, subpart 4 or 4a;

- B. billing adjustment amounts, such as Kwh, Mcf, Ccf, or Btu, charged customers for each type of energy cost, such as nuclear, coal, purchased power, purchased gas by major component, peak shaving gas, or manufactured gas;
  - C. [Unchanged.]
  - D. the total cost of fuel or gas delivered to customers including, for gas utilities, the cost of supply-related services;
  - E. to G. [Unchanged.]
- Subp. 2. Additional information from gas utilities. In addition to the requirements in subpart 1, gas utilities are required to report:
- A. purchased gas adjustment rule variances in effect or requested during the 12-month reporting period and reasons why those variances were necessary;
  - B. changes in demand contracted for during the reporting period and reasons for those revisions;
- C. the level of customer-owned gas volumes delivered through the utility's distribution system under retail transportation tariffs during the reporting period; and
  - D. a brief explanation of deviations between gas cost recovery and actual gas cost during the reporting period.

#### 7825.2830 ANNUAL FIVE-YEAR PROJECTION.

- By September 1 of each year, all gas and electric utilities shall submit to the commission a five-year projection of fuel and gas costs by energy source by month for the first two years and on an annual basis thereafter.
- By September 1 of each year, each gas utility shall submit to the commission a brief statement of its opinion on the impact of market forces on gas costs for the coming year.

#### FILING FOR AUTOMATIC ADJUSTMENT OF CHARGES

#### 7825.2900 FILE UPON CHANCE OF AUTOMATIC ADJUSTMENT OF CHARGES FILING BY ELECTRIC UTILITIES.

- Subpart 1. Filing required. Whenever a public When an electric utility changes its automatic adjustment of charges, the utility shall prior to, before the effective date of the change, shall file the following:
  - A. a summary of the computation of the adjustment-;
- B. an explanation of significant changes between the base cost and current cost. Changes for electric utilities shall be quantified as to price, mix, thermal efficiency, and distribution loss. Changes for gas utilities shall be quantified as to price and mix changes.; and
- C. a computation of standard cost for the current reporting period, if available. The standard cost for this computation may be either the planned or budgeted cost of fuel or simulation of the cost of fuel under normal operating and purchasing limits for the adjustment period or current period.
  - Subp. 2. to 4. [See Repealer.]

#### 7825.2910 FILING BY GAS UTILITIES.

- Subpart 1. Monthly reports. Gas utilities shall submit monthly to the department purchased gas adjustment reports, which must include:
  - A. a summary of adjustments that were implemented in the previous month and the computation of each adjustment;
- B. an explanation of significant changes between the base gas cost and current cost, quantified as to changes in price and source of gas;
  - C. the estimated previous month's and year-to-date commodity-delivered gas cost by supplier;
- D. estimated gas volumes purchased from suppliers whose gas rates are not regulated by the Federal Energy Regulatory Commission; and
- E. estimated costs of gas purchased in item D expressed as a percentage of all commodity-delivered gas costs and demand-delivered gas costs.
  - The department shall summarize the monthly reports every three months and submit the summary to the commission for review.
- Subp. 2. Filing upon change in demand. Gas utilities shall file for a change in demand to increase or decrease demand, to redistribute demand percentages among classes, or to exchange one form of demand for another. A filing must contain:
  - A. a description of the factors contributing to the need for changing demand;

- B. the utility's design-day demand by customer class and the change in design-day demand, if any, necessitating the demand revision;
  - C. a summary of the levels of winter versus summer usage for all customer classes; and
  - D. a description of design-day gas supply from all sources under the new level, allocation, or form of demand.
- Subp. 3. Notice. A gas utility shall provide notice to the intervenors in its previous two general rate cases of the availability of the change in demand filing when it submits the filing to the department.
- Subp. 4. True-up filing. Gas utilities shall file and implement on September 1 of each year the true-up adjustment computed under part 7825.2700, subpart 7, for the previous year commencing July 1 and ending June 30.

#### 7825.2920 APPROVAL FOR AUTOMATIC ADJUSTMENT OF CHARGES.

- Subpart 1. Approval. Automatic adjustment of charges filed under parts 7825.2900 and 7825.2910 are provisionally approved and may be placed into effect without commission action, but subject to the conditions in subparts 2 and 3.
- Subp. 2. Errors. Errors made in adjustment must be refunded by check or credits to bills to the consumer in an amount not to exceed the amount of the error plus interest computed at the prime rate upon the order of the commission if (1) the order is served within 90 days after the receipt of the filing defined in part 7825.2900 or 7825.2910 or at the end of the next major rate proceeding, whichever is later, and (2) the amount of the error is greater than five percent of the corrected adjustment charge.
- Subp. 3. Commission action. The commission, on complaint or on its own motion, and after appropriate investigation, notice, and hearing, may issue an order to fix at current levels, discontinue, or modify an automatic adjustment provision for an individual utility.
- IMPLEMENTATION. Existing variances to parts 7825.2500, 7825.2700, 7825.2810, and 7825.2900 in effect on the effective date of these amendments to parts 7825.2390 to 7825.3000, are modified to eliminate conflicts with parts 7825.2390 to 7825.2920, as amended, on and after the effective date of these amendments.
- INSTRUCTION TO REVISOR. The revisor of statutes shall change the term "7825.3000" to "7825.2920" in part 7825.3100, subpart 9, in the next and subsequent editions and supplements of Minnesota Rules.
- REPEALER. Minnesota Rules, parts 7825.2400, subparts 6 and 14; 7825.2900, subparts 2, 3, and 4; and 7825.3000, are repealed.

# **Adopted Rules**

- increasing property values and property taxes which pressure farmers to sell out,

- costs to local governments to provide services (such as roads, road maintenance and additional police and fire personnel) to rural, non-farm residents compared to property tax revenues (a study by Resource Management Consultants has this information).

Aspects of the program which could be explained include: planning grants to counties, planning and ordinance requirements, the state review process, landowner covenants and technical assistance. The experience of the counties participating in a recently completed pilot project would likely be useful and illustrative for communicating these aspects. ## Request for Proposals for Technical Evaluation of Hazardous Waste

#### I. INTRODUCTION

The Minnesota Pollution Control Agency (MPCA) is responsible for protecting the state's air, water and groundwater quality, and for ensuring the responsible management of solid and hazardous wastes. The MPCA is developing a state Capacity Assurance Plan (CAP), as required under the Superfund Amendments and Reauthorization Act section 104(c)(9). The CAP will document Minnesota's progress in developing a comprehensive system to manage its hazardous wastes.

Since the early 1980s, waste minimization has been a major component of Minnesota's hazardous waste management program, and will continue to play an important role as part of the State's plan to meet the capacity assurance requirements. Waste minimization consists of the source reduction and on and off-site recycling of hazardous wastes. Progress in reducing waste generation will decrease the need for new hazardous waste management facilities.

Through this RFP, the MPCA is seeking assistance to evaluate the success of Minnesota's present waste minimization programs, to project future results, and to assess the need to modify existing programs and/or develop new programs to foster waste minimization.

#### II. DESCRIPTION OF CURRENT PROGRAMS

The MPCA administers several programs designed to encourage and/or assist generators in minimizing the quantity of hazardous wastes generated in the state:

• The Minnesota Technical Assistance Program (MnTAP). MnTAP's primary objective is to encourage industrial waste reduction and foster improved waste management. To achieve this objective, MnTAP offers a variety of technical assistance services.

<u>Telephone Consultation</u>. Since MnTAP's inception in 1984, over 2400 generators received technical assistance through telephone consultation with MnTAP staff. The most common areas of assistance include current waste management needs, waste reduction opportunities, and regulatory compliance.

On-site Consultation. MnTAP provides on-site consultation services when telephone consultation is not sufficient to meet the needs of generators seeking technical assistance. Through December 1988, 219 on-site visits to generator facilities have been conducted by MnTAP staff.

<u>Student Interns</u>. Interns are placed in an industrial setting and work directly with company representatives to promote waste reduction concepts. The interns conduct in-plant audits, gather technical and vendor literature, evaluate product substitution and process modifications, identify recycling and reuse options, recommend waste reduction options, conduct preliminary design work, and assist the company in implementing the selected recommendations. Students also document the waste reduction achieved so that the acquired knowledge can be used to assist other companies with similar waste disposal problems. MnTAP sponsors 5-6 interns each year.

## State Contracts and Advertised Bids

<u>Clearinghouse</u>. MnTAP develops fact sheets, distributes a quarterly newsletter, and administers a library of vendor and technical literature. Industry-specific workshops and waste reduction conferences are also periodically offered through MnTAP.

<u>Research awards</u>. MnTAP recently completed a two-year small quantity generator Research Awards Program. The program was designed to provide small quantity hazardous waste generators with new technologies for waste reduction, and innovative uses of existing technologies such as scaled down applications. The reports from the projects identify waste reduction opportunitites that have direct application to small and medium-sized generators.

<u>EPA-Funded Research</u>. MnTAP recently started work on a solvent waste reduction project. A separate project emphasizing improved rinsing techniques for the metal finishing industry in also in progress.

- <u>Hazardous and Industrial Waste Reduction Grant Program</u>. This program was established in 1984 to assist Minnesota generators seeking to study the feasibility of applying specific methods and technologies to reduce the generation of hazardous and nonhazardous industrial wastes. To date, 15 grants have been awarded. A total of \$409,684 in state funds and \$211,829 in matching funds from the applicants have been allocated to complete these projects. Eligible projects include studies of the applicability of existing methods or technologies to a particular manufacturing or production process, and research oriented projects designed to determine whether a new reduction method or technology could be applicable to generators in Minnesota. Information obtained from the feasibility studies is made available to Minnesota generators through MnTAP.
- Fees and Taxes. A special waste-end tax is imposed on generators of hazardous wastes based on waste volumes and management methods. This places a direct tax burden on waste generators which can be decreased in direct proportion to the amount of waste reduction accomplished. This tax funds the Minnesota Superfund and provides the State match required for federal Superfund remedial action dollars.

In addition, fees are charged to hazardous waste generators based on waste types and volumes generated. Management method discounts are provided, with recycling activities awarded the largest discount. Generator fees assist in funding state and county hazardous waste regulatory programs.

• <u>Biennial Reports on Waste Minimization</u>. Generators provide detailed reports on waste minimization activities. The quantities and percent of waste generated, recycled and prevented are reported along with answers to specific questions on waste minimization. The data are used to quantify hazardous waste minimization and to project the future impact of waste minimization. Both large and small-quantity generators report on their activities.

Additional information regarding the current waste minimization programs offered by the State of Minnesota may be found in Hazardous and Industrial Programs—1988 Program Evaluation Report. Other background information is contained in the MnTAP Biennial Report for 1987-1988. Rules governing the Hazardous and Industrial Waste Grant Program, and copies of blank EPA Biennial Reports on Waste Minimization may also be made available upon request. Other information may be made available upon request.

#### III. SCOPE OF WORK

The MPCA is seeking proposals from qualified firms to perform the project outlined in this proposal. The scope of the project is to evaluate specific aspects of the MPCA's hazardous waste minimization programs and to assist staff in developing recommendations to improve the effectiveness of the programs. The selected consultant will design and carry out six tasks to complete this project:

#### **TASK 1: Waste Reduction Grants Program Evaluation**

- Develop questions for 10 Waste Reduction Grant and 9 MnTAP Research Awards recipients;
- Interview (telephone or on-site) Waste Reduction Grant and Research Awards recipients, and MnTAP staff; and
- Summarize and analyze interview responses to determine the effectiveness of the grants programs, quantify waste minimization achieved.

#### TASK 2: MnTAP Services Evaluation

- Develop a mail survey to solicit qualitative responses from potential MnTAP users regarding MnTAP services;
- Mail survey to the 1000-plus users identified in MnTAP mailing list;
- Collect and compile information on results of MnTAP on-site visits and the intern program; and
- Using responses to the survey <u>and</u> information obtained from MnTAP, analyze the effectiveness of MnTAP's services, including waste minimization achieved.

#### TASK 3: Biennial Reports Evaluation/Comparisons

• Using data reported in the 1987 EPA Biennial Report on Waste Minimization by the state's 350 large quantity generators, determine which factors encourage waste minimization. Summarize, evaluate and make comparisons of various data. Tasks include

summarizing, evaluating and making comparisons of waste prevented/recycled to: audits conducted, waste minimization information, barriers/incentives, and corporate pollution prevention policies. Both manual and computer-aided manipulation of data may be necessary to complete this task.

• Summarize, evaluate and make comparisons of qualitative responses reported in the 1987 EPA Biennial Report on Waste Minimization by a select number of the 5500 small quantity generator respondents.

#### **TASK 4: Other Waste Minimization Programs**

• Collect and analyze existing information on other state waste minimization programs. A select number of waste minimization programs administered by other states shall be analyzed. Programs identified in this task shall be incorporated in the surveys detailed in Task 5.

#### TASK 5: Minnesota Generator Surveys

- Develop surveys to solicit generator input to determine which programs and/or market factors (e.g., costs of management and transportation) are most effective in encouraging waste minimization. Separate surveys will be required for each of three different survey populations based on the quantity of hazardous wastes generated annually: large (> 1000 kg/month), small (100-1000 kg/month) and conditionally exempt (< 100 kg/month) generators). The surveys shall include questions addressing both positive incentives (e.g., MnTAP and grants) and negative incentives (e.g., fees and taxes) to encourage waste minimization, and any barriers that may be inhibiting waste minimization activities in Minnesota. The survey must evaluate existing Minnesota programs and other programs such as waste minimization equipment grants, waste minimization equipment loans, audit grants, and a program to encourage larger companies with established waste minimization programs to assist smaller companies.
  - Mail surveys to the approximately 6000 Minnesota hazardous waste generators. Mailing lists will be provided by the MPCA.
- Analyze the results to determine appropriate modifications to existing programs and/or to provide data for formulating recommendations in Task 6 for new programs.

#### **TASK 6: Recommendations**

• Based on data obtained from Tasks 1-5, recommend potential modifications and/or new programs to enhance Minnesota's waste minimization efforts.

#### IV. WORK PRODUCT

The product of this contract shall consist of a draft and final report detailing the results of each of the six tasks. The report must include at least the following:

- Table of Contents;
- List of tables and figures;
- Executive Summary;
- Chapter summarizing project objectives and tasks;
- Chapter summarizing development of data gathering techniques;
- Chapter summarizing results of Task 1;

#### V. SCHEDULE

A workplan must be included in the response. The workplan detailing specific steps to carry out <u>each</u> task must be included in the proposal. The workplan should include a time schedule for developing and implementing each task.

Weekly oral updates on the project to the project manager will be required. A draft report will be due on August 1, 1989. A final report will be due on September 15, 1989.

#### VI. BUDGET

Compensation should be based on the time necessary to conduct the evaluation, to prepare the required written materials, and to present the report to the MPCA citizens board and the MPCA's Hazardous Waste Management Planning Council. The board and the Council meet on separate days. Two meetings in St. Paul (one at project commencement and another prior to submittal of draft report) must be included in the overall budget. Hourly billing rates and the number of hours for the individuals assigned to the project

should be included with the budget. Costs should be itemized for each task of the project. Expenses should reflect only travel and subsistence expenses necessary to perform the services required under this project. All meetings will be held in St. Paul, Minnesota. Total cost for this project, including expenses, must not exceed \$50,000. The proposal must include the total cost for the project, with separate categories for compensation and expenses. Record Fish Taken in 1988: In an award ceremony at the DNR building in St. Paul on Wednesday 22 March, certificates were presented to the following anglers for their record fish landed during the 1988 fishing season: Robert Wilmes—18 pound 4.8 ounce burbot; Don Kizer—6 pound 2.7 ounce sauger; Rick Julian—3 pound 7 once river carpsucker; Owen Brummer—2 pound 3 ounce goldeye; Kathryn Nennis—30.21 pound chinook salmon; Edward Thamm—31 pound 4 ounce chinook salmon; and Michael Ranthum—31 pound 12 ounce chinook salmon.

Traffic Deaths: Statistics from the Department of Public Safety show 85 more traffic deaths in 1988 than in 1987. Contributing factors to the 615 deaths in 1988 are late winter storms, an increase in miles being driven and an overall increase in speed. Department of Transportation reports that drivers have collided with MnDOT snowplowing equipment more than two dozen times this winter, including 14 rear-end collisions, with two of those accidents resulting in fatalities. The latest fatality occurred March 14 near Duluth when a motorist attempting to pass a plow on I-35 lost control of his vehicle, struck a bridge abutment and was hit by an oncoming semi-trailer truck.

Minnesota Highways Rank High in Federal Funding: In fiscal year 1989, Minnesota ranks third nationally in receipt of federal discretionary funds for highway and bridge projects with a grant total of \$120.2 million. Projects benefitting from the discretionary funds are: I-394 in Minneapolis and the western suburbs, I-94 and I-35E in St. Paul, the Lake Street Bridge spanning the Mississippi River between the Twin Cities, and I-35 in Duluth. Over the past two

fiscal years, Minnesota has received \$204.4 million in these federal funds, ranking 6th in the nation.

The Minnesota Department of Agriculture Seed Testing Laboratory urges farmers who are planning to use their own seeds in spring planting to test the seeds before planting. Minnesota Department of Agriculture tests on soybean samples indicate last year's soybean seeds have a very erratic capacity for natural growth and development. Tests on grain seeds show good vigor and germination rates. Minnesota Commissioner of Agriculture Jim Nichols said that if the vigor test on seeds is low the potential for high yields is diminished. A grower may then want to consider another source of seed, he said. "We seem to have a problem with last year's soybeans so we are urging farmers to have their own soybean seed tested before planting," Nichols said. "This is most likely a condition brought on by the drought, so to be safe I would urge farmers who plan to use any of their own farm seed from last year to have it tested first." Growers are advised to send seeds to competent laboratories for testing. Growers wishing to use the Minnesota Seed Testing Laboratory should place 1 and one-half cups of seed into a plastic bag and place the plastic bag into a small box or seed envelope. Send the seed envelope to the Minnesota Seed Testing Laboratory, 90 West Plato Blvd., St. Paul, MN 55107. Both a vigor and a germination test are recommended. Cost is \$5 for one test and \$10 for both. Make checks payable to the Commissioner of Agriculture. Seed envelopes are available from extension offices, county agents, state and county inspectors and most elevators.

Metro Council Seeks Volunteer: The Metropolitan Council is seeking a representative of the private waste management industry to serve on its regional Waste Management Advisory Committee. The 30-member committee, made up of waste professionals, agency representatives and private citizens, helps the Council develop a long-range plan for the

reuse or disposal of solid and hazardous waste. It also reviews county solid waste plans, county annual reports on landfills and waste abatement, and permit applications for new disposal facilities. Applicants may reside anywhere in the seven-county Metropolitan Area. The term will expire in December 1991. Committee members volunteer their time but are reimbursed for travel and parking. The application deadline is April 14. The appointment will be made on April 27. For more information and an application form, call Vivian Ramirez at 291-6468.
