

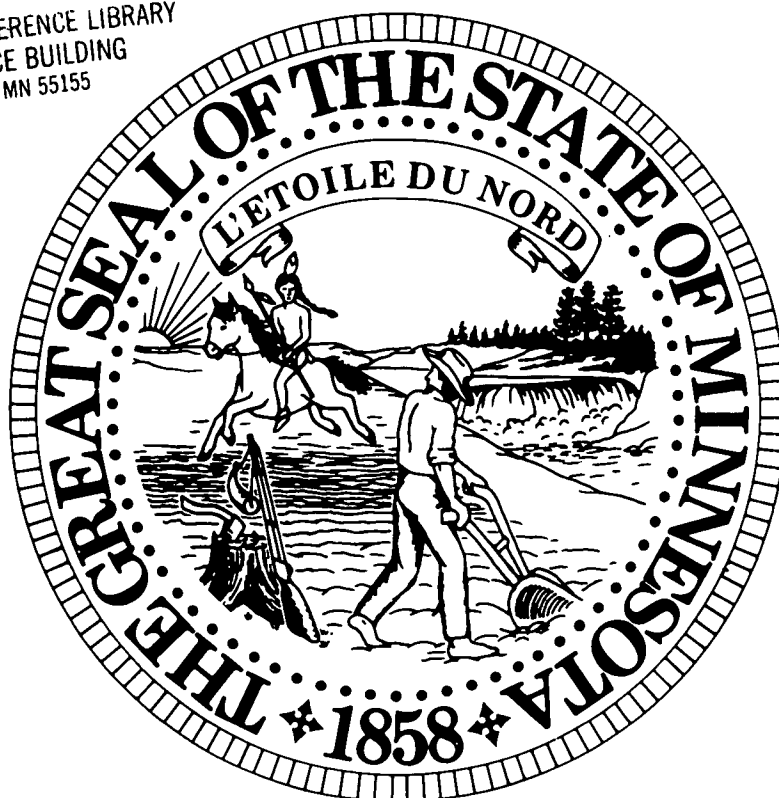

Requests for deadline extensions should be made only in valid emergency situations.

**Notices of public hearings on proposed rules and notices of intent to adopt rules without a public hearing are published in the Proposed Rules section and must be submitted two weeks prior to the issue date.

The Monday edition is the vehicle for conveying all information about state agency rulemaking, including official notices; hearing notices; proposed, adopted and emergency rules. It also contains executive orders of the governor; commissioners' orders; state contracts and advertised bids; professional, technical and consulting contracts; non-state public contracts; state grants; decisions of the supreme court; a monthly calendar of scheduled cases before the supreme court; and other announcements. The Thursday edition contains additional state contracts and advertised bids, and the most complete listing of contract awards available in one source.

In accordance with expressed legislative intent that the *STATE REGISTER* be self-supporting, the following subscription rates have been established: the Monday edition costs \$130.00 per year and includes an index issue published in August (single issues are available at the address listed above for \$3.50 per copy); the combined Monday and Thursday editions cost \$195.00 (subscriptions are not available for just the *Contracts Supplement*); trial subscriptions are available for \$60.00, include both the Monday and Thursday edition, last for 13 weeks, and may be converted to a full subscription anytime by making up the price difference. Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the *State Register*

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific *Minnesota Rule* chapter numbers. Every odd-numbered year the *Minnesota Rules* are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION in the *Official Notices* section of the *State Register*. When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. 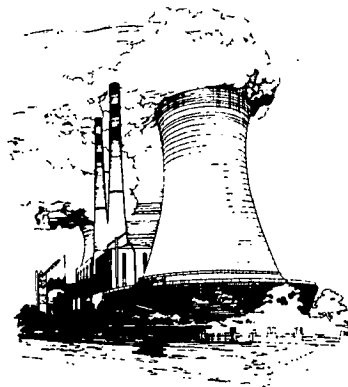

Proposed Rules

Pursuant to Minn. Stat. §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. The notice must advise the public:

1. that they have 30 days in which to submit comment on the proposed rules;
2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
3. of the manner in which persons shall request a hearing on the proposed rules; and
4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

Proposed Permanent Rules Relating to Minnesota Grown Labeling Statements

Notice of Intent to Adopt a Rule Without a Public Hearing

NOTICE IS HEREBY GIVEN that the Minnesota Department of Agriculture intends to amend the above-entitled rule without a public hearing following the procedures set forth in the Administrative Procedures Act for adopting rules without a public hearing in *Minnesota Statutes*, sections 14.22-14.28. The statutory authority to adopt this rule is *Minnesota Statutes*, section 17.102, subdivision 6.

All persons have 30 days in which to submit comment in support of or in opposition to the proposed amendments or any part or subpart of the amendments. Comment is encouraged. Each comment should identify the portion of the proposed amendments addressed, the reason for the comment, and any change proposed.

Any person may make a written request for a public hearing on the amendments within the 30-day comment period. If 25 or more persons submit a written request for a public hearing within the 30-day comment period, a public hearing will be held unless a sufficient number withdraw their request in writing. Any person requesting a public hearing should state their name and address, and is encouraged to identify the portion of the proposed amendments addressed, the reason for the request, and any proposed change. If a public hearing is required, the department will proceed according to *Minnesota Statutes*, sections 14.131-14.20.

Comments or written requests for a public hearing must be submitted to: Carol Milligan, Minnesota Department of Agriculture, 90 West Plato Boulevard, St. Paul, MN 55107, (612) 296-6906.

The proposed amendments may be modified if the modifications are supported by the data and views submitted to the department and do not result in a substantial change in the proposed amendments as noticed.

A copy of the proposed amendments is attached to this notice.

A STATEMENT OF NEED AND REASONABLENESS that describes the need for and reasonableness of each provision of the proposed amendments and identifies the data and information relied upon to support the proposed amendments has been prepared and is available upon request from Ms. Milligan.

The department has determined that small business will be minimally affected by these amendments because they expand and clarify an existing rule, and therefore, do not affect any small businesses not already covered by the rule. Additionally, the program is completely voluntary and the only reporting requirement is an annual license application.

If no hearing is required, upon adoption of the final amendments, the amendments and the required supporting documents will be submitted to Attorney General for review as to legality and form to the extent the form relates to legality. Any person may request notification of the date of submission to the Attorney General. Persons who wish to be advised of the submission of this material to the Attorney General, or who wish to receive a copy of the adopted amendments must submit a written request to Ms. Milligan.

Rules as Proposed

1556.0110 DEFINITIONS.

[For text of subpart 1, see M.R.]

Subp. 2. **Agricultural products.** "Agricultural products" means livestock or livestock products, dairy products, poultry or poultry products, fish, fruit, vegetables, grains, including natural and cultivated wild rice, bees, apiary products, and floral and nursery crops.

[For text of subs 3 and 4, see M.R.]

Subp. 4a. **Hand harvested wild rice.** "Hand harvested wild rice" means 100 percent natural lake or river grown wild rice which was hand harvested in accordance with Minnesota Statutes, section 84.111.

[For text of subs 5 to 7, see M.R.]

Subp. 8. **Producer.** "Producer" means an individual, partnership, family farm, family farm corporation, authorized farm corporation, or cooperative association engaged in the production for sale or harvest for sale of agricultural products.

[For text of subs 9 and 10, see M.R.]

1556.0120 "MINNESOTA GROWN" AND "2,000 MILES FRESHER" LABELING STATEMENTS.

[For text of subs 1 to 3, see M.R.]

Subp. 4. **Appearance of labeling statement.** The labeling statement may be added to an eligible product or display in any color or color combination, except on cultivated wild rice or products containing cultivated wild rice labeling statements may not be printed in navy blue and red or other color combinations designed to make the labeling statement similar in appearance to the "hand harvested wild rice" labeling statement.

1556.0132 "HAND HARVESTED WILD RICE" LABELING STATEMENT.

Subpart 1. **Eligible products.** Agricultural products containing hand harvested wild rice may be identified with the labeling statement if all of the wild rice contained in the product was hand harvested in Minnesota.

Subp. 2. **Use of the "hand harvested wild rice" labeling statement.** A producer licensed under part 1556.0160 may use the "hand harvested wild rice" labeling statement on an eligible agricultural product. A processor licensed under part 1556.0160 may use the "hand harvested wild rice" labeling statement on an eligible product if the wild rice was processed in a plant located partially or completely in Minnesota.

Subp. 3. **Use by retailers and wholesalers.** A retailer or wholesaler may use the "hand harvested wild rice" labeling statement without a license in order to display and advertise eligible products.

Subp. 4. **Availability and appearance of labeling statement.** The labeling statement may only be purchased from the commissioner at cost in the form of stickers. The stickers will only be made available in the color combination of navy blue and red.

1556.0134 "CULTIVATED WILD RICE" LABELING STATEMENT.

Subpart 1. **Eligible products.** Agricultural products containing cultivated wild rice may be identified with the labeling statement if no less than 80 percent of the wild rice contained in the product was produced in Minnesota.

Subp. 2. **Use of the "cultivated wild rice" labeling statement.** A producer licensed under part 1556.0160 may use the "cultivated wild rice" labeling statement on an eligible agricultural product. A processor licensed under part 1556.0160 may use the "cultivated wild rice" labeling statement on an eligible product if the cultivated wild rice was processed in a plant located partially or completely in Minnesota.

Subp. 3. **Use by retailers and wholesalers.** A retailer or wholesaler may use the "cultivated wild rice" labeling statement without a license in order to display and advertise eligible products.

Subp. 4. **Appearance of labeling statement.** The labeling statement may be added to an eligible product or display in any color or color combination except navy blue and red or other color combinations designed to make the labeling statement similar in appearance to the "hand harvested wild rice" labeling statement.

Proposed Permanent Rules Relating to Fees for Manufactured Home Parks and Recreational Camping Areas

Notice of Intent to Adopt Rules Without a Public Hearing, Notice of Intent to Adopt Rules With a Public Hearing if 25 or More Persons Request a Hearing, and Notice of Intent to Cancel Hearing on the Proposed Rules if Fewer than 25 Persons Request a Hearing

I. Explanation of Alternative Notices

The Minnesota Department of Health (hereinafter "Department") hereby proposes to adopt rules without a public hearing under the noncontroversial rulemaking procedure of *Minnesota Statutes*, sections 14.22 to 14.28. However, if 25 or more persons request a hearing on the proposed rules, one will be held according to *Minnesota Statutes*, section 14.25. To expedite the rulemaking process should that occur, the Department is at the same time giving notice of hearing on the proposed rules according to *Minnesota Statutes*, sections 14.131 to 14.20. The hearing on the proposed rules will be cancelled if 25 or more persons do not request that one be held. With the comment period closing on August 1, 1990, there will be 14 days before the scheduled hearing date. This 14-day period will give interested persons time to contact the Department to find out whether the hearing will be cancelled.

II. Notice of Intent to Adopt Proposed Rules Without a Public Hearing

NOTICE IS HEREBY GIVEN that the Minnesota Department of Health (hereinafter "Department") proposes to adopt the above-captioned rules without a public hearing unless 25 or more persons submit written requests for a public hearing with respect to the proposed rules. The Department has determined that the proposed rules will be noncontroversial in nature and has elected to follow the procedures set forth in *Minnesota Statutes*, sections 14.22 to 14.28.

Interested persons shall have 30 days from the date this notice is published in the *State Register* to submit comments in support of or in opposition to the proposed rules. The 30 days will expire on August 1, 1990. Comment is encouraged. Each comment should identify the portion of the proposed rule being addressed, the reason for the comment, and any change proposed to the rule by the commentor. The proposed rule may be modified if the modifications are supported by the data and views submitted to the Department and do not result in a substantial change in the proposed language.

In addition to submitting comment, interested persons may request, in writing, during the 30-day comment period that a hearing be held on the proposed rules. Any person requesting a hearing should state his or her name, address, and telephone number and is encouraged to identify the portion of the proposed rules addressed, the reason for the request, and any changes the commentor wants made to the proposed rules. If a person desires that a hearing be held on only a portion of the proposed rules, it is requested that the Department be informed of the specific portion of the rules on which a hearing is being requested at the time that the hearing request is made. This will enable the Department to limit the hearing, if one is held, to the specific issues of concern. A public hearing will be held only if 25 or more persons submit in writing requests for a hearing on the proposed rules or portion thereof by August 1, 1990, thus necessitating that one be held with respect to the proposed rules. If a hearing is required, it will be held in accordance with the provisions of *Minnesota Statutes*, sections, 14.131 to 14.20 and the hearing notice provided in section III below.

The statutory authority of the Department to adopt the proposed rules is contained in *Minnesota Statutes*, sections 144.05, paragraphs (b) and (c), 144.12, 144.122, paragraph (a), 157.045 and 327.16, subdivision 3.

The proposed rules are published immediately following this notice in the *State Register* on July 2, 1990, and a free copy of the rules may be obtained from the Department by writing or telephoning Charles Schneider at the address or telephone number listed above.

Proposed Rules

The proposed rules amend *Minnesota Rules*, part 4630.1900 to classify manufactured home parks and recreational camping areas as "category A" or "category B" sites. The proposed rules would increase the primary license fee in part 4630.2000 from \$75 for every 50 sites to \$75 for every 10 sites. The proposed amendments also change the fee for additional sites constructed after issuance of a primary license to \$75 for each ten sites or fraction thereof. The renewal fee for category A sites would increase, beginning January 1, 1991, to a \$75 base fee plus \$4 for each site up to 500 sites. The renewal fee for category B sites, beginning January 1, 1991, would increase to a \$75 base fee plus \$3 for each site up to 500 sites. The fee for late renewal is proposed to increase from \$10 to \$20 and the inspection frequency specified in part 4630.2210 is proposed to be at least once a year for category A sites and at least once every two years for category B sites.

A STATEMENT OF NEED AND REASONABLENESS that describes the need for and reasonableness of each provision of the proposed rules and identifies the data and information relied on to support the proposed rules has been prepared and may be obtained from the Department by writing or telephoning Charles Schneider at the address or telephone number listed above.

After the close of the comment period on the proposed rules, if no hearing is required, the Department will submit to the Attorney General the proposed rules and notice as published, the rules as proposed for adoption, any written comments received by the Department, the statement of need and reasonableness, and a statement explaining any modifications to the proposed rules. The Attorney General will approve or disapprove the rules as to their legality and form, including the issue of substantial change and determine whether the Department has the authority to adopt the rules and whether the record demonstrates a rational basis for the need for and reasonableness of the proposed rules. The Department will give notice to all persons who request to be informed that these materials have been submitted to the Attorney General. Persons who wish to be advised of the submission of these materials to the Attorney General should submit a written request to Charles Schneider at the address listed above. If the proposed rule has been modified, the notice will also state that fact and will state that a free copy of the proposed rule, as modified, will be available upon request from the department.

Local Government Considerations

The Department's evaluation of the impact of the proposed rule on the expenditure of public monies by local public bodies is addressed in the statement of need and reasonableness.

Agricultural Land

The proposed rule amendments will not have an impact on agricultural land; therefore, no further information need be provided under *Minnesota Statutes*, section 14.11.

Small Business Considerations

The Department is subject to *Minnesota Statutes*, section 14.115 regarding small business considerations in rulemaking. The Department's evaluation of the applicability of the methods contained in *Minnesota Statutes*, section 14.115, subdivision 2, for reducing the impact of the proposed rules is addressed in the statement of need and reasonableness.

Notice to Department of Finance

In accordance with *Minnesota Statutes*, section 16A.128, pertaining to fees, the Department has notified the Commissioner of Finance of the Department's intent to adopt the above-entitled matter. A copy of the Department's notice and the Commissioner of Finance's reply are attached to the Statement of Need and Reasonableness.

The renewal fee for category B sites, beginning January 1, 1991, would increase to a \$75 base fee plus \$3 for each site up to 500 sites. The fee for late renewal is proposed to increase from \$10 to \$20 and the inspection frequency specified in part 4630.2210 is proposed to be at least once a year for category A sites and at least once every two years for category B sites. At the hearing the applicant will present its evidence showing that a license should be granted and that all persons will be given an opportunity to cross-examine witnesses, to be heard orally, to present witnesses, and to submit written data or statements. All persons are encouraged to participate in the hearing and are requested to bring to the hearing all documents, records, and witnesses needed to support their position. It is not necessary to intervene as a party in order to participate in the hearing.

8. Please be advised that if non public data is admitted into evidence, it may become public data unless an objection is made and relief is requested under *Minnesota Statutes* §§ 14.60, subd. 2.

9. You are hereby informed that you may choose to be represented by an attorney in these proceedings, may represent yourself, or be represented by a person of your choice if not otherwise prohibited as the unauthorized practice of law.

10. A Notice of Appearance must be filed with the administrative law judge identified above within 20 days following receipt of the Notice by any person intending to appear at the hearing as a party.

11. In accordance with the provisions of *Minnesota Statutes* §§ 14.61, the final decision of the Commissioner in this proceeding will not be made until the Report of the Administrative Law Judge has been made available to the parties in this proceeding for at least 10 days. Any party adversely affected by the Report of the Administrative Law Judge has the right to file exceptions and present arguments to the Commissioner. Any exceptions or arguments must be submitted in writing and filed with the Commissioner of Health, 717 Delaware Street Southeast, Mpls., Minnesota 55440, within 10 days of the receipt of the Administrative Law Judge's Report.

This information or material is in addition to dental history, future dental plans, x-rays, identification of affected teeth and other documentation to support the dental needs of the recipient.

2. Pharmacy Services Addition

Effective July 1, 1990, Medical Assistance (MA) and General Assistance Medical Care (GMAC) will provide payment for Clozaril, subsequent to receiving prior authorization approval.

Prior authorization will be approved for Clozaril for MA and GMAC recipients who are diagnosed with schizophrenia and who have failed to respond to standard antipsychotic medications. Clozaril will be distributed through Caremark Pharmacy, Inc, 2111 Central Avenue Northeast, Minneapolis, Minnesota 55418.

Caremark Pharmacy will require physicians prescribing Clozaril to enroll the recipient in the Clozaril Patient Monitoring System. Caremark may be contacted by writing to the address above or by calling the Caremark Pharmacy at 1-800-237-2767.

Notice of Special Transportation Payment Rate Under Medical Assistance (MA)

The Department of Human Services is establishing a Medical Assistance payment rate for ambulatory recipients using special transportation. Special transportation is provided to recipients who cannot use a regular bus, car or taxi because of a mental or physical impairment. The new rate will apply to trips provided to ambulatory recipients who are not wheelchair bound. This lesser payment rate is authorized by *Minnesota Statutes* section 256B.0625, subdivision 17.

Currently all special transportation services are reimbursed at a base rate of \$16.00. The special transportation base rate for ambulatory persons will be \$10.00. The rate is effective for services provided on or after August 1, 1990.

If 40 percent of the special transportation rides are billed at the ambulatory rate, the change in payment methodology is expected to decrease expenditures in the Medical Assistance Program by \$876,000 in FY 1991.

Request for Proposals for Technical Support for the Establishment of College Institutional Research Offices

A. Purpose of Project

The purpose of this project is to assist the Minnesota Community Colleges in establishing institutional research offices. The assistance will be in the form of consulting services provided to college institutional research staff. These services will support the implementation of personal computer based software applications for research and the initiation of community college institutional research projects.

B. Background

The Minnesota Community Colleges are establishing a research office as part of the System's Student Success Strategy. The Strategy includes assessment of new students' basic skills, placement of students in appropriate courses, offering necessary developmental courses, a student retention initiative and an expansion of the System's Student Outcomes Assessment Project. The research office is an integral part of the Strategy since it will support implementation and evaluation of the colleges' student success efforts as well as college decision-making in a variety of areas.

The research office will provide college research staff with access to Minnesota Community College System (MCCS) data bases and with the equipment and technical support to conduct research and analyses. College staff will have direct access to detailed information on their students, courses and faculty. They will have the capability to generate reports, prepare summary information, conduct analyses to meet specific college needs and generate lists and mailing labels. They will also have the capability to produce high-quality written, tabular and graphic output.

Each of the eighteen Colleges and the Cambridge Center will purchase a research workstation including an IBM compatible personal computer, laser printer and software for research. The software will include dBASE compatible data base software, Lotus 1-2-3 compatible spreadsheet software, PC Contact downloading software as well as statistics, graphics and word processing software.

The colleges are responsible for providing staffing, training and supplies for their research offices. The majority of the colleges do not currently have a research office. The research and personal computer experience and skills of the research staff they choose are likely to vary widely. As a result of the variations, the level of support provided will also vary from college to college. It is the responsibility of the college, however, to insure that its research staff has basic personal computing hardware and software skills. Research staffing arrangements will also vary. The research office may be staffed with a faculty member, a part-time research professional or a college administrator. Research staffing may also be combined with other functions at the college or with other colleges. It is possible that some colleges will not establish a research office at this time.

C. Project Goals

The goals of the project are as follows:

1. All colleges that choose to establish an institutional research office will have one functioning by June 30, 1991.
2. All college institutional research offices will have an operational student data base and the staff will have a basic understanding of the structure and use of the data base.
3. All college institutional research offices will have a staff member who can download student data from the MCCS IBM 4381 mainframe Student Information System and load it into the college student data base.
4. Some college institutional research offices will have a second research application operational.

D. Project Tasks

The selected vendor will serve as a consultant to the community colleges as they establish or augment their research offices. The consulting will be provided through on-site visits to each of the nineteen campuses and in response to phone inquiries.

Request for Proposal to Study Long Term Claims in the Workers' Compensation System

The Minnesota Department of Labor and Industry is seeking proposals to study long-term claims in the workers' compensation system. The study must include the early identification of factors contributing to long-term disabilities and the identification of medical care that results in the best recovery. Early identification is defined as before the mandated waiting period for rehabilitation evaluation of 30 days for a back injury and 60 days for other injuries. Long-term disability is defined as disability extending longer than six months.

The research study must:

- establish a uniform data collection system that will identify factors (e.g., employee, employer, and injury characteristics) that predict long-term disability;
- identify specific modes of treatment that can provide for the best recovery from the injury;
- test whether these treatments result in earlier return to work and less expensive workers' compensation claims (taking into account medical, indemnity, rehabilitation, and legal costs).

The proposal must describe the research design and methodology of the pilot project. The sample size should be large enough to detect a 10-percent difference in the outcome measures between the groups with an alpha of .05 and a power of .80. The pilot project must be designed to address issues of sensitivity and specificity of the instrument and meet strict scientific standards.

The pilot project must be a randomized controlled trial experimental design. The four study groups to be included are: (1) claimants who are identified by the instrument and where the score is reported to the insurer along with suggested medical treatments, (2) claimants who are identified by the instrument and where the score is reported to the insurer but no specific intervention is suggested, (3) a set of control cases that is tested but the scores are not reported to the insurer, and (4) a set of control cases that is not tested.

Data to be collected must include data necessary for the identification of factors contributing to recovery, detailed data on the treatment course (including ICD-9 diagnostic codes, CPT and UB 82 treatment codes, dates of service, and type of provider), and detailed information of the duration of disability and medical and indemnity workers' compensation costs.

The research must protect the confidentiality of the claimants. After the instrument is designed and before it is tested, the instrument must be reviewed by the legal staff of the Department of Labor and Industry. Any portions of the instrument that violate the confidentiality of participants or privileged information status in the workers' compensation system must be corrected prior to the testing of the instrument.

The evaluation of the instrument must address its utility for all parties in the workers' compensation system (workers, employers, medical and rehabilitation providers, insurers, state monitoring organizations, litigators, and adjudicators).

The project director must report on a quarterly basis to the Director of Research and Education at the Department of Labor and Industry as to the progress of the study.

The proposal must include copies of a proposed instrument, pilot study data on its reliability and validity along with detailed information on any prior studies conducted with the instrument (published papers, in-house data). All proprietary data will be protected but must be submitted.

Professional, Technical & Consulting Contracts

The proposing organization must have substantial background in medical and psychological instrumentation and substantial knowledge of disability assessment and the Minnesota workers' compensation system. Preference will be given to bidders who have no direct interest in the Minnesota workers' compensation system.

A report of the findings of this study must be submitted to the Commissioner of Labor and Industry by July 1, 1991. The report must include all data files as well as summary statistics and statistical tests. The Department will then review the study and evaluate the instruments' cost effectiveness in the workers' compensations system. The Department will present its evaluation of the project to the 1992 legislature.

The Department of Labor and Industry will contribute \$15,000 toward the cost of the project **only upon commitment by private sources** of at least five times that amount (\$75,000) in monies or in-kind services. The proposal must list the other funding sources and detail the nature of the support (monies or in-kind commitment). The Department will periodically review the research project and evaluate the project upon completion.

C5-89-1625 State of Minnesota v. William Edward Drieman, Appellant. St. Louis County.

The trial court's failure to grant defendant certain challenges for cause and motions to change venue did not deny defendant a fair and impartial jury.

Defendant waived his right to challenge the prosecutor's statements to the grand jury by failing to raise the issues in his motion to dismiss the indictment for insufficient evidence.

The trial court did not abuse its discretion by allowing evidence of an assault committed by defendant 9½ years before trial or by admitting photographs of Corey McDougall's body.

The evidence is sufficient to support convictions for murder in the first and second degree.

Order: In Re: Amendment of the Rules of the State Board of Law Examiners for Admission to the Bar

WHEREAS, the State Board of Law Examiners has recommended that the Rules of the Supreme Court and of the State Board of Law Examiners for Admission to the Bar be amended to increase certain fees, charged in connection with applications for admission to the Bar of Minnesota,

NOW, THEREFORE, IT IS HEREBY ORDERED that Rule 105 of the Rules of the State Board of Law Examiners for Admission to the Bar is hereby amended as follows:

Rule 105. Fees

A. General. All fees required under these rules shall be paid in the form of certified check, money order or bank draft and payable to the Board. The fee applicable is determined as of the date of filing of a complete application under Rule 100.

B. Fee for Examination, Not Previously Admitted. An applicant taking the examination for the first time and making timely filing on or before October 15 for the February examination, or on or before March 15 for the July examination, shall submit a fee of ~~\$240~~ \$300.

An application for the examination submitted after the timely filing date but on or before December 15 for the February examination, or on or before May 15 for the July examination, shall include a fee of ~~\$360~~ \$450.

C. Fee for Examination, Prior Admission. An applicant licensed to practice in another jurisdiction more than six months preceding the date of the Minnesota examination and making a timely filing shall submit a fee of ~~\$540~~ \$600.

An application for examination submitted after the timely filing date but on or before December 15 for the February examination, or on or before May 15 for the July examination, shall include a fee of ~~\$660~~ \$750.

An applicant licensed to practice in another jurisdiction less than six months preceding the date of the Minnesota examination shall comply with paragraph B.

D. Repeat Examination. An applicant who has previously been unsuccessful on the examination and filing on or before December 15 for the February examination or on or before May 15 for the July examination, shall include a fee of ~~\$240~~ \$300 and comply with Rule 100.E and Rule 101.D(5).

E. Fee for Admission Without Examination. An applicant for admission without examination shall submit a fee of ~~\$500~~ \$600. An applicant for admission pursuant to Rule VI shall submit a fee of ~~\$700~~ \$800.

F. Refund of Fees. An applicant may request a refund in the amount of \$50 in the following circumstances:

(1) An applicant who advises the Board in writing at least four days prior to an examination of the applicant's desire to withdraw the application.

(2) An applicant denied permission to take an examination under Rule 101.D(1) or 101.D(5).

G. Carry-over of Fees. The fee of an applicant declared ineligible under Court Rule IV shall be applied to an examination held within the succeeding 15 months at the written request of the applicant received within 30 days of notice of the denial. No other transfers of fees shall be granted.

H. Transfer of Examination Scores. A request for transfer of scores pursuant to Rule 102.B shall include a fee of \$10. A score report may be obtained by submitting payment of \$10 to the National Conference of Bar Examiners.

I. Copies of Examination Answers. An unsuccessful applicant may request copies of the applicant's essay answers upon written request to the Board within 30 days of the release of the examination rules and submission of a fee of \$15.

J. Other Fees. For matters not covered in these Rules, the Director may set reasonable fees which reflect the costs of staff time, services, duplicating, postage, etc.

September Canada Goose Season Permits: Experimental Canada goose seasons will again be held in three areas of Minnesota this year. The zones will be identical to 1989: Fergus Falls/Alexandria Zone, Southwest Border Zone, and the Twin Cities Metro Zone. Individuals interested in participating in the September Canada goose seasons will need to apply for permits by Aug. 1. Application forms will be available after June 22 at county auditors offices, DNR wildlife offices, license agents, and the DNR License Bureau at 500 Lafayette Road, St. Paul. To participate in these September seasons, all hunters must have the special goose hunt permit in their possession. An unlimited number of permits are available, but they must be applied for by the Aug. 1 deadline. Applicants must mail a separate application along with a \$3 fee (do not send cash) for each hunt to an address provided on the application. Applications must be postmarked or delivered to the appropriate address given on the application by Aug. 1. Persons who want to hunt in the proposed late December goose season in the metropolitan area need this same permit. They should apply for the early metro season. The same permit will be valid for both the early and the late metro hunts. In addition to a valid special permit, hunters must have a current small game license, federal duck stamp, and a Minnesota migratory waterfowl stamp, in accordance with state and federal regulations. All three seasons will run from Sept. 1 through Sept. 10, with shooting hours from one-half hour before sunrise to sunset daily. Bag limits will be four daily and eight in possession in the Twin Cities Metro Zone, and two daily and four in possession in the Fergus Falls/Alexandria and Southwest Border zones. • **Steel shot** is required for all waterfowl hunting in Minnesota. In order to protect resident duck populations, no hunting will be allowed within 100 yards of surface water. In addition, no hunting will be allowed from or upon public roads or road right-of-ways in the Fergus Falls/Alexandria Zone and the Twin Cities Metro Zone.
