The Thursday edition contains additional state contracts and advertised bids, and the most complete listing of contract awards available in one source.

In accordance with expressed legislative intent that the State Register be self-supporting, the following subscription rates have been established: the Monday edition costs \$140.00 per year and includes an index issue published in August (single issues are available at the address listed above for \$3.50 per copy); the combined Monday and Thursday editions cost \$195.00 (subscriptions are not available for just the Contracts Supplement); trial subscriptions are available for \$60.00, include both the Monday and Thursday edition, last for 13 weeks, and may be converted to a full subscription anytime by making up the price difference. No refunds will be made in the event of subscription cancellation.

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUT-SIDE OPINION in the *Official Notices* section of the *State Register*. When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the *Minnesota Guidebook to State Agency Services*.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. Adopted Rules

The adoption of a rule becomes effective after the requirements of Minn. Stat. \$14.14-14.28 have been met and five working days after the rule is published in *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

An emergency rule becomes effective five working days after the approval of the Attorney General as specified in Minn. Stat. §14.33 and upon the approval of the Revisor of Statutes as specified in §14.36. Notice of approval by the Attorney General will be published as soon as practicable, and the adopted emergency rule will be published in the manner provided for adopted rules under §14.18.

WHEREAS, certain lands in Cook County, Minnesota, described as:

Government Lots 6 and 7, Section Six (6), Township Sixty-two (62) North, Range Four (4) East.

are under the control and possession of the Department of Natural Resources; and

WHEREAS, such lands contain an old growth northern hardwood plant community and provide habitat for Chilean sweet cicely (Osmorhiza chilensis), a state endangered species, and Carolina spring beauty (Claytonia caroliniana), a state special concern species; and

WHEREAS, the most effective means by which such lands can be protected and perpetuated in their natural state and used for educational and research purposes in such a manner as will leave them conserved for future generations is by designation as a Scientific and Natural Area;

Commissioners' Orders

NOW THEREFORE, I, Rodney W. Sando, Commissioner of Natural Resources, pursuant to authority vested in me by *Minnesota Statutes* §§ 84.033, 86A.05, subd. 5, and other applicable law, do hereby designate the above-described lands as Spring Beauty Northern Hardwoods Scientific and Natural Area. Revenue Notices:

Effective July 1, 1991, the Department of Revenue has authority to issue revenue notices. A revenue notice is a policy statement made by the department that provides interpretation, details, or supplementary information concerning the application of law or rules. This authority was provided by the Legislature in 1991 Session Laws Chapter 291, article 21, section 6 and will be codified at Minnesota Statutes section 270.0604.

Department of Revenue

Revenue Notice #92-11: Unfair Cigarette Sales Act—Price Discounts

Issue: What constitutes an illegal rebate, concession or discount of cigarettes under the Unfair Cigarette Sales Act?

Revenue Notices

Law: Minnesota Statutes § 325D.33, subd. 3 provides that "It is unlawful for a wholesaler to offer a rebate in price, to give a rebate in price, to offer a concession of any kind, or to give a concession of any kind in connection with the sale of cigarettes. For purposes of this chapter, the term 'discount' is included in the definition of a rebate."

"Wholesaler" is defined in *Minnesota Statutes* § 325D.32, subd. 4 to include any person who sells cigarettes to another party for resale. The wholesaler definition includes, but is not limited to, cigarette manufacturers, distributors, and subjobbers.

Conclusion: If an offer is made equally to all buyers, the offer is not a rebate or concession prohibited by § 325D.33, subd. 3. An offer is not made equally to all buyers if it would not be feasible for some to take advantage of the offer. An offer is not feasible if it would require a significant expenditure of money or a significant change in the purchaser's methods of doing business.

Example #1. A cigarette manufacturer wants to introduce a new product at a temporarily reduced price to the consumer. This introductory low price will be indicated on special product packaging. The product will be offered to all wholesalers at a reduced net invoice price that will be passed on to the retailer.

This is not a rebate as long as it is offered on all sales.

Example #2. A cigarette manufacturer offers to retailers with computerized cash registers the ability to generate coupons for its product when a consumer purchases a competing brand.

Competing retailers without computerized cash registers would be unable to participate in this promotion. Therefore, it is a rebate unless a feasible alternative plan is available to all of these retailers.

Example #3. A wholesaler invoices sales discounting the basic cost of cigarettes by passing on a promotional allowance or basic distributor allowance received from a manufacturer.

This is a rebate unless all distributors are given the same price reduction.

Example #4. A wholesaler offers a discount for volume purchase of cigarettes.

This is a rebate because it is an offer to sell cigarettes at a lower price only to buyers who are able to purchase in volume.

Example #5. A manufacturer's sales representative goes to a distributor's warehouse and places stickers on boxes allowing a \$2.00 reduction in price per carton. The representative gives a check to the distributor for the total of the stickers attached to the cartons. The distributor then allows \$2.00 off per carton on the invoice to the retailer. If the distributor will not allow a representative to affix the sticker, the representative goes to retailers and places the stickers on the cartons and gives the retailer a check for the total of the stickers attached to the cartons.

This offer will be presumed to be a rebate, unless the manufacturer can prove to the Department that it offered the same price reduction to all distributors or retailers.

Example #6. A cigarette manufacturer has a coupon attached or printed on every carton of cigarettes sold to all distributors in Minnesota.

This is not a rebate since it is offered equally to all distributors.

Example #7. A cigarette manufacturer has a coupon printed in a magazine or newspaper offering a price reduction to consumers on the price of a carton of cigarettes.

This is not a rebate since it is offered equally to all consumers.

Emergency Rules

Proposed Emergency Rules

According to Minn. Stat. of 1984, §§14.29-14.30, state agencies may propose adoption of emergency rules if: 1) expressly required: 2) authorized by statute; or 3) if the manner permitted by a directive (given by statute, federal law or court order) does not allow for compliance with sections 14.14-14.28. The agency must, however, publish a notice of intent to adopt emergency rules, along with the rules themselves, in the *State Register*. The notice must advise the public:

- 1) that a free copy of the proposed emergency rule is available upon request from the agency;
- 2) that notice of the date that the rule is submitted to the attorney general will be mailed to persons requesting notification;
- 3) that the public has at least 25 days after publication of the proposed emergency rule to submit data and views in writing; and
- 4) that the emergency rule may be modified if the data and views submitted support such modification.

Adopted Emergency Rules

Emergency rules take effect five working days after approval by the attorney general, and after compliance with Minn. Stat. §§14.29-14.365. As soon as possible, emergency rules are published in the State Register in the manner provided for in section 14.18.

Emergency rules are effective for the period stated in the notice of intent to adopt emergency rules. This may not exceed 180 days.

Continued/Extended Emergency Rules

Adopted emergency rules may be continued in effect (extended) for an additional 180 days. To do this, the agency must give notice by: 1) publishing notice in the *State Register*: and 2) mailing the same notice to all persons who requested notification on rulemaking. No emergency rule may remain in effect 361 days after its original effective date. At that point, permanent rules adopted according to Minn. Stat. 14.14-14.28 supercede emergency rules.

The authority to develop and issue a general permit is based on the 1989 U.S. Environmental Protection Agency (EPA) promulgated revisions to the NPDES program regulations, which created a class of permits called general permits. The general permits are issued under 40 CFR 122.28 and *Minnesota Rules* pt. 7001.0210. General permits can be issued in NPDES approved states if the approved state program includes general permit authority. The General Permit Program of the MPCA was approved by EPA on December 15, 1987.

This general permit is being proposed as a mechanism to regulate water treatment facilities using filter backwash systems to produce potable water. This general permit will potentially cover more then 50 sites. This general permit will provide timely issuance without the delays of individual permit issuance procedures.

This permit regulates the discharge of filter backwash water from water treatment facilities. A general permit will only be issued in cases where the following criteria are met.

- 1. The discharge consists of filter backwash water from municipal water treatment plants.
- 2. The facilities must provide at least 24-hour detention before the discharge of filter backwash water to the receiving water.
- 3. No discharge is allowed under this permit to Outstanding Resource Value Waters.
- 4. Lime and zeolite softening water treatment plants are excluded from this general permit.
- 5. No discharge is allowed under this permit in cases where the discharge would violate surface water quality standards *Minnesota Rules* ch. 7050, ground water quality standards (*Minnesota Rules* pt. 7050.0220), or air emissions of toxic pollutants (*Minnesota Statute* § 116.81, subd. 4.A.).

This NPDES/SDS general permit establishes effluent limitations, monitoring requirements, and other conditions on facilities which

discharge filter backwash water to surface waters of the state. General conditions, which are a part of all NPDES/SDS permits, are included as PART II of this permit.

On the basis of preliminary MPCA staff review and application of applicable standards and regulations, the Commissioner has made a preliminary determination that a general permit should be issued for construction of treatment and disposal systems and discharge from these facilities subject to certain effluent limitations and special conditions.

The Commissioner's determination that the general permit should be issued is tentative. Interested persons are invited to submit written comments upon the proposed permit action. The comment period begins and ends as indicated on page one of this Notice. Any comments received no later than the last day of the comment period will be considered in the formulation of final determinations.

Any comments submitted are required by Minnesota Rules pt. 7001.0110 to include the following information:

- 1. A statement of the person's interest in the draft general permit.
- 2. A statement of the action the person wishes the MPCA to take, including specific references to sections of the draft general permit that the person believes should be changed.
- 3. The reasons supporting the person's position, stated with sufficient specificity as to allow the Commissioner to investigate the merits of the person's position.

During the comment period, any person may submit a request for a public informational meeting or a contested case hearing on the proposed permit action. A public informational meeting is an informal meeting which the MPCA may hold to help clarify and resolve issues. A contested case hearing is a formal proceeding before a state Administrative Law Judge.

Any request for a public informational meeting or a contested case hearing must include the items 1 through 3 listed above and also a statement of the reasons the person desires the MPCA to hold a public informational meeting or contested case hearing and the issues that the persons would like the MPCA to address at the public informational meeting or contested case hearing.

Request for Proposals for Water Quality Collection, Analysis and Interpretation for Metropolitan Lakes

The Minnesota Department of Natural Resources (MDNR) is seeking the services of a qualified private or government contractor to collect, analyze, and interpret data on Metropolitan lakes. The contractor will assist in the collection of chemical, physical, biological and recreational suitability data on the study lakes, identify and quantify the principal phytoplankton species present, and prepare a report evaluating the chemical, physical, biological, and recreational suitability results.

A. Purpose

The MDNR is conducting a study to evaluate the impact of year-round aeration on lake ecosystems, in general, and on the Department's fish and wildlife management activities, in particular. The collection, analysis, and interpretation of water quality information detailed here represents one major component of that study.

B. Goals

The specific goals of this project are as follows:

- 1. Assist with 154 lake visits to collect chemical, physical, biological and recreational suitability data.
- 2. Identify and quantify the principal phytoplankton species in 180 samples.
- 3. Provide a detailed report documenting water quality conditions in the study lakes with special emphasis on differences associated with aeration.

The phytoplankton analyses msut be completed by March 31, 1993 and the final report is due by June 15, 1993.

C. Project Tasks

- 1. Assist with the collection of chemical, physical, biological, and recreational suitability data on eleven (11) lakes. Each lake will be visited fourteen (14) times, about twice a month, between April 1, 1992 and October 31, 1992. - 2. Identify and quantify the principal phytoplankton species present in surface water samples from the eleven (11) lakes identified above. The counting and quantification technique will be similar to the Rapid Assessment Technique used by the Minnesota Pollution Control Agency. A total of 180 analyses (samples plus duplicates) are anticipated.
- 3. Provide a detailed report documenting how the chemical, physical, biological, and recreational suitability conditions in each lake varied between October 1991 and the end of the study period. The MDNR will supply the necessary data for the time period prior to April 1992. The report also must analyze water quality differences between the aerated and non-aerated lakes, both in general and specifically between the lake pairs identified by the MDNR. The report shall include statistical tests where appropriate, use tables and figures to illustrate and summarize important data, and evaluate the precision estimates obtained from field duplicates.




