Minnesota Rules: Amendments and Additions :

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 75 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. This is a ten-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Proposed and adopted emergency rules do not appear in this set because of their short-term nature, but are published in the State Register.

If an agency seeks outside opinion before issuing new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUT-SIDE OPINION in the Official Notices section of the State Register. When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety in the State Register, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the Minnesota Guidebook to State Agency Services.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues 1-13 inclusive; issues 14-25 inclusive; issue 26, cumulative for issues 1-26; issues 27-38 inclusive; issue 39, cumulative for 1-39; issues 40-51 inclusive; and issue 52, cumulative for 1-52. An annual subject matter index for rules appears in August. Proposed Rules

Pursuant to Minn. Stat. §§ 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing, as long as the agency determines that the rules will be noncontroversial in nature. The agency must first publish a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. The notice must advise the public:

- 1. that they have 30 days in which to submit comment on the proposed rules;
- 2. that no public hearing will be held unless 25 or more persons make a written request for a hearing within the 30-day comment period;
- 3. of the manner in which persons shall request a hearing on the proposed rules; and
- 4. that the rule may be modified if the modifications are supported by the data and views submitted.

If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Pursuant to Minn. Stat. §§ 14.29 and 14.30, agencies may propose emergency rules under certain circumstances. Proposed emergency rules are published in the *State Register* and, for at least 25 days thereafter, interested persons may submit data and views in writing to the proposing agency.

Proposed Permanent Rules Relating to Experimental and Special Management Waters

Notice of Intent to Adopt a Rule Without a Public Hearing

The Department of Natural Resources, Division of Fish and Wildlife intends to adopt a permanent rule without a public hearing following the procedures set forth in the Administrative Procedures Act, *Minnesota Statutes*, sections 14.22 to 14.28. You have 30 days to submit written comments on the proposed rule and may also request that a hearing be held on the rule.

Subject of Rule and Statutory Authority. The proposed rule is about experimental and special management waters. The statutory authority to adopt this rule is *Minnesota Statutes*, sections 97C.001, subdivision 1 and 97C.005, subdivision 1. A copy of the proposed rule is published in the *State Register* and attached to this notice as mailed.

Comments. You have until 4:30 p.m., February 12, 1993 to submit written comment in support of or in opposition to the proposed rule and any part or subpart of the rule. Your comment must be in writing and received by the agency contact person by the due date. Comment is encouraged. Your comment should identify the portion of the proposed rule addressed, the reason for the comment, and any proposed change.

Request for a Hearing. In addition to submitting comments, you may also request that a hearing be held on the rule. Your request for a public hearing must be in writing and must be received by the agency contact person by 4:30 p.m. on February 12, 1993. Your written request for a public hearing must include your name and address. You are encouraged to identify the portion of the proposed rule which caused your request, the reason for the request, and any changes you want made to the proposed rule. If 25 or more persons submit a written request for a hearing, a public hearing will be held unless a sufficient number withdraw their requests in writing. If a public hearing is required, the agency will follow the procedures in *Minnesota Statutes*, sections 14.131 to 14.20.

Modifications. The proposed rule may be modified as a result of public comment. The modifications must be supported by data and views submitted to the agency and may not result in a substantial change in the proposed rule as attached and printed in the *State Register*. If the proposed rule affects you in any way, you are encouraged to participate in the rulemaking process.

Statement of Need and Reasonableness. A statement of need and reasonableness is now available from the agency contact person.

Proposed Rules =

This statement describes the need for and reasonableness of each provision of the proposed rule and identifies the data and information relied upon to support the proposed rule.

Small Business Considerations. The provisions of *Minnesota Statutes*, section 14.155 have been reviewed and it has been determined that this proposed rule will not affect small businesses.

Expenditure of Public Money by Local Public Bodies. The provisions of *Minnesota Statutes*, sections 3.982 and 14.11, subd. 1 have been reviewed and it has been determined that this proposed rule will not require the expenditure of public money by local public bodies; therefore, no fiscal statement is required.

Impact on Agriculture Lands. The provisions of *Minnesota Statutes*, sections 14.11, subd. 2 and 17.80-84 have been reviewed and it has been determined that this proposed rule will not affect agricultural land.

Adoption and Review of Rule. If no hearing is required, after the end of the comment period the agency may adopt the rule. The rule and supporting documents will then be submitted to the attorney general for review as to legality and form to the extent form relates to legality. You may request to be notified of the date the rule is submitted to the attorney general or be notified of the attorney general's decision on the rule. If you wish to be so notified, or wish to receive a copy of the adopted rule, submit your request to the agency contact person listed above.

Rules as Proposed (all new material)

6268.0010 DEFINITIONS.

- Subpart 1. **Scope.** For purposes of parts 6268.0010 to 6268.0040, the following terms have the meanings given them unless otherwise provided.
 - Subp. 2. Commissioner. "Commissioner" means the commissioner of natural resources.
 - Subp. 3. Department. "Department" means the Minnesota Department of Natural Resources.
 - Subp. 4. Experimental waters. "Experimental waters" has the meaning given it in Minnesota Statutes, section 97C.001.
- Subp. 5. Special management waters. "Special management waters" has the meaning given it in *Minnesota Statutes*, section 97C.005.

6268.0020 AUTHORITY; SCOPE; PURPOSE.

- Subpart 1. Authority. Parts 6268.0010 to 6268.0040 are adopted under authority of *Minnesota Statutes*, sections 97C.001 and 97C.005.
- Subp. 2. **Scope.** Parts 6268.0010 to 6268.0040 apply to public initiation and public participation in the evaluation of all experimental and special management waters designations.
- Subp. 3. **Purpose.** The purpose of parts 6268.0010 to 6268.0040 is to ensure adequate opportunity for public involvement in the initiation, designation, and evaluation of experimental or special fishing regulations adopted under *Minnesota Statutes*, sections 97C.001 and 97C.005.

6268.0030 PUBLIC INITIATION OF EXPERIMENTAL AND SPECIAL MANAGEMENT WATERS DESIGNATION.

- Subpart 1. Submission of proposals. A person, organization, or other entity may submit a proposal to the commissioner at any time for designation of specific lakes or streams as experimental or special management waters. Proposals must include the following information:
 - A. names of waters proposed for designation and counties where waters are located;
 - B. description of proposed experimental or special regulations;
 - C. objective of proposed experimental or special regulations;
 - D. documentation of public support for the proposal; and
 - E. proposed implementation date.
- Subp. 2. **Proposal evaluation.** The commissioner shall evaluate proposals for experimental or special management waters based on the following criteria:
 - A. presence of an objective which meets a defined biological or social need supported by reliable information;
 - B. compatibility with existing programs of the department;
 - C. public acceptance;

- D. compatibility with existing state law;
- E. availability of sufficient funding if needed for evaluation; and
- F. scientific validity and conformance with established biological principles.
- Subp. 3. Action on proposal. The commissioner may deny a proposal which does not meet the criteria in subpart 2, or may suggest modifications to the proposal so that it better meets the criteria. The commissioner shall notify originators of proposals of acceptance, denial, or suggested modifications within three months of receiving the proposal. The commissioner shall provide a written explanation for denials and suggestions for modification. The originator of the proposal may decide to accept suggested modifications or to drop the proposal. Acceptance of a proposal by the commissioner is not a guarantee that the proposal will be implemented as experimental or special management waters.
- Subp. 4. Proposal approval. Proposals which are accepted by the commissioner are subject to further review by the department; public notice and meeting requirements of Minnesota Statutes, sections 97C.001, subdivision 2, and 97C.005, subdivision 1; and all other applicable state law before final approval and implementation. The commissioner may order that a proposal be dropped or modified at any time during the internal review or public notification process. If a proposal is dropped or modified, the commissioner shall provide the reasons for this action in writing to the originator of the proposal. The originator of the proposal may decide to accept the commissioner's modifications or to drop the proposal.

6268.0040 PUBLIC PARTICIPATION IN EVALUATION OF EXPERIMENTAL AND SPECIAL MANAGEMENT WATERS DESIGNATION.

- Subpart 1. Experimental waters. Public meetings held to determine if experimental waters should be terminated, extended, or designated as special management waters must provide an opportunity for public review, comment, and questions concerning the proposed action. The commissioner shall review public comments before making a final determination on whether experimental waters should be terminated, extended, or designated as special management waters. Final determination regarding changes in experimental waters designation will consider public comments, but will also be based on natural resource needs and department management plans.
- Subp. 2. Special management waters. The commissioner may hold meetings to allow public review, comment, and questions concerning existing special management waters. The commissioner shall review public comments before making a determination on changing the status of special management waters. Final determination regarding changes in special management waters designation will consider public comments, but will also be based on natural resource needs and department management plans.

Notice is hereby given that a Statement of Need and Reasonableness is now available for review at the Minnesota Department of Transportation, Division of State Aid for Local Transportation and at the Office of Administrative Hearing. This Statement of Need and Reasonableness includes a summary of all the evidence and argument which the department anticipates presenting at the hearing justifying both the need for and reasonableness of the proposed rules. A free copy of the Statement of Need and Reasonableness may be obtained from Dennis Carlson at the address given above or a copy may be obtained from the Office of Administrative Hearings at the cost of reproduction.

Any person may present his or her views on the proposed rules in one or more of the following ways: by submitting written data to the Administrative Law Judge at any time before the close of the hearing; by submitting oral or written data at the hearing; and by submitting written data to the Administrative Law Judge during the comment period following the hearing.

The Minnesota Department of Transportation requests that any person submitting written views or data to the Administrative Law Judge prior to the hearing or during the comment period also submit a copy of the written data to Dennis Carlson at the address given above.

Written material may be submitted and recorded in the hearing record for five working days after the public hearing ends. The comment period may be extended for a longer period not to exceed 20 calendar days if ordered by the Administrative Law Judge at the hearing. Any written material must be received at the Office of Administrative Hearings no later than 4:30 on the final day. The written material received during the comment period will be available for review at the Office of Administrative Hearings. For five business days after expiration of the comment period, the Minnesota Department of Transportation and interested persons may respond in writing to any new information received during the comment period. Any written material or responses must be received at the Office of Administrative Hearings no later than 4:30 p.m. on the fifth day. No additional evidence may be submitted during this five day period.

Please be advised that *Minnesota Statutes*, chapter 10A, requires each lobbyist to register with the State Ethical Practices Board within five days after he or she commences lobbying. Notice: Any person may request notification of the date on which the Administrative Law Judge's report will be available, after which date the Department of Transportation may not take final action on the rules for a period of five working days. If you desire to be so notified, you may so indicate at the hearing. After the hearing, you may request notification by sending a written request to the Administrative Law Judge. Any person may request notification of the date on which the rules are adopted and filed with the Secretary of State. The notice must be mailed on the same day that the rules are filed. If you want to be notified you may so indicate at the hearing or send a request in writing to the department at any time prior to the filing of the rules with the Secretary of State.

In preparing the rules, the Department has considered the requirements of *Minnesota Statutes*, section 14.155, in regard to the

impact of the proposed rules on small businesses. The adoption of these rules will not affect small businesses.

The adoption of the proposed rules will not require a total expenditure of public monies by local public bodies of more than \$100,000 in either of the two years immediately following adoption. Therefore, *Minnesota Statutes*, section 14.11, subdivision 2, is not applicable to this rulemaking proceeding.

Adoption of the proposed rules will not have a direct or substantial adverse impact on agricultural land. Therefore, *Minnesota Statutes*, section 14.11, subdivision 2, is not applicable to this rulemaking proceeding.

Rules as Proposed 8820.0100 DEFINITIONS.

Subp. 12a. Natural preservation route. "Natural preservation route" means an existing or proposed roadway that has been designated as a natural preservation route by the commissioner upon petition by a county board and that possesses sensitive or unique scenic, environmental, or historical characteristics. Examples may include roads along lakes, rivers, wetlands, or floodplains or through forests or hilly, rocky, or bluff terrain.

8820.2500 MINIMUM STATE-AID STANDARDS.

Subpart 1. Geometric design standards. The standards in part 8820.9910 apply to rural design undivided roadways, new or reconstruction.

The standards in part 8820.9930 apply to suburban design roadways that meet indicated conditions, new or reconstruction.

The standards in parts 8820.9935 and 8820.9940 apply to urban design roadways, new or reconstruction.

The requirements in parts 8820.9925, 8820.9945, and 8820.9970 apply to resurfacing projects.

The roadway classifications in part 8820.9950 apply to urban roadways.

The vertical clearances for underpasses in part 8820.9955 apply.

The standards in part 8820.9965 apply to designated forest highways within national forests and state park access roads within state parks, new or reconstruction.

The standards in parts 8820.9980 and 8820.9985 apply to designated natural preservation routes.

NATURAL PRESERVATION ROUTES

8820.4000 REQUEST TO COUNTY BOARD.

Any person may make a written request to designate a county state-aid highway as a natural preservation route. The request must be directed to the county board having jurisdiction over the route. A county board is not required to propose designation for the entire length of a county state-aid highway. The county board shall act on the request within 60 days. The commissioner may designate a county state-aid highway as a natural preservation route only after receipt of a board resolution from the county having jurisdiction over the road.

The county board shall use the descriptions in part 8820.4010 as a guide for determining which designation type best fits a particular route. All of the descriptors may be used in combination. No single descriptor, including ADT, may be used to eliminate a route type from consideration.

8820.4010 CHARACTERISTICS OF ROUTE TYPES.

Subpart 1. Selection criteria generally. To be considered for designation as a natural preservation route, a route must be on the county state-aid highway system. It may be selected if it possesses particular scenic, environmental, or historical characteristics such as routes along lakes, rivers, wetlands, or floodplains or through forests or hilly, rocky, or bluff terrain.

Proposed Rules =

- Subp. 2. Type I natural preservation route. A type I natural preservation route is best characterized as one in which the natural surroundings convey a feeling of intimacy with nature. This type of route carries local passenger vehicles with occasional commercial vehicles. This route has very low volumes with leisurely driving speeds and may be used by pleasure drivers. The roadway alignment follows the terrain, which may be hilly or curving around lakes and wetlands, and can be described as lying lightly on the land. There are few reported accidents related to the geometric design of the roadway or accidents can be minimized without realignment. The operating speeds are generally lower than on regular county state-aid highway routes.
- Subp. 3. Type II natural preservation route. A type II natural preservation route creates a feeling similar to the feeling created by a type I natural preservation route, but the surroundings and vistas may be more distant from the roadway. It carries local traffic with moderate amounts of commercial vehicles. This route generally has low volumes but may have seasonal peaks greater than 300 vehicles per day. It has leisurely driving speeds and may be used by some commuters and pleasure drivers. The roadway alignment follows the terrain, which may be hilly or curving around lakes and wetlands. Some modifications may be made to the land surface. There are few reported accidents related to the geometric design of the roadway or accidents can be minimized with mitigation as referred to in part 8820,4060. The operating speeds may be lower than regular county state-aid highway routes.
- Subp. 4. Type III natural preservation route. A type III natural preservation route goes through an environment similar to the types I and II natural preservation routes, but the surroundings and vistas may be more distant from the roadway. It may function as a minor or major collector and may be used by general commercial traffic. It generally has volumes less than 750 vehicles per day but may have seasonal peaks. This type of roadway passes through diverse terrain features and the alignment is consistent with the traffic mix. It may have required some modifications to the land surface. The safety problems that may exist are related to the traffic volumes and to the geometric design of the roadway. The problems can be corrected with mitigation as referred to in part 8820.4060 or with reconstruction. The operating speeds may be lower than a comparable county state-aid highway route that is not on the natural preservation route system.

8820.4020 REQUIREMENTS FOR ROUTE DESIGNATION PROPOSALS.

- Subpart 1. County board resolution. The county board shall submit a formal request to the commissioner in the form of a resolution.
 - Subp. 2. Required information. The request must be accompanied by:
 - A. an index map that identifies the proposed natural preservation route by county state-aid highway number and termini;
- B. a narrative describing the history of the route, any controversy surrounding it, the inplace cross section, the particular scenic, environmental, or historical characteristics considered desirable to preserve, and which designation category (type I, II, or III) of natural preservation route being requested;
 - C. photographs of the route;
- D. a listing of parks, rivers, or other designated natural or historical resource areas that the highway corridor passes through or adjoins and that are considered desirable to preserve;
 - E. a description of any safety hazards existing along the route and a discussion of the accident record over the past five years;
- F. a transportation plan that considers alternate routes, or traffic management plan for the area including compatibility with the existing roadway network, as well as the existing and projected ADT;
- G. a description of the function of the route including the functional classification, the type of traffic using the route, and a discussion of seasonal variations and trip purposes;
- H. a comparison of the current operating speed, the legal speed limit, and the rationale for the selection of the planned design speed;
 - I. a preliminary description of the planned design if construction or reconstruction is proposed, including a discussion of:
 - (1) what natural or historical elements might be affected by different construction alternatives;
 - (2) which safety features might be affected by different construction alternatives; and
 - (3) how any changes in the continuity of design will be mitigated;
 - J. preliminary cost estimates of the various alternatives considered;
- K. environmental documentation that may have been completed, including public notices and public meetings that have occurred;
- L. a description of existing and projected land uses, any zoning in effect, and compatibility with the natural preservation route characteristics; and
 - M. a description of any provisions to address bicycles, pedestrians, and equestrians.

8820.4030 ADVISORY COMMITTEE.

The commissioner shall appoint an advisory committee for each construction district consisting of seven members: one member from the department of natural resources, one county highway engineer, one county commissioner, one representative of a recognized environmental organization, and three members of the public. The commissioner shall refer each county board submittal received to the advisory committee for the construction district in which the county exists. The advisory committee shall consider all data relative to the petition for designation and make a recommendation to the commissioner. No elected or appointed official that represents a political subdivision requesting the designation or any public member residing in that county may serve on the committee.

8820.4040 DESIGNATION BY COMMISSIONER.

Following receipt of the advisory committee recommendation, the commissioner may designate the roadway as a natural preservation route.

8820.4050 EXTENT OF STATE AID.

The extent of state aid participation for a construction project must be determined on the same basis as a regular county state-aid highway project, except that landscaping items are eligible for up to two percent of the total construction allocation of the year in which any construction on the natural preservation route is completed.

8820.4060 GEOMETRIC STANDARDS.

The standards in parts 8820.9980 and 8820.9985 apply to designated natural preservation routes. The designer shall consider the use of guardrails, retaining walls, and curb sections to protect natural amenities. The designer shall consider landscaping, including native species, curving alignments, variable back slopes, variable ditch bottoms, limited clearing, and other means available to limit the impacts on the environment while still addressing public safety.

8820.4070 RECONSTRUCTION NOTIFICATION.

A county proposing a project that requires removal of the entire surface of a county state-aid highway that is a natural preservation route shall send to owners of property abutting the highway a written notice that describes the project. In addition, the county shall hold a public meeting to discuss design and construction alternatives. Spot maintenance projects, such as culvert replacements or subgrade corrections, do not require notice.

8820,4080 SIGNS.

Route markers must be posted at public road entry points to and at regular intervals along natural preservation routes. Signs posted must conform to the Minnesota Manual on Uniform Traffic Control Devices adopted under Minnesota Statutes, section 169.06. Properly posted signs are prima facie evidence that adequate notice of a natural preservation route has been given to the motoring public. Signs must conform to the requirements in part 8820.9990.

8820.4090 REMOVAL OF DESIGNATION.

A county board, after notice and a public hearing, may petition the commissioner to remove the natural preservation route designation if the board believes the characteristics on which the natural preservation route designation was approved have substantially been lost. The petition for removing the designation must be based on, and the advisory committee shall consider, such items as loss of aesthetic qualities, changes in land use, changes in road function, or significant increases in accidents. The committee shall then make a recommendation to the commissioner. Following receipt of the advisory committee's recommendation, the commissioner may remove the natural preservation route designation from the roadway.

Notice of Determination/Future ACRRA Surcharges

The Agricultural Chemical Response Compensation Board (ACRRA Board) and the Commissioner of the Minnesota Department of Agriculture (MDA) have determined that the amount of the annual response and reimbursement fees (surcharges) for the Agricultural Chemical Response and Reimbursement Account (ACRRA) will remain at the same amounts for 1993 as was determined and collected for 1992, in order to maintain the statutory-required ACRRA balance.

Therefore, the ACRRA surcharges to be imposed by the MDA for 1993 will be the following:

- For pesticides registered under *Minnesota Statutes* Chapter 18B.26: a surcharge equal to 0.2 percent of sales of pesticides in the state as well as sales of pesticides for use in the state, during the period January 1, 1993 through December 31, 1993.
- For fertilizers, soil amendments, and plant amendments inspection fees, under *Minnesota Statutes* Chapter 18C.4254: twenty (20) cents per ton.
- For sites licensed under *Minnesota Statutes* Chapter 18B.31—Pesticide Dealers; and for sites licensed under *Minnesota Statutes* Chapter 18C.415 and 18C.425—where a fertilizer, plant amendment, or soil amendment is distributed: \$300 per site.
 - For Structural Pest Control Applicator business license, under Minnesota Statutes Chapter 18B.32: \$100 per license.
 - For Commercial Pesticide Applicator license, under Minnesota Statutes Chapter 18B.33: \$40 per license.
- For Commercial Pesticide Applicator license (turf and ornamental category), under *Minnesota Statutes* Chapter 18B.33: \$50 per license.
 - For Non-commercial Pesticide Applicator license, under Minnesota Statutes Chapter 18B.34: \$40 per license.

The ACRRA Board and the MDA have made the determination that maintaining the amounts of surcharges for 1993 at the levels previously set for 1991 and 1992 is reasonable and necessary for the following reasons:

- 1) The ACRRA, by statute, must maintain an unencumbered balance of \$1,000,000;
- 2) The ACRRA balance, after the addition of 1992 surcharges collected from November, 1992 to March, 1993 is projected to be more than \$1,000,000 and less than \$5,000,000;
- 3) Reimbursements or payments expected to be ordered by the ACRRA Board during the next year are estimated to be \$500,000 to \$1,500,000;
- 4) ACRRA surcharges for 1993, as detailed above, will not be collected until the period November, 1993 to March, 1994; and,
- 5) The Commissioner of the MDA, and the ACRRA Board, have been informed by persons required by statute to pay ACRRA surcharges that notification of determination of surcharge amounts is best managed, most acceptable and least objectionable to those affected if such determination and disclosure is made as soon as possible and no later than the end of any respective calendar year.

I. Introduction and Background.

The Minnesota Department of Labor and Industry, Special Compensation Fund has long been involved in the administration of workers' compensation claims brought by uninsured injured workers pursuant to *Minnesota Statutes* § 176.183. The Special Claims Unit of the Special Fund is to review claims made by uninsured employees and also is to conduct an investigation to determine liability.

Pursuant to its grant of authority, if the Special Fund makes a determination that there is liability, the Department will accept the claim and begin paying appropriate workers' compensation benefits to the injured employee of an uninsured employer.

The Department is considering various options to improve the quality, the efficiency, and the ability of the special claims unit to receive, analyze, investigate and make determinations on workers' compensation liability. The overall goal is to minimize the impact on employers and employees of making a workers' compensation claim.

An essential element of any claim is the question of primary liability, and, lesser questions regarding the employee's prior claim history, circumstances surrounding the injury, witnesses and the subsequent activities of the employee. Proper, expert investigative services are crucial in enabling the staff of the Special Claims Unit to handle and assess uninsured claims.

The options that the Department of Labor and Industry have considered, include, but are not limited to:

- 1. Increasing the number of Departmental staff in order to efficiently and professionally provide all services and tasks required for proper functioning of the Special Claims unit;
- 2. Contracting with a firm to provide investigation services for the Special Claims unit regarding the investigation and handling of workers' compensation cases.

II. The Scope of the Project.

The Department of Labor and Industry, Special Compensation Fund, Special Claims Unit, investigates all reports of uninsured/bankrupt self-insured claims to determine workers' compensation liability.

Investigation of uninsured/bankrupt-self-insured employees/employers includes taking statements from all relevant parties, producing asset checks on alleged uninsured employers, and production of all medical records.

At the present time, it is unknown what the volume of individual cases of workers' compensation uninsured claims will be on a monthly or yearly basis. Therefore, proposals should evidence the ability to be flexible and accommodating.

If the Department of Labor and Industry, Special Compensation Fund, decides to contract for investigative services, such services will be requested on a case by case basis. Heating Plant Mechanical and Electrical Upgrade Moorhead State University

Appropriation: \$4,090,000.00 to design and construct the upgrade.

Scope of Project: Rehabilitate heating plant to remedy equipment and operating problems, put the plant in reliable operating condition, and meet future steam demand. The work will require major mechanical and electrical construction:

The new emergency generator will be sized to handle all heating plant and campus emergency electric loads.

Asbestos abatement is included in the project budget, but is excluded from the selected engineer's scope of work.

<u>Purpose of the Project</u>: The objective of this work is to increase the maximum plant output from approximately 63,000 pounds per hour to something in excess of 160,000 pounds per hour. The heating plant boilers (there are three) have a combined steam output rating of 160,000 pounds per hour. Wear and tear (the boilers were new in 1958, 1966, and 1976) has reduced combined output to 125,500 pounds per hour. Limited electrical capacity within the heating building limits operation to only two boilers at a time, which further reduces the heating plant output to 85,500 pounds per hour. Deficiencies with the mechanical equipment that support the boilers further reduce the maximum plant output from 85,500 to 70,000 pounds per hour. Boiler fuel is interruptible natural gas and No. 6 fuel oil during periods of gas interruption. Gas interruption further reduces the plant output to 63,000 pounds per hour because 7,000 pounds per hour steam is required to heat the No. 6 oil. This 7,000 pounds per hour can be recovered by staying on natural gas, but the penalty for continuing with natural gas during interruptible times ranges from \$160,000-\$225,000.

Engineering Responsibilities: For planning through schematic design, the architect will be responsible for such tasks as review of the University's heating plant study report completed in 1991, preparation of preliminary schematics (including consideration of alternative designs), cost estimates, and the schematic design report. Following approval of schematic design, the engineer will continue with design development drawings, specifications, and cost estimate; final construction documents and cost estimate; and project administration during construction, including but not limited to preparation of construction change orders, review and approval/rejection of shop drawing and payment requests, oversight of project for owner (including on-site observation and chairing construction meetings), and recommendation to the owner of project acceptance. Design and construction will be done consistent with Minnesota State University System standards.

Prior experience with design of heating plants of similar size is required. Personnel with experience focused on construction will be an important consideration.

Engineer will be required to assist the University in obtaining all required Minnesota Pollution Control Agency permits and other required regulatory approvals.
