Minnesota Rules: Amendments and Additions:

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. The current 1995 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous State Register publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Exempt Rules

An exempt rule adopted under Minnesota Statutes §§ 14.386 or 14.388 is effective upon its publication in the State Register.

Emergency Expedited Rules

Provisions for the Commissioner of Natural Resources to adopt emergency expedited Game and Fish Rules are specified in *Minnesota Statutes* §§ 84.027. The commissioner may adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months.

Adopted Permanent Rules Relating to Safety and Health Standards; Adoption of Federal Occupational Safety and Health Standards by Reference

The rules proposed and published at State Register, Volume 21, Number 26, pages 878-881, December 23, 1996 (21 SR 878), are adopted as proposed.

Revenue Notices =

The Department of Revenue began issuing revenue notices in July of 1991. Revenue notices are statements of policy made by the department that provide interpretation, detail, or supplementary information concerning a particular statute, rule, or departmental practice. The authority to issue revenue notices is found in *Minnesota Statutes* §270.0604.

Revenue Notice # 97-03: Income and Franchise Tax - Federal Entity "Check the Box" Classification Rule

The Department feels a need to clarify how Treasury Decision (T.D.) 8697, Internal Revenue Code Regulation § 301.7701-2 (Dec. 17, 1996), effective January 1, 1997, will impact the classification of Minnesota business entities under Minnesota Statutes § 290.01, subds. 3, 4, and 31. Treasury Decision 8697 simplifies the process of classifying business organizations by allowing businesses to indicate how they would like to be classified. The Department will follow T.D. 8697 with respect to its "check the box" regulation. This will make it easier for entities to classify their business for income and franchise tax purposes.

Public Notice for the National Pollutant Discharge Elimination System (NPDES) and State Disposal System (SDS) Permit Program Draft NPDES and SDS General Permit to Discharge Treated Filter Backwash Water to Waters of the State

The Minnesota Pollution Control Agency proposes to reissue the general permit covering domestic water treatment facilities of Minnesota discharging treated filter backwash to waters of the state. This general permit will provide timely reissuance without the delay of individual permit reissuance procedures and will cover more than 40 facilities. The general permit has a duration of approximately five years.

This permit regulates the surface water discharge resulting from domestic water treatment plants being operated in the state. A general permit will only be issued in cases where:

- a) the discharge consists of filter backwash water from water treatment plants;
- b) the facility must provide a detention time of at least 24 hours before the discharge of filter backwash water to the receiving water;
- the discharge of treated filter backwash water to surface water, or to ground water indirectly through seepage will not have a significant impact on water quality;
- d) the discharge is not a new discharge to an outstanding resource value water (ORVW);
- e) any chemical water softening treatment plants, such as lime, alum, ferric chlorine or zinc are excluded from this general permit;
- f) the discharge does not contain a contaminant not specifically limited in the permit; and
- the discharge will not violate water quality standards contained in *Minnesota Rules* Chapter 7050, ground water quality standards (*Minnesota Rules* 7050.0220), or air emissions of toxic pollutants (*Minnesota Statutes* § 116.081, subd. 4.A.

This general permit establishes effluent limitations, monitoring requirements, and other conditions on facilities which discharge treated filter backwash water. The Commissioner's determination that the general permit should be reissued is tentative. Interested persons are invited to submit written comments upon the proposed permit action. The public comment period begins March 17, 1997, and ends April 16, 1997. 
