

## Minnesota Rules: Amendments and Additions =

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1997 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ## **Expedited Emergency Rules**

Provisions exist for the Commissioners of some state agencies to adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these emergency expedited rules detail the agency's rulemaking authority.

### **Department of Natural Resources**

Proposed Emergency Rules Relating to Closed Waters; Waters with Restrictions on Taking Fish 6262.0500 WATERS CLOSED TO TAKING FISH.

Subp. 2a. Waters closed to possession of fish. The following waters have restrictions on the possession of fish:

[For text of items A and B, see M.R.]

[Item C. EXPIRED]

[For text of item D, see 22 SR 1907, April 27, 1998]

- E. Crawford Lake in Wright county: T.119, R.25, S.20 is closed to the possession of all fish through February 29, 2000, except that the daily and possession limit for sunfish is five.
- F. Mountain Lake in Cottonwood county: T.106, R.34, S.32, 33 is closed to the possession of all fish through May 12, 2000. Effective May 13, 2000, until February 28, 2002, Mountain Lake is closed to the possession of walleye, largemouth bass, black crappie, yellow perch, and northern pike, except the daily and possession limit for sunfish is five.

Anglers must immediately return to the water the fish species noted for each water. It shall be unlawful for anyone to have in possession or under control, regardless of where taken, fish species noted for each water while on or fishing on these waters. Possession includes personal possession and possession in a vehicle.

#### 6262.0550 WATERS WITH RESTRICTIONS ON TAKING FISH.

Angling for largemouth bass and smallmouth bass shall be limited to catch and release only, whereby any largemouth bass or smallmouth bass caught must be immediately returned to the water. Catch and release angling for largemouth bass and smallmouth bass shall be legal during the open season for largemouth bass and smallmouth bass in inland waters. It is unlawful for anyone to have in possession, regardless of where taken, any largemouth bass or smallmouth bass while on or fishing in these waters.

**EFFECTIVE PERIOD.** The emergency rules take effect five working days after approval by the attorney general and are effective for 18 months after that date.

### **Executive Orders**

The governor has the authority to issue written statements or orders, called Executive Orders, as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

## Emergency Executive Order #99-13: Providing for Personnel and Equipment for the Monticello Nuclear Power Plant Drill and Exercise

**I, JESSE VENTURA, GOVERNOR OF THE STATE OF MINNESOTA,** by virtue of the authority vested in me by the Constitution and the applicable statutes, do hereby issue this Emergency Executive Order:

WHEREAS, the Minnesota Department of Public Safety, Division of Emergency Management, has requested assistance in providing personnel and equipment to support the Monticello Nuclear Power Plant Drill and Exercise; and

**WHEREAS**, adequate personnel and equipment are not available from the Department of Public Safety, other participating agencies, Sherburne and Wright Counties of Minnesota and other local authorities;

#### **NOW, THEREFORE,** I hereby order that:

- 1. The Adjutant General of Minnesota order to state active duty on or about May 12, 1999, and June 22, 1999, in the service of the State, such personnel and equipment of the military forces of the State needed by the Department of Public Safety and Sherburne and Wright Counties to successfully complete the Monticello Nuclear Power Plant Drill and Exercise.
- 2. The cost of subsistence, transportation, fuel, pay and allowances of said individuals shall be paid by the Department of Public Safety, Division of Emergency Management, as provided by an interdepartmental agreement dated August 7, 1995.

Pursuant to *Minnesota Statutes* 1998, section 4.035, subd. 2, this Order is effective immediately and shall remain in effect until rescinded by proper authority or it expires in accordance with *Minnesota Statutes* 1998, section 4.035, subd. 3.

#### Revenue Notice #99-06: Sales and Use Tax - Technical Correction to Revenue Notice # 98-01

Revenue Notice # 98-01, which was published in the *State Register* on January 26, 1998, contains a technical error in the form of an incorrect date in the first paragraph. The first paragraph should be corrected as follows:

"Minnesota Statutes, § 297A.25, subdivision 65, provides an exemption from sales and use tax for construction materials and supplies used in a project mandated by state or federal law, rule or regulation to construct or improve an adult or juvenile correctional facility. However, Minnesota Statutes, § 297A.15, subdivision 7, requires that the sales or use tax must first be paid on purchases of the construction materials and supplies and the governmental subdivision must apply for a refund of the tax paid. Materials and supplies purchased from June 1, 1992 through August 31, 1997 1996 are eligible for a refund of 20 percent of the sales or use tax paid. Purchases of materials and supplies made after August 31, 1997 1996 are eligible for a full refund of the sales or use tax paid. "

## REQUEST FOR COMMENTS on Planned Amendment to Permanent Rules Relating to Passing Scores for State Tests of Basic Requirements, *Minnesota Rules*, 3501.0180, Subparts 2 and 3

**Background.** In the July 14, 1997 *State Register*, Volume 22, Number 2, the State Board of Education published amended Rules Relating to Passing Scores for State Tests of Basic Requirements. This amendment was made using the exempt rule process as directed by *Minnesota Laws* 1997, Ch. 138, Sec. 2(a), to keep the passing score for the tests of mathematics and reading at the 75 percent level. These exempt rules are temporary; therefore, the Board plans to permanently amend the rules to keep the passing score at 75 percent level using Chapter 14 rulemaking procedures.

**Subject of Rules.** The State Board of Education requests comments on the planned amendment of Rules Relating to Passing Scores for State Tests of Basic Requirements. By deleting language in the rule that would raise the score to 80 percent, the planned permanent amendment to the rules would keep the passing score at 75 percent, which is the same level that it has been since 1997.

**Persons Affected.** The proposed rules would affect public school students, their parents, teachers, school administrators, local school boards and communities. The Board is not appointing an advisory committee to comment on the planned rule.

Statutory Authority. Minnesota Laws of 1997, Ch. 138, Sec 2(b) authorized the State Board of Education to amend this rule.

## Commissioner's Request to Report Cases, Suspect Cases, Carriers and Deaths Due to Methicillin-resistant *Staphylococcus aureus* Pursuant to *Minnesota Rules* Part 4605-7080

The Commissioner of Health has determined pursuant to *Minnesota Statute* {§§} 144.05, 144.0742 and 144.12, and *Minnesota Rules* part 4605.7080 that cases, suspect cases, carriers and deaths due to community-acquired methicillin-resistant *Staphylococcus aureus* be considered a reportable disease inasmuch as the following circumstances exist.

- A. Since many questions about the epidemiology of community acquired methicillin-resistant *Staphylococcus aureus* (MRSA) are as yet unanswered, reporting will assist in further understanding the risk for disease and prevention and control measures. The incidence of community-acquired MRSA remains unknown. For the period of 1997 to 1999, the Minnesota Department of Health (MDH) received reports of two deaths in children under fourteen years of age due to MRSA. Neither the MDH nor the U. S. Centers for Disease Control and Prevention conduct surveillance for community-acquired MRSA. Although much is known about MRSA infections acquired in hospitals or nursing homes, information about the prevalence of community-acquired MRSA infections is not known.
- B. Information about the virulence for community-acquired MRSA is not available. A review of the medical literature does not provide information about the virulence of community-acquired MRSA. Persons infected with community-acquired MRSA may develop infections at any body site including: superficial skin infections, osteomyelitis, pneumonia, and septicemia; some of these infections may result in death. The frequency with which persons carrying community-acquired MRSA develop serious disease is not known.
- C. Because MRSA has been associated with infections in hospital or nursing home patients and has not been associated with infections in previously healthy children, identifying the prevalence of community-acquired MRSA (in healthy populations) may provide physicians and other primary care givers with data on which to base antibiotic selection. Timely and appropriate use of antibiotics effective against *Staphylococcus aureus* may prevent serious infections and possibly death.
- D. A case-oriented public health response would be helpful for control inasmuch as surveillance for community-acquired MRSA may allow for identification of the prevalence of MRSA within a community which could lead to implications for treatment and control measures. Through interviewing a sample of persons with community-acquired MRSA the spectrum of illness associated with this bacteria can be better defined, risk factors may be identified, and appropriate control mechanisms can be implemented.
- E. The commissioner has developed a specific protocol and methodology incorporating active surveillance and data collection as follows:
  - 1. Persons required to report disease as specified in *Minnesota Rule* part 4605.7080 shall report deaths or serious illness from cases of community-acquired MRSA.
  - 2. The commissioner shall select a group of hospitals representing geographic and demographic diversity which shall:
    - a. Report all MRSA cases to the MDH;
    - b. Submit all MRSA isolates to the MDH for confirmation of antibiotic-susceptibility testing and genetic typing;
    - c. Provide medical records of MRSA positive patients for review by MDH epidemiology staff;
    - d. The MDH shall interview a sample of MRSA patients from each of the hospitals selected by the commissioner (see above) to determine possible exposures to non-community-acquired MRSA.
- F. For the reasons referenced above, the Commissioner of Health hereby requests reporting to the Department of Health all cases, suspect cases, and carriers of community-acquired methicillin resistant *Staphylococcus aureus* in a select group of hospitals beginning July 1, 1999;
- G. The Commissioner of Health hereby requests reporting to the Department of Health all deaths and serious illness caused by community-acquired MRSA throughout Minnesota be reported to the Department of Health beginning July 1, 1999.

Employers covered by workers' compensation insurance, including those approved as self-insured employers, are eligible to apply for safety/health matching grants to abate safety hazards in their workplace. The safety/health hazards must have been identified in an on-site survey conducted by one of the following: 1) MNOSHA safety/health investigator, 2) DLI Workplace Safety Consultation safety/health consultant, 3) in-house employee safety/health committee, 4) workers' compensation underwriter, or 5) private safety/health consultant.
