

## Minnesota Rules: Amendments and Additions =

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. 

## Notice of Adoption of Ordinance No. 95

Please take notice that on the 21st day of February, at a regular meeting, the Metropolitan Airports Commission adopted Ordinance No. 95.

#### Ordinance No. 95:

An Ordinance to promote and conserve public safety, health, peace, convenience and welfare, to provide regulation on use of the Minneapolis-St. Paul International Airport – Wold – Chamberlain Field and to control the loading and unloading of passengers and freight thereat; to provide for payment of landing fees by aircraft other than signatory airlines and military aircraft; to provide for payment of Facility Use Fees, Aircraft Parking Fees, and Federal Inspections Services Facility Use Fees and the new Humphrey Terminal; prescribing the penalty for violation thereof; and to repeal Commission Ordinance No. 89.

## Notice of Public Hearing on Proposed Bus Fare Increase

The Metropolitan Council this week approved a series of public hearings in April, 2001, to hear comment on its proposal to increase regional bus fares effective July 1, 2001. The increase in base fares will be the first since December 1993, and is necessary to cover an \$8 million annual funding shortfall in transit operating costs in 2001 and 2002.

The base fare for most rides would increase by \$.25 per ride. The new base fares are:

- Off-peak local, up \$.25 to \$1.25
- Peak local, up \$.25 to \$1.75
- Off-peak express, up \$.25 to \$1.75
- Peak express, up \$.25 to \$2.25

Some other modifications in transit service have also been proposed. A new 15-day unlimited ride pass would replace the current 31-day unlimited ride pass. Also, an increased discount of 20 percent off the normal full-fare price would be applied to off-peak local passes. New 15-day passes for the other rate categories will be discounted 10 percent off the normal full fare price. Limited mobility, senior and fares for children aged 6-12 would remain unchanged at \$.50 per ride. Metro Mobility off-peak fares would remain at \$2.00, but peak fares will increase to \$3.00. Downtown zone off-peak fares would increase to \$.50, equal to the current peak zone fare.

The proposed increases will help Metro Transit and suburban providers respond to higher costs due to inflation, fuel, labor and insurance, and more services routes since the last fare adjustment. The proposed changes have been made with these three goals in mind: 1) generate more revenue to offset increased costs; 2) maintain a simple fare structure; and 3) recognize equity issues among various transit riders.

# Request for Comments Sought on Planned Amendments to Rules Governing Storm Water Permits and Permit Fees, *Minnesota Rules* Chapters 7001 and 7002

**Subject of Rules:** On March 13, 1995, the Minnesota Pollution Control Agency (MPCA or agency) adopted permanent rules governing storm water discharge permits and associated fees, *Minnesota Rules* Chapters 7001 and 7002. Following the adoption of these rules, regulated parties requested an exemption from the industrial storm water permit rules, *Minnesota Rules* part 7001.1035, because they had no exposure to industrial activities or materials from storm water. The MPCA was unable to consider the exemption requests because the initial applicable federal rules did not allow for exemptions beyond a defined category. Following a Ninth Circuit court remand on the defined category for exemptions, the federal regulations for "no exposure certification" were promulgated.

The MPCA is in the preliminary stages of pursuing environmental tax reform through the MPCA Environmental Tax Reform Proposal (Proposal). The goal of the Proposal is to restructure existing fee structures and establish function-based accounts that can be directed to the most significant environmental problems. It is anticipated that the Proposal will result in the elimination of various fees and the MPCA expects the water quality fees to be impacted. Given the impact a successful Proposal would have, the

MPCA does not intend to pursue changes to rules that would impact the existing fee structures with this first state rulemaking effort. Failure or significant changes to the Proposal may result in future rulemaking that impacts fees.

The MPCA requests comments on its planned rule amendments that would incorporate by reference the federal no exposure certification provisions of 40 CFR 122.26(g)(1)-(g)(4) for sources required to obtain a National Pollutant Discharge Elimination System (NPDES) permit under *Minnesota Rules* part 7001.1035. Incorporation of the federal requirements into state regulations is required before sources may take advantage of the new federal no exposure certification provisions. Incorporation of these provisions may result in a decrease in fees for eligible sources.

**Persons Affected.** The rule amendments will likely affect current industrial storm water permit holders required to obtain an industrial storm water permit pursuant to *Minnesota Rules* part 7001.1035. This same group is subject to associated permit application fees and annual fees. The group of persons most affected would consist of current permittees categorized as holding mandatory permits. Currently there are approximately 2,112 industrial storm water permittees categorized as mandatory and discretionary. The MPCA expects that only the mandatory category of permittees will be affected by the no exposure certification provisions. Of the current 930 "mandatory" industrial storm water permittees, the MPCA estimates approximately 232 may be eligible.

**Statutory Authority.** *Minnesota Statutes*, section 115.03, subdivision 5 authorizes the MPCA to adopt rules in order to prevent, control or abate water pollution.

**Public Comment.** Interested persons or groups may submit comments or information on this planned rule in writing or orally until 4:30 p.m. on April 11, 2001. The MPCA does not intend to form an advisory work group to assist with the rule amendments.

**Rule Drafts.** The MPCA has not yet prepared a draft of the planned rule amendments.

# Public Notice of Intent to Issue for the National Pollution Discharge Elimination System (NPDES)/State Disposal System (SDS) Permit MN G790000

**NOTICE IS HEREBY GIVEN** that Minnesota Pollution Control Agency (MPCA) proposes to reissue the NPDES/SDS General Permit (general permit) to cover facilities discharging or proposing to discharge treated wastewater from ground water remediation projects to waters of the state or the unsaturated zone. The general permit will be reissued for a term of approximately five years. The public comment period begins March 12, 2001 and ends at 4:30 p.m. on April 11, 2001.

This general permit is being proposed as a mechanism to regulate the extraction of petroleum contaminated ground water, which is found to be a threat to public welfare and the environment. It is important that these requests be addressed without delay due to the need to initiate remediation as soon as possible in order to prevent the possible spread of contaminant plumes in ground water. This general permit will allow cleanup actions at contaminated sites to begin without the delays of individual permit issuance procedures. This general permit has authorized discharges at over one hundred such sites. This permit currently covers about forty sites.

The authority to develop and issue a general permit is based on the 1979 Environmental Protection Agency (EPA) promulgated revisions to the NPDES program regulations, which created a class of permits called general permits. The general permits are issued under 40 CFR §122.28 and *Minnesota Rule* 7001.0210. General permits can be issued in NPDES approved states if the

approved state program includes general permit activities. EPA approved the General Permit Program of the MPCA on December 15, 1987.

This general permit regulates the discharge of ground water contaminated with petroleum products. Coverage under the general permit will only be authorized in cases where:

- 1. The source of the contamination is petroleum and/or petroleum related products,
- 2. The discharge is less than or equal to 50 gallons per minute (72,000 gallons per day),
- 3. The discharge is not to an Outstanding Resource Value Water, trout water, or to waters on tribal lands,
- 4. The Commissioner determines that the discharge of the treated, extracted water will not have significant impacts on the receiving waters,
- 5. The discharge would not violate surface water quality standards or ground water quality standards.

The NPDES/SDS general permit establishes effluent limitations, monitoring requirements, and other conditions for sites which discharge treated ground water incidental to the petroleum contaminated ground water cleanup operations. General conditions which are a part of all NPDES/SDS permits are included as part of this general permit.

The Minnesota Department of Administration, Division of State Building Construction (STATE) is requesting proposals for an independent testing agency (Testing Agency) certified in the State of Minnesota to coordinate the planning, field testing and administration for the windows on the Retirement Systems of Minnesota Building at 60 Empire Drive, St. Paul, Minnesota 55155.

#### A. Project Overview

The Project consists of site analysis and review of installation to correspond with the bid documents and construction administration for exterior windows. STATE has estimated that this analysis, testing and administration work, including reimbursable expenses, will not exceed \$35,000.00.

#### B. Goal

It is the goal of this project that the Retirement Systems of Minnesota Building windows will meet American Society for Testing and Materials (ASTM) recommended standards.

  - c. Air infiltration tests to be conducted at a uniform static test pressure of 6.24 psf. The maximum allowable rate of air leakage will not exceed .15 cfm per foot of sash crack length.
  - d. Water penetration tests to be conducted at a static test pressure of 10 psf.
  - e. For each test that fails, the STATE will select two additional windows to be tested. All unsuccessful tests, both original and retest as well as additional windows to be tested due to an unsuccessful test will be paid by the Design/Builder, The Ryan Companies, U.S. Inc. (Ryan Companies).
  - f. Testing agent to provide all vertical access required for testing of windows selected.
- 2. Testing Agent will be directly responsible to the STATE's Project Manager and work closely on site with STATE's Project Representatives—Cost Planning Management, Inc (CPMI) and Minnesota Department of Administration Plant Management Division, the Design Builder—Ryan Companies, and representatives from three (3) Retirement Systems Boards and other STATE personnel.

- Testing Agent will submit a written work plan on task organization for approval by CPMI's Project Manager and the STATE's Project Representative.
- 4. Testing Agent will review with CPMI Project Manager adherence to project requirements and completeness of installation of windows prior to approval to proceed and prepare oral and written reports as required.
- 5. Testing Agent will participate in coordination of activities of construction; prepare as needed, site installation and analysis of tests, and review results with and recommend adjustments to CPMI's Project Manager.
- 6. Testing Agent will prepare a report for all types of windows tested.

Responders are encouraged to propose additional tasks or activities if it will substantially improve the results of the window installation. These items should be separated from the required items on the Testing Agency's proposal.

#### D. Contract and General Requirements

- 1. The Testing Agency is required to be certified in the State of Minnesota. Testing Agency shall not provide any other services or materials not specified in the contract.

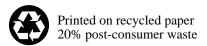
