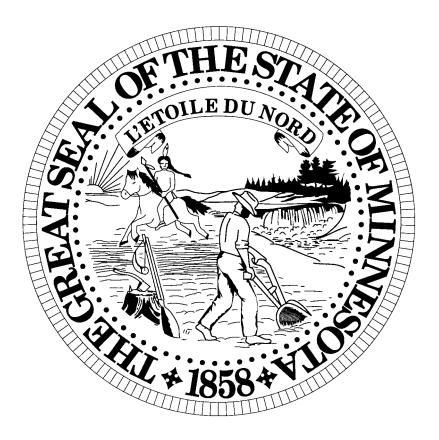

# Minnesota Rules: Amendments and Additions =

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety in the State Register, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the Minnesota Guidebook to State Agency Services.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # **Expedited Emergency Rules**

Provisions exist for the Commissioners of some state agencies to adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months. Specific *Minnesota Statutes* citations accompanying these emergency expedited rules detail the agency's rulemaking authority.

# Adopted Expedited Emergency Game and Fish Rules: Bemidji Game Refuge, Waterfowl Hunting, Deer Hunting, Falconry

**NOTICE IS HEREBY GIVEN** that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rules is *Minnesota Statutes*, sections 97A.091, 97B.305, 97B.301, 97B.305, 97B.311, 97B.731, 97B.802, and 97B.803.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that:

- 1) Deer. Population data needed to establish quotas and classify permit areas are not available until June. Deer populations continued to increase in 2003, despite record antlerless permit quotas in 2002, prompting the need to redesign the deer permit area system to facilitate higher harvest and to reduce unnecessary paperwork for hunters. Data needed to classify the permit areas by type were not available until deer population modeling was completed in June.
- 2) Falconry. Waterfowl seasons by all methods, including falconry, are limited by federal rule to no more than 107 days per year. The change to falconry waterfowl seasons is necessary to be consistent with Minnesota's waterfowl seasons established under the federal frameworks that were announced in early August.
- 3) **Migratory waterfowl.** Coots, moorhens, duck, and goose breeding population data are not available until June and federal frameworks for late season migratory birds are not announced until early August.

Subp. 2. Bemidji Game Refuge, Beltrami county. The Bemidji Game Refuge in Beltrami county is open to:

A. small game hunting, except waterfowl, through October 31 the Thursday nearest November 4;

Subp. 8. **Bag limit.** A person may not tag more than one deer during a license year by any method, except as authorized in items A to  $\frac{\mathbf{P}}{\mathbf{F}}$ .

# **Expedited Emergency Rules**:

- F. Total bag limits by deer permit area are as follows:
  - (1) the total bag limit for lottery deer permit areas is one deer, except all-season license holders may take two deer;
- (2) the total bag limit for managed deer permit areas is two deer, except all-season license holders may take up to three deer. Archery and muzzleloader hunters using intensive harvest permits may not harvest antlerless deer in more than one managed deer permit area. Hunters may not harvest a deer with both a firearms deer management permit and an intensive harvest permit in managed deer permit areas;
  - (3) the total bag limit for intensive deer permit areas is five deer; and
- (4) in addition to the total bag limits under subitems (1) to (3), a person with a free landowner deer license may take one additional antlerless deer on land owned or leased by the person in managed and intensive deer permit areas.

#### 6232.1300 SEASONS FOR TAKING DEER BY FIREARMS.

Subp. 5. Taking antlerless deer on firearms licenses. The provisions for taking antlerless deer in this part apply to the use of a regular firearms or all-season deer license tag. In addition, antlerless deer may be taken and tagged with management and intensive harvest permits as prescribed in parts 6232.1900 and 6232.1950.

#### 6234,0800 HUNTING BY FALCONRY.

Subp. 4. **Open season and hours for migratory game birds.** Woodcock, sora and Virginia rails, and common snipe may be taken by falconry from September 1 to December 16. Ducks, coots, and moorhens (Gallinules) may be taken by falconry from the Saturday nearest October 1 September 27 to the Saturday nearest January 14 10. Geese may be taken by falconry during any open goose season. Crows may be taken by falconry during the open season. Falconry hours are from one-half hour before sunrise to sunset, except during the regular waterfowl season when falconry hours are the same as waterfowl shooting hours.

#### 6240.0650 TAKING COOTS, MOORHENS, AND DUCKS.

- Subpart 1. Open season. Coots, moorhens, and ducks, except pintails and canvasbacks, may be taken statewide during the 60-day period from September 27 to November 25, 2003. Pintails may be taken statewide during the 30-day period from September 27 to October 26, 2003. Canvasbacks may be taken during the 30-day period from October 11 to November 9, 2003.
- Subp. 2. Daily limits. In any one day, a person may not take more than: six ducks, five mergansers, and a total of 15 coots and moorhens. The daily limit of ducks (other than mergansers) may not include more than four mallards, of which not more than two may be female mallards; one black duck; two redheads; three lesser or greater scaup; two wood ducks; one pintail; and one canvasback, during the respective open seasons in subpart 1. The daily limit of mergansers may not include more than one hooded merganser.

### 6240.0950 OPEN SEASONS; DAILY LIMIT; WEST, WEST CENTRAL, AND NORTHWEST GOOSE ZONES.

- Subpart 1. Open season; West Goose Zone. Canada geese may be taken in the West Goose Zone during the 40-day period from September 27 to November 5, 2003, except in the West Central Goose Zone as provided in subpart 2.
- <u>Subp. 2.</u> **Open season; West Central Goose Zone.** <u>Canada geese may be taken in the West Central Goose Zone during the 40-day period from October 11 to November 19, 2003.</u>
- Subp. 3. Open season; Northwest Goose Zone. Canada geese may be taken in the Northwest Goose Zone during the 40-day period from September 27 to November 5, 2003.
- Subp. 4. Daily limit. A person may not take more than one Canada goose in the West, West Central, and Northwest Goose Zones.

  6240.1000 TAKING CANADA GEESE IN SOUTHEAST GOOSE ZONE.

- Subp. 2. [See repealer.]

### 6240.1100 TAKING CANADA GEESE IN REMAINDER OF STATE.

<u>Subpart 1.</u> **Zone and season.** The remainder of the state consists of all areas not within the <del>Southeast,</del> Northwest, and West Goose Zones. Canada <del>and white fronted</del> geese <del>and brant</del> may be taken in the remainder of the state during the 70-day period beginning

the Saturday on or nearest October 1, September 27.

Subp. 2. Daily limit. A person may not take more than two Canada geese each day in the remainder of the state.

### 6240.1150 TAKING SNOW, BLUE, AND ROSS', AND WHITE-FRONTED GEESE AND BRANT.

<u>Subpart 1.</u> Seasons. Snow, blue, and Ross', and white-fronted geese and brant may be taken statewide during the 80-day period beginning the Saturday on or nearest October 1, except that the season in the Lac qui Parle Goose Zone will be closed when the season for Canada and white-fronted geese is closed, September 27.

Subp. 2. Daily limit. A person may not take more than 20 snow, blue, and Ross' geese in combination; two white-fronted geese; and one brant each day.

### 6240.1900 LATE SEASON FOR TAKING CANADA GEESE.

Subpart 1. **Daily limit.** A person may not take more than two five Canada geese per day during the late season, except that no more than two Canada geese per day may be taken in the Southeast Goose Zone.

Subp. 3. Seasons. Canada geese may be taken in the Twin Cities Metro Canada Goose Zone and the Fergus Falls/Alexandria Goose Zone and in Olmsted County during the ten day period beginning the second Saturday in December statewide from December 6 to December 15, 2003, except for the Southeast Goose Zone where Canada geese may be taken from December 12 to December 21, 2003, and except for the West Central Goose Zone, which is closed to late season hunting of Canada geese. Taking Canada geese on or within 100 yards of all surface waters, excluding ice, is prohibited in the Twin Cities Metro Canada Goose Zone during the late season.

<u>Subp. 4.</u> Special Canada goose license required. The late seasons established in this part are special seasons for purposes of the special season Canada goose license required under *Minnesota Statutes*, section 97B.802.

**REPEALER.** Minnesota Rules, part 6240.1000, subpart 2, is repealed. The expedited emergency amendments to part 6240.1000, subpart 1, published in the State Register, volume 27, page 290, August 26, 2002, are repealed.

**EFFECTIVE PERIOD.** The emergency amendments to *Minnesota Rules*, parts 6230.0400; 6232.0300; 6232.1300; 6234.0800; 6240.1000; 6240.1100; 6240.1150; and 6240.1900, and the repealer expire December 31, 2003. REQUEST FOR COMMENTS on Proposed Amendments to Rules Relating to Continuing Teacher License Issuance and Renewal Requirement Regarding the Understanding of Warning Signs For Mental Illness in Children and Adolescents [Proposed Amendments to Minnesota Rules 8710.7200, Subpart 2.]

Subject of Rules. The Board of Teaching requests comments on its proposed rules regarding a statutory requirement that, effective with teaching licenses that expire on or after June 30, 2003, all teachers must include in their renewal clock hours additional preparation in understanding the key warning signs of early-onset mental illness in children and adolescents.

Persons Affected. The amendments to the rules would likely affect teachers, the schools they will serve, and educational organizations and institutions in Minnesota.

Statutory Authority. Minnesota Statutes, section 122A.09, subdivision 4, grants authority to the Board of Teaching to adopt rules regarding teacher licensure and renewal. This statue was amended by Laws of Minnesota 2003, Special Session, Chapter 9, Article 2, Section 7, to include the following provision:

(n) The board must adopt rules that require all licensed teachers who are renewing their continuing license to include in their renewal requirements further preparation in understanding the key warning signs of early-onset mental illness in children and adolescents.
