NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Pursuant to Minnesota Statutes § § 14.101, an agency must first solicit comments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking. The *State Register* also publishes other official notices of state agencies and non-state agencies, including notices of meetings and matters of public interest.

REQUESTS FOR COMMENTS on Possible Adoption of Rules Governing a New Mortality Table for Life Insurance Reserves and Nonforfeiture Benefits

Subject of Rules. The Minnesota Department of Commerce requests comments on its possible adoption of rules governing the recognition and use of the 2001 CSO Mortality Table in determining minimum reserve liabilities and nonforfeiture benefits for life insurance policies. The purpose of the rules would be to recognize, permit and prescribe the use of the 2001 Commissioners Standard Ordinary (CSO) mortality table in accordance with certain sections of the Standard Valuation Law under *Minnesota Statutes* § 61A.25, the Standard Nonforfeiture Law under *Minnesota Statutes* § 61A.24, and *Minnesota Rules*, chapter 2747, Valuation of Life Insurance Policies.

Persons Affected. The promulgation of the rules would affect insurance companies authorized to conduct business in Minnesota.

Statutory Authority. *Minnesota Statutes* §§ 61A.25, 61A.24, and 45.023, authorize the Department to adopt rules for updating the mortality tables recommended and approved by the National Association of Insurance Commissioners.

Public Comment. Interested persons or groups may submit comments or information on these possible rules in writing until further notice is published in the *State Register* that the Department intends to adopt the rules. The Department contemplates appointing an advisory committee to comment on the possible rules. Anyone interested in serving on the advisory committee should write to or call the agency contact person.

Rules Drafts. The Department does not anticipate that a draft of the possible rules will be available before the publication of the proposed rules.

NOTE: Comments received in response to this notice will not necessarily be included in the formal rulemaking record submitted to the administrative law judge when a proceeding to adopt rules is started. The agency is required to submit to the judge only those written comments received in response to the rules after they are proposed. If you submitted comments during the development of the rules and you want to ensure that the administrative law judge reviews the comments, you should resubmit the comments after the rules are formally proposed.

Request for Applications: Community Development Corporations 2003-2005 Introduction

The Minnesota Legislature. During the 1993, 1994, 1995, and 1996 sessions, amended the statutes governing community development corporations. *Minnesota Statutes 116J.982 includes specific standards and procedures for a CDC to become "certified"*

and therefore eligible to receive grants and enter into contracts with the State.

To become certified, a CDC must fulfill all basic eligibility standards and provide documentation indicated on the application which is available by contacting the Department of Employment and Economic Development (DEED) at the address and telephone number indicated below.

Benefits of Certification

Only certified CDCs would be invited to apply grant funds should they become available through DEED. During 2003 no CDC grant funds are available to CDCs.

At the discretion of the Commissioner of the Housing Finance Agency (MHFA), certified CDCs may enter into contracts with the contracts with MHFA for purposes of housing activities associated with economic development activities.

A certified CDC is also exempt from real estate license requirements of *Minnesota Statutes* 82.80 (call DEED to receive a copy of this section of statutes).

Deadline for Certification Application

Applications for CDC certification must be received by the Department of Employment and Economic Development by 2:30 p.m., September 5, 2003.

Summary of Amended Legislation

Minnesota Statutes 116J.982 sets forth a number of requirements and qualifications for certification. These are summarized below.

Incorporation

A community development corporation must be a non-profit corporation under *Minnesota Statutes* 317A, the "Minnesota Non Profit Corporation Act." It stipulates the requirements for incorporation as a non-profit corporation; evidence from the Secretary of State's Office that the CDC has met those requirements will be required as part of the certification process. The CDC must also be tax exempt under Section 501 (C) (3) of the Internal Revenue Service code (IRS), and also be able to document that status.

If a corporation is a non-profit but yet has to receive its notification from the IRS that it is a 501 (C) (3), it may still apply to become a state certified CDC; on the application the corporation will then be asked whether it has applied to the IRS and when it plans to attain status.

Purpose of the Corporation

The major purpose of the corporation must be economic development, redevelopment, and/or housing in its designated area. Articles of incorporation or bylaws will be required to document the organization's purpose.

Designated Area

The CDC must designate a low-income area as the geographic area in which it will operate. Within the cities of the first class (Minneapolis, St. Paul, and Duluth), a designated community must be an identifiable neighborhood or a combination of neighborhoods, but may not be an entire city. In other parts of Minnesota, a designated community can't include an entire economic development region or cross regional boundaries. Those regions are the twelve regions established under *Minnesota Statutes* 462; contact DEED if you have any questions about geographic areas covered by those regions.

Low Income Requirements

For purposes of the Community Development Certification Program, "low income" means gross income below the Housing and Urban Development (HUD) low income level. Low-income standards vary on a local basis. To receive 2003 low income criteria for your community, please telephone Gerald Wenner at DEED, (651) 297-1844 or (800) 657-3858.

"Low income area" means an area that is 10% of the population have low incomes, or there are one or more recognized areas such as census tract, city, township, or county in which 15% of the populations have low incomes.

The HUD low income guidelines will be helpful in determining whether the non-profit corporation's board of directors meet low income requirements (see "board membership" below).

Board of Directors Membership

A CDC's board of directors can fulfill certification membership requirements in either one of two ways:

1. The corporation's membership and board of directors must be representative of the designated area. At least 20% of the directors must have low incomes, or reside in low-income areas. At least 60% of the directors must be residents of or employed in the designated area. Other directors must be in business, financial, civic leaders or representative at large of the designated area. At least 40% of the directors must reside in the designated community.

Official Notices

 A corporation, which meets board structure requirements for a Certified Housing Development Organization (CHDO) under United States 24 CFR part 92.2 can meet the board membership requirements for CDC certification under the *Minnesota Statute*. The CHDO certification was developed to establish organizations eligible to receive funds under the HOME program. Information on the community development housing corporation program requirements can be obtained by calling Susan Ude at the Minnesota Housing Finance Agency, (651) 297-3656 or (800) 657-3769.

Professional, Technical & Consulting Contracts

Whichever route the CDC selects, it will be required to provide documentation of how its meets theses criteria.

In addition, the corporation is advised that it must not discriminate against any person(s) on the basis of a statute protected under *Minnesota Statues* 363, the Minnesota Human Rights Act. For more information on the provisions of that act contact the Minnesota Department of Human Rights, (651) 296-5663.

Technical Qualifications

The corporation must be skilled in the analysis and packaging of economic development, redevelopment, or housing projects, and be familiar with available public and private funding sources. During the past three years, the corporation must have completed two or more economic development, redevelopment, or housing projects within the designated area. For these projects to qualify, the organization must have primary responsibility for coordinating the execution of the activities.

If the corporation does not presently have the skills within the organization, it must be able to obtain these skills during the certification period, with its precise plan and schedule for acquiring the training skills.

Certification Period

Certification is for a period of two years from the date of certification, and can be renewed. DEED will provide re-certification materials to those organizations seeking renewal of their status.

REQUEST FOR COMMENTS on Possible Amendment to Rules Governing the Environmental Review Program, *Minnesota Rules*, Chapter 4410, Adopting Mandatory Review and **Exemption Categories for Recreational Trails**

Subject of Rules. The Minnesota Environmental Quality Board (EQB) is required by legislation passed in the 2003 legislative session to "adopt rules providing for threshold levels for environmental review for recreational trails." These rules are to be adopted by January 1, 2005. The EQB hereby requests comments on its possible adoption of rules establishing thresholds at which mandatory Environmental Assessment Worksheets (EAWs) and mandatory Environmental Impact Statements (EISs) would be required for certain recreational trails, and also establishing thresholds below which certain recreational trails would be exempted from environmental review. The rules that establish thresholds for mandatory EAWs and EISs are commonly referred to as "mandatory categories" and those that establish thresholds for exemptions are commonly referred to as "exemption categories," (or simply as "exemptions"). Mandatory and exemption categories are organized in the EQB's rules according to type or class of project or activity. This proposed rulemaking would potentially add mandatory categories and exemption categories for various types of recreational trails. These categories could apply to private as well as public recreational trails (provided that private trails would only be subject to review if governmental approval or financial assistance was involved).

Currently, the environmental review rules do not contain any mandatory review or exemption categories that apply directly to recreational trails of any type. An EAW may be prepared on a discretionary basis by a unit of government for a recreational trail, and citizens may request preparation of an EAW by filing a citizens petition as authorized by the environmental review rules. If

the EQB adopts mandatory review and exemption categories, review will become automatic for some trail projects, while discretionary review (including review initiated by citizen petition) will no longer be possible for some other projects. It is likely, however, that for most types of recreational trail projects, environmental review will neither become mandatory nor exempted through this rulemaking. For most of the classes of projects for which there now are mandatory review and exemption categories in the EQB's rules, most of the projects within the class neither fit within the mandatory categories nor the exemption categories (and are therefore subject to discretionary review).

Persons Affected. Adoption of mandatory review and exemption categories for recreational trails would directly affect units of government and private organizations that establish and construct recreational trails. Some new or extended trails proposed by these entities would become subject to the review procedures of the environmental review process. These entities would bear the costs of preparing the review documents, and the design and schedule for establishment of the trails may be altered as a result of this process.

Individuals and groups that use recreational trails may be indirectly affected by the adoption of mandatory review and exemption categories for recreational trails in that the design of and schedule for establishment of new or extended trails may be altered as a result of this process.

The public will also be affected by adoption of mandatory review and exemption categories for recreational trails. For those new or extended trails for which an EAW or EIS would be made mandatory, the public would automatically be able to participate in the review of the potential environmental impacts of those trails through review of the EAW or EIS documents. However, for any trail projects for which exemptions are adopted, the public would no longer have the opportunity to seek discretionary environmental review through the filing of a citizens petition.

Statutory Authority. *Minnesota Statutes*, section 116D.04, subd. 2a (2) authorizes the EQB to adopt rules establishing mandatory review and exemption categories for various types of activities. The EQB is specifically directed to adopt such categories for recreational trails by *Laws of Minnesota 2003*, Chapter 128, Article 1, section 167, subd. 3 (enacted as Senate File 905 in the 2003 regular legislative session).

Public Comment. Interested persons or groups may submit comments or information on these possible rules in writing or orally until 4:30 p.m. on Wednesday, **October 1, 2003**.

The EQB is especially seeking information about the following topics:

- For which types of recreational trails should mandatory EAW, mandatory EIS, and exemption categories be established? Should some types of trails not be placed in any of these categories (and therefore remain subject to possible discretionary review on a case-by-case basis)?
- Could some types of trails be logically grouped together into the same categories due to similar environmental impacts?
- What criteria or parameters should the EQB use to establish thresholds for review and exemption categories i.e., what criteria or parameters would be the best indicators of potential for environmental impacts?
- · Specific proposals for mandatory EAW, mandatory EIS, or exemption categories.
- Sources of information that might help EQB in developing categories -- e.g., published studies on environmental impacts from types of recreational trails or classifications of trails developed by other states according to potential for environmental impacts.

After reviewing the comments received, the EQB will decide if it would be useful to hold public meetings to discuss the proposed rules and obtain additional comments. Also, the EQB may consider forming an advisory committee to discuss the proposed rules more formally, if it appears that forming an advisory committee would be useful.

Rule Drafts. The EQB has not yet prepared a draft of the possible rules. It is the EQB's intent to obtain input from interested persons and organizations prior to drafting rules. Once a rule draft has been completed it will be available upon request and will be posted at the EQB's website at: *www. eqb.state.mn.us/review.html*.

Subject of Rules. The Minnesota Department of Revenue requests comments on its planned amendment to the rules governing the application of the Sales and Use Tax Laws to the sales of meals and drinks and food products. The Department is considering rule amendments that update the rules to reflect current practices and statutory provisions. The original Request for Comments was published in the *State Register* on May 15, 2000 (24 S.R. 1653). Because of the lengthy period of time that has passed since the original Request was published and because of the law changes that have been enacted since the original Request was published, the Department would like to receive more input from the public. The Rule addresses the following areas: food and food ingredients; soft drinks; candy; meals served at hospitals, sanitariums, nursing homes, senior citizens' homes, and correctional, detention, and detoxification facilities; meals served at schools; the definition of sales price (as it applies to the sale of food); food sold to transportation companies; incidental meals at recreational and educational programs; meals provided to employees; and the purchase of equipment by vendors of meals and drinks.

Persons Affected. The proposed rule would likely affect taxpayers in the food industry.
