## Minnesota Rules: Amendments and Additions =

#### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ## **Exempt Rules**

Exempt rules are excluded from the normal rulemaking procedures (*Minnesota Statutes* § 14.386 and 14.388). They are most often of two kinds. One kind is specifically exempted by the Legislature from rulemaking procedures, but approved for form by the Revisor of Statutes, reviewed for legality by the Office of Administrative Hearings, and then published in the *State Register*. These exempt rules are effective for two years only.

The second kind of exempt rule is one adopted where an agency for good cause finds that the rulemaking provisions of *Minnesota Statutes*, Chapter 14 are unnecessary, impracticable, or contrary to the public interest. This exemption can only be used where the rules:

- (1) address a serious and immediate threat to the public health, safety, or welfare, or
- (2) comply with a court order or a requirement in federal law in a manner that does not allow for compliance with *Minnesota Statutes* 14.14-14.28, or
- (3) incorporate specific changes set forth in applicable statutes when no interpretation of law is required, or
- (4) make changes that do not alter the sense, meaning or effect the rules.

These exempt rules are also reviewed for form by the Revisor or Statutes, for legality by the Office of Administrative Hearings and then published in the *State Register*. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years from the date of publication of the rule in the *State Register*. Rules adopted, amended or repealed under clause (3) or (4) are effective upon publication in the *State Register*.

The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

# Proposed Exempt Permanent Rules Relating to Occupational Safety and Health; Adoption of Federal Standards by Reference Occupational Safety and Health Division

#### Proposed Revisions to the Occupational Safety and Health Standards and Request for Comments

**NOTICE IS HEREBY GIVEN** that the Department of Labor and Industry, Occupational Safety and Health Division (Minnesota OSHA) proposes to adopt the following revisions to the Department of Labor and Industry, Occupational Safety and Health Rules, as authorized under *Minnesota Statutes* § 182.655 (2002). This notice proposes the adoption by reference of corrections and amendments to Occupational Safety and Health Standards that have already been proposed and adopted by the Federal Occupational Safety and Health Administration (Federal OSHA).

All interested or affected persons have 30 days from the date this notice is published in the *State Register* to submit, in writing, data and views on the proposed amendments to the rule. Comments in support of or in opposition to the proposed amendments are encouraged. Each comment should identify the portion of the proposed amendment addressed, the reason for the comment, and any proposed change.

Any person may file with the Commissioner written objections to the proposed amendments stating the grounds for those objections and may request a public hearing. A public hearing will be held if 25 or more persons submit written requests for a public hearing on the proposed amendments within the 30-day comment period. Requests for hearing must include the name and address of the person submitting the request, define the reasons for the request, and discuss any proposed changes. If a public hearing is required, the Department will proceed according to the provisions of *Minnesota Statutes* § 182.655 and *Minnesota Rules* 5210.0010 to 5210.0100.

#### SUMMARY OF CHANGES

#### (A) "Occupational Injury and Illness Recording and Reporting Requirements; Final Rule."

On December 17, 2002, federal OSHA published in the Federal Register a final rule which delayed the effective date of three pro-

visions of the Occupational Injury and Illness Recording and Reporting Requirements rules published January 19, 2001. The effective date of these provisions on ergonomics and recordkeeping forms was delayed from January 1, 2003 until January 1, 2004.

By this notice, Minnesota OSHA proposes to adopt the final rule as published in the *Federal Register* on December 17, 2002. See Item (B), below, for subsequent amendments to this rule.

#### (B) "Occupational Injury and Illness Recording and Reporting Requirements; Final Rule."

On June 30, 2003, federal OSHA published in the *Federal Register* a final rule amending their occupational safety and health recordkeeping requirements. The notice deletes two provisions of the rule published January 19, 2001. These provisions required 1) employers to check the MSD column on the OSHA 300 Log if an employee experienced a work-related musculoskele-tal disorder (MSD) [Part 1904.12]; and 2) stated that MSDs are not considered privacy concern cases [1904.29(b)(7)(vi), sentence 2]. The effective date of these provisions was delayed since publication of the Recordkeeping rule in January 2001; consequently, the requirements deleted by this final rule have never been in effect. The amendments in this rule will become effective on January 1, 2004.

By this notice, Minnesota OSHA proposes to adopt the final rule as published in the Federal Register on June 30, 2003.

NOTE: The delay of effective date for Part 1904(10)(b)(7), which requires employers to enter a check mark in the hearing loss column on the 300 Log for cases involving occupational hearing loss, still remains January 1, 2004, as stated in the December 17, 2002 and June 30, 2003 *Federal Register* notices published by Federal OSHA.

#### 5205.0010 ADOPTION OF FEDERAL OCCUPATIONAL SAFETY AND HEALTH STANDARDS BY REFERENCE.

Subp. 1a. **Part 1904.** Part 1904: Occupational Safety and Health Standards as published in Volume 66, No. 13 of the Federal Register on January 19, 2001, and amended in Volume 66, No. 128 on July 3, 2001, which incorporates changes, additions, deletions, and corrections made up to July 3, 2001, with the exception of part 1904.2. Parts 1904.10, with the exception of (b)(7), will become effective on January 1, 2003. Parts 1904.10(b)(7), 1904.12, and the second sentence of Part 1904.29(b)(7)(vi) will be adopted following a final decision by federal OSHA; the effective dates will be identical to those of federal OSHA.; and subsequent changes as follows:

(1) Federal Register, Volume 67, No. 126, pages 44037-44048, dated July 1, 2002:: "Occupational Injury and Illness Recording and Reporting Requirements; Final Rule."

Provisions exist for the Commissioners of some state agencies to adopt emergency expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Emergency expedited rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions. Emergency expedited rules are effective for the period stated or up to 18 months. Specific *Minnesota Statutes* citations accompanying these emergency expedited rules detail the agency's rulemaking authority.

# Adopted Expedited Emergency Game and Fish Rules; Youth Waterfowl Hunting Day; Early Goose Hunting; Migratory Waterfowl Feeding and Resting Areas

**NOTICE IS HEREBY GIVEN** that the above entitled rule has been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 97A.091; 97A.095, subdivision 2; 97B.731, subdivision 1; and 97B.803.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that duck and goose breeding population data are not available until June and federal frameworks for early season migratory birds are not finalized until July.

#### 6240.0610 YOUTH WATERFOWL HUNTING DAY.

<u>Subpart 1.</u> Dates, eligibility, and license requirements. <u>Ducks</u>, mergansers, coots, moorhens, and Canada geese may be taken statewide on September 20, 2003, by hunters 15 years of age or younger who are accompanied by an adult 18 years of age or older. The accompanying adult may not hunt. No hunting license or waterfowl stamps are required.

Subp. 2. Shooting hours. Shooting hours are one-half hour before sunrise to 4:00 p.m.

Subp. 3. Bag limits.

A. The daily bag limit for ducks is six and may not include more than four mallards, of which not more than two may be female mallards; three greater or lesser scaup combined; one pintail; two wood ducks; two redheads; and one black duck. The limit for canvasback is as allowed by federal rule.

B. The daily bag limit for mergansers is five, of which no more than one may be a hooded merganser.

C. The daily bag limit for coots and moorhens is 15 in combination.

D. The daily bag limit for geese is five Canada geese, except in those areas where taking Canada geese near water is restricted under part 6240.1200, subpart 1, item A, where the daily bag limit is one Canada goose.

#### 6240.1200 SPECIAL PROVISIONS ON TAKING GEESE DURING EARLY SEASONS.

Subpart 1. Taking near water.

<u>A.</u> Taking Canada geese during the early seasons is prohibited on or within 100 yards of all surface waters<del>, except on those described or shown on a map provided by the commissioner. in the following areas:</del>

(1) the Northwest, Southeast, and Twin Cities Metro Goose Zones;

(2) all of the Carlos Avery Wildlife Management Area, including that portion outside the Twin Cities Metro Goose Zone;

and

(3) the Swan Lake area in Nicollet County, within the boundary described as follows:

Beginning at the junction of State Trunk Highway (STH) 14 and County State-Aid Highway (CSAH) 12 north along CSAH

12 to CSAH 5; thence east along CSAH 5 to CSAH 13; thence south along CSAH 13 to STH 99; thence west along STH 99 to CSAH 17; thence south along CSAH 17 to STH 14; thence northwest and west along STH 14 to CSAH 12.

B. Taking Canada geese on or within 100 yards of surface waters during the early Canada goose seasons is allowed on specific bodies of water in closed zones as described or shown on maps provided by the commissioner and for youth hunters participating in the youth waterfowl hunting day.

6240.1850 GAME REFUGES OPEN TO THE TAKING OF GEESE.

The following refuges are open to the taking of geese, as specified:

A. Subpart 1. Goose refuges. Those portions of the Douglas County Goose Refuge in Douglas County, the Otter Tail County Goose Refuge in Otter Tail County, and the Sauk Rapids-Rice Goose Refuge in Benton County, in the respective zone or zones in which they are located, are open to goose hunting during the early, regular, and late goose seasons for those zones. All other goose hunting regulations apply in these refuges. Taking waterfowl from public roads and their rights-of-way is prohibited. The Ashby Goose Refuge in Grant County is open to Canada goose hunting during the early September goose season.

**B.** Subp. 2. Game refuges. The Fox Lake Game Refuge in Martin County and the Saint James Game Refuge in Watonwan County are open to goose hunting during the first three days of the regular goose season in the respective zones in which they are located. The Fox Lake Game Refuge is also open to goose hunting from the Saturday on or nearest November 20 26 to the end of the goose season in the zone in which it is located, except there is no goose hunting within 100 yards of Fox and Temperence Lakes.

C. Subp. 3. Waterfowl refuges. The Harstad Slough Waterfowl Refuge in Stevens County is open to Canada goose hunting during the early September goose season. The Mud-Bardwell Waterfowl Refuge in Martin County is open to Canada goose hunting from November 1 the Saturday on or nearest October 30 to the end of the regular goose season in the zone in which it is located, except there is no goose hunting within 100 yards of Mud and Bardwell Lakes. The Rickert Lake Waterfowl Refuge in Steele County is open to Canada goose hunting during the early September goose season. The waterfowl sanctuary within this refuge is closed to hunting and trespassing, as posted.

# Adopted Expedited Emergency Game and Fish Rules: Special Provisions for State Game Refuges; Deer Season; Furbearers

**NOTICE IS HEREBY GIVEN** that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rules is *Minnesota Statutes*, sections 97A.091, 97A.092, 97A.401, subd. 4, 97A.441, 97A.465, 97A.485, 97B.111, 97B.112, 97B.301, 97B.305, 97B.311, 97B.605, 97B.901, and 97B.926.

The emergency conditions that do not allow compliance with Minnesota Statutes, sections 97A.0451 to 97A.0459, are that:

- Refuges. Population data needed for opening or closing refuges to hunting are not available until June. Public input and coordination with local government on opening a portion of the Bemidji Game Refuge to firearms deer hunting was not completed until June.
- 2) Deer. Population data needed to establish quotas and classify permit areas are not available until June. Deer populations continued to increase in 2003, despite record antlerless permit quotas in 2002, prompting the need to redesign the deer permit areas system to facilitate higher harvest and to reduce unnecessary paperwork for hunters. Data needed to classify the permit areas by type were not available until deer population modeling was completed in June. Special hunt areas open or closed to hunting are not established until harvest and population data are evaluated in May and June. Changes in zone and registration block boundaries are to improve deer harvest and population management; many of them were in effect on a trial basis initially and the department wants to continue them, but the permanent rule to do so will not take effect before the deer season. Some other permit and zone boundary changes are new adjustments to facilitate harvest by land ownership and use, or are to accommodate changes in local road numbering systems.
- 3) Furbearers. Changes to furbearer tagging requirements are to continue the repeal of site-tagging of fisher, pine marten and otter that was done legislatively for 2001 and 2002, but that expired on March 1, 2003 (*Laws of Minnesota for 2001*, Chapter 206, Sec. 2 and 3). Following the sunset of this law, an evaluation of the effects of discontinuance of site-tagging revealed no biological need to continue site-tagging to regulate total harvests of these species. Annual bag limits are established based on population modeling completed in May of each year.

<u>Subp. 4a.</u> **Deer permit area.** <u>"Deer permit area" means an area of the state consisting of one or more deer registration blocks.</u> Deer permit areas open for taking legal bucks and antlerless deer during the regular firearms deer season are defined as follows:

A. "intensive deer permit area" means a deer permit area where taking deer of either sex is authorized by a regular firearms license and where intensive harvest permits are authorized;

B. "managed deer permit area" means a deer permit area where taking deer of either sex is authorized by a regular firearms license and where firearms management permits are authorized; and

<u>C.</u> "lottery deer permit area" means a deer permit area where taking legal bucks is authorized by a regular firearms license and taking antlerless deer is authorized by an either-sex permit.

Subp. 5. **Deer management permit.** "Deer management permit" means a <u>firearms</u> license to take and tag a second deer. It is available for one-half the cost of a regular resident or nonresident license, except that the license is free to qualifying owners and tenants of ten acres or more of agricultural land and is valid immediately upon issuance, as long as the purchaser has a valid regular license. Deer taken and tagged with a management permit must be antlerless unless otherwise prescribed by the commissioner.

Subp. 5a. **Intensive harvest permit.** "Intensive harvest permit" means a license to take and tag deer by archery or firearms, in addition to deer authorized to be taken under regular archery or firearms licenses and deer management permits. It is available for one-half the cost of a regular <u>resident or nonresident</u> license <u>and is valid immediately upon issuance</u>, as long as the purchaser has a valid regular license. Deer taken and tagged with an intensive harvest permit must be antlerless unless otherwise prescribed by the commissioner.

Subp. 3. **Party hunting.** A party is a group of two or more licensed deer hunters who are afield hunting together and are all using firearms or all using archery equipment. A member of a party may kill a deer for another member of the party who has an unused tag valid for that deer, except as provided by Minnesota Statutes, section 97B.301. A mixed-weapons group is considered two separate parties. Multizone buck licensees may party hunt with regular firearms licensees. Persons issued permits under Minnesota Statutes, section 97B.055, subdivision 3, who are hunting in a lottery deer permit area and do not have an antlerless either-sex permit may not tag antlerless deer for another member of the party.

Subp. 8. **Bag limit.** A person may not tag more than one deer during a license year by any method, except as authorized in items A to  $\underline{\mathbf{P}} \underline{\mathbf{E}}$ .

B. In Marshall, Kittson, Roseau, Lake of the Woods, and Pennington counties, a person may tag one deer with a regular archery license and another with a regular firearms license, including the muzzleloader option or multizone buck license. Both deer must be taken and registered in this five-county area.

C. A person may tag a third, fourth, or fifth second deer by archery or, firearms, or muzzleloader with an intensive harvest permit in specified areas as prescribed in this chapter.

D. <u>A person may tag a third, fourth, or fifth deer by archery, firearms, or muzzleloader with an intensive harvest permit in specified areas as prescribed in this chapter.</u>

<u>E.</u> In no case may a person tag more than five deer per year by firearms, archery, or both methods combined, except a sixth deer may be tagged if the person takes a deer with a free landowner permit.

A license is not valid in the special areas provided in this chapter. C. Cleary Lake regional park in Scott county is open November 14 to November 16 for taking antlerless deer and legal bucks. No more than 55 permits shall be issued. Up to four intensive harvest permits may be used by permittees to take deer. Applications must be sent to Three Rivers Parks Bow Hunt, 3800 County Road 24, Maple Plain, MN 55359;

D. portions of the city of Red Wing as shown on maps available from the city are open September 13 to December 31 for taking antlerless deer. A proficiency test is required and hunters must wear back tags during the hunt. A valid archery or all-season deer license must be purchased to qualify for the hunt. Up to four intensive harvest permits may be used by permittees to take deer. Applications must be submitted to City of Red Wing Deer Hunt, Red Wing Public Works, 229 Tyler Road S., Red Wing, MN 55066;

E. portions of the city of Sandstone are open September 13 to December 31 by special permit from the city. Hunters must have a valid archery or all-season deer license to participate. Hunting is allowed on private land within these areas with written landowner permission and on certain city-owned lands under special hunting rules. Intensive harvest permits are available and strongly encouraged for participants in the city hunt. <u>F.</u> portions of the city of New Ulm are open October 11 to December 31 for taking antlerless deer and legal bucks. No more than 50 permits shall be issued by the city of New Ulm. #### 6232.1250 TAKING DEER BY ARCHERY UNDER INTENSIVE HARVEST PERMITS.

In managed or intensive deer permit areas, antlerless deer may be taken only by permit throughout this season and only within the deer permit area specified on each hunter's permit license, except as specifically authorized by statute. In lottery deer permit areas and in special hunt areas, antlerless deer may be taken only by permit throughout this season and only within the deer permit areas and hunt area specified on each hunter's permit, except as specifically authorized by statute. A person who is authorized by statute to take a deer of either sex without an antlerless either-sex permit and who is licensed for Zone 2 may take an antlerless deer without a permit in any Zone 2 antlerless deer permit area, except in those lottery deer permit areas where no either-sex permits are offered.

Subp. 3. Zone 3. This subpart applies to season dates in Zone 3.

A. Legal bucks may be taken in the early Zone 3A season in Zone 3 for a nine day seven-day period beginning the Saturday nearest November 6. In managed or intensive deer permit areas, antlerless deer may be taken throughout this season only within the deer permit area specified on each hunter's license, except as specifically authorized by statute. In lottery deer permit areas and in special hunt areas, antlerless deer may be taken only by permit throughout this season and only within the deer permit or special hunt areas specified on each hunter's permit, except as specifically authorized by statute. A person who is authorized by statute to take a deer of either sex without an either-sex permit and who is licensed for Zone 3A may take an antlerless deer without a permit in any Zone 3A deer permit area, except in those lottery deer permit areas where no either-sex permits are offered.

B. Legal bucks and antlerless deer may be taken during the late <u>Zone 3B</u> season in <u>Zone 3</u> for a <u>seven-day nine-day</u> period beginning the Saturday nearest November 20. <u>In managed or intensive deer permit areas</u>, antlerless deer may be taken <u>throughout this season</u> only by permit and only within the <u>deer</u> permit area specified on each hunter's <u>permit license</u>, except as specifically authorized by statute. <u>In lottery deer permit or special hunt areas</u>, antlerless deer may be taken only by permit throughout this season and only within the deer permit or special hunt area specified on each hunter's permit, except as specifically authorized by statute. A person who is authorized by statute to take a deer of either sex without an <del>antlerless <u>either-sex</u></del> permit and who is licensed for Zone 3B may take an antlerless deer without a permit in any Zone 3B <del>antlerless</del> <u>deer</u> permit area <u>, except in those</u> lottery deer permit areas where <u>no either-sex</u> permits are offered.

Subp. 4. Zone 4. This subpart applies to season dates in Zone 4.

A. Legal bucks and antlerless deer may be taken in the early Zone 4A season in Zone 4 for a two-day period beginning the Saturday nearest November 6. In managed or intensive deer permit areas, antlerless deer may be taken throughout the season only by permit and only within the deer permit area specified on each hunter's permit license, except as specifically authorized by statute. In lottery deer permit areas and in special hunt areas, antlerless deer may be taken only by permit throughout this season and only within the deer permit or special hunt areas, antlerless deer may be taken only by permit throughout this season and only within the deer permit or special hunt area specified on each hunter's permit, except as specifically authorized by statute. A person who is authorized by statute to take a deer of either sex without an antlerless either-sex permit and who is licensed for Zone 4A may take an antlerless deer without a permit in any Zone 4A antlerless deer permit area, except in those lottery deer permit areas where no either-sex permits are offered.

B. Legal bucks and antherless deer may be taken in the late Zone 4B season in Zone 4 for a four-day period beginning the Saturday nearest November 13. In managed or intensive deer permit areas, antherless deer may be taken throughout the season only by permit and only within the deer permit area specified on each hunter's permit license, except as specifically authorized by statute. In lottery deer permit areas and in special hunt areas, antherless deer may be taken only by permit throughout this season and only within the deer permit or special hunt area specified on each hunter's permit, except as specifically authorized by statute. A person who is authorized by statute to take a deer of either sex without an antherless either-sex permit and who is licensed for Zone 4B may take an antherless deer without a permit in any Zone 4B antherless deer permit area, except in those lottery deer permit areas where no either-sex permits are offered.

#### 6232.1800 ANTLERLESS EITHER-SEX PERMITS AND PREFERENCE DRAWINGS.

Subpart 1. **Procedures for applying for an antlerless** <u>either-sex</u> **permit.** Residents and nonresidents are eligible for <del>antlerless</del> <u>either-sex</u> permits. A person may not apply for an <del>antlerless</del> <u>either-sex</u> deer permit without first purchasing a firearms <u>or all-sea</u>son deer license <del>and obtaining a permit application issued with the license</del>. The application may be made for only one of the <u>deer</u> permit areas described in this part, and must be for the zone and dates on the applicant's deer license. A person may not submit more than one application for an <del>antlerless</del> <u>either-sex</u> permit. A person may apply for an <del>antlerless</del> <u>either-sex</u> permit or a special <u>hunt</u> permit, but not both.

After the application has been completed, it must be either mailed or delivered to the license bureau. The application deadline is the first Thursday following Labor Day.

Subp. 2. **Preference drawings for antherless** <u>either-sex</u> <u>permits in lottery deer permit areas</u> and special <u>hunt</u> area permits. If the number of applications for <u>either-sex</u> permits in <u>an antherless permit a lottery deer permit area</u> or <u>for permits in a</u> special hunt area exceeds the quota set forth in the annual hunting regulations, a preference drawing will be used to select permit holders. Persons 12 years of age or older may enter the preference drawing by supplying their driver's license number, official state of Minnesota Identification Number, or 13-digit Firearms Safety Identification Number on the application, except that resident hunters under age 16 on the Saturday nearest November 6 may not apply for <del>antlerless</del> <u>either-sex</u> permits. All applicants who have reached their 18th birthday by the first Thursday following Labor Day must provide one of these three numbers to qualify. Applicants under 18 years of age who do not submit one of these numbers will be assigned a number and will be entered into the preference drawing. Applicants establish a preference rating based upon the number of times they have applied in previous years and have not obtained an <del>antlerless</del> <u>either-sex</u> or special <u>hunt</u> area permit. The preference rating will increase each year the applicant applies unsuccessfully for either an <del>antlerless</del> <u>either-sex</u> or special <u>hunt</u> area permit. Persons applying for the first time have no preference. Applicants receiving <del>either antlerless</del> <u>either-sex</u> or special <u>hunt</u> area permit. Persons applying for the first time have no preference.

#### 6232.1900 FIREARMS DEER MANAGEMENT PERMITS.

Subpart 1. Undersubseribed antlerless permit Managed deer permit areas. Firearms deer management permits are authorized in antlerless managed deer permit areas where the number of applications is less than the number of permits available. The number of deer management permits authorized is up to 1–1/2 times the difference between the number of available permits and the number of antlerless permits issued as prescribed in part 6232.1750, item B. A deer management permit for an undersubscribed antlerless permit area is valid only within the area designated on the management permit. A person with a regular firearms license validated for the appropriate zone and time option, except muzzleloader, or an all-season deer license valid for a managed deer permit area may purchase one deer management permit from an electronic license system agent or the Department of Natural Resources license center. Deer management permits may be purchased throughout the regular firearms season. The following proeedures are used to select antlerless permit applicants for management permits:

A. A landowner-tenant drawing will be held in those antlerless permit areas where firearms deer management permits are available subject to the following restrictions:

(1) Owners and tenants who live on at least ten acres of agricultural land will be given preference for firearms management permits in those antlerless permit areas where management permits are available.

(2) Agricultural land includes land that is plowed or tilled, that has standing crops or crop residues, that is within a maintained fence for enclosing domestic livestock, or that is enrolled in the federal Conservation Reserve Program (CRP) or the state RIM Reserve Program in the antlerless permit area or subpermit area applied for.

(3) An applicant must be a landowner or tenant living on the qualifying property or a family member of a qualifying landowner or tenant who lives on the qualifying property and is part of the farming operation.

(4) Eligible landowner tenants or qualifying family members must fill out an application available from county auditors, the license bureau, and other authorized agents and submit the application in an envelope with their antlerless permit application by the first Thursday following Labor Day.

(5) A random drawing will be held among eligible landowner tenant applications for available firearms deer management permits in each antlerless permit area.

(6) Landowner tenants selected in the preference drawing will receive certification on their antlerless permit authorizing acquisition of a management permit. They may obtain a firearms deer management permit at no cost by submitting the certificate to any county auditor's office or the license bureau before or during the regular firearms season. Eligible landowner tenants who apply for the orchard subpermit area may also obtain free management permits under this provision. Before receiving the management permit, the landowner tenant must verify that they still qualify as a landowner tenant for purposes of firearms deer management permits, and will allow public firearms deer hunting on their lands during the firearms deer season.

B. If there are firearms deer management permits available after the landowner-tenant drawing, hunters randomly drawn from permittees in each undersubscribed area who have checked the bonus option on their antlerless permit application will be authorized to purchase a management permit. A deer management permit may be purchased by submitting the certificate and fee to the license bureau, a Minnesota county auditors' office, or other authorized agents. Deer management permits may be purchased throughout the regular firearms season.

#### 6232.1950 TAKING DEER BY FIREARMS UNDER INTENSIVE HARVEST PERMITS.

Subpart 1. **Purchase.** The purchase of an intensive harvest permit is authorized for any person who has purchased and presents a regular firearms deer license, multizone buck license, <u>all-season deer license</u>, or muzzleloader license for the current year. Intensive harvest permits may be purchased for one-half the cost of a regular license from <del>license vendors in Anoka, Washington, Ramsey, Hennepin, Scott, Carver, and Dakota counties, county auditor offices</del> <u>electronic license system agents</u>, the Department of Natural Resources license <del>bureau</del> <u>center</u>, and other authorized agents.

Subp. 2. **Restrictions.** Intensive harvest permits may be used to take antlerless deer only in antlerless permit areas and special hunt areas prescribed by the commissioner. by firearms during the regular firearms and muzzleloader seasons as follows:

<u>A. for the regular firearms season, hunters must have a regular firearms license validated for the appropriate zone and time option, including except the muzzleloader option, or a multizone buck license, or an all-season deer license to take deer under an intensive harvest permit in that the respective zone and time period for which the license is valid. Intensive harvest permits may be used to take antlerless deer only in intensive deer permit areas as prescribed in part 6232.1750, item C, and in special hunt areas as prescribed in part 6232.1600, subpart 6, items B to N and P; and</u>

B. for the muzzleloader season, intensive harvest permits may be used to take antlerless deer in intensive deer permit areas open for either the early or the late firearms season, as prescribed in part 6232.1750, item C, and special hunt areas prescribed by the commissioner. Hunters licensed for the muzzleloader season may also use one intensive harvest permit to take an antlerless deer in managed deer permit areas open for either the early or the late firearms season, as prescribed in part 6232.1750, item B, except permit area 224.

#### 6232.2000 MULTIZONE BUCK LICENSE.

Multizone buck licensees may not take antlerless deer under Minnesota Statutes, section 97B.055, subdivision 3, or 97B.301, subdivision 6.

#### 6232.2050 ALL-SEASON DEER LICENSE.

#### Subpart 1. Season and open area.

<u>A.</u> An all-season deer license allows a hunter to take and tag one legal buck and one antlerless deer per year. All-season deer license holders may hunt deer in any of the following seasons, according to all rules and laws for methods of taking in each respective season and zone:

(1) the archery deer season;

(2) the muzzleloader deer season; and

(3) the regular firearms season during any open firearms zone and time period, except the Zone 3B season.

B. All-season deer license holders must declare the deer permit area they intend to hunt for antlerless deer during the regular firearms season at the time of license purchase.

C. In lottery deer permit areas, all-season deer hunters must apply for and receive authorization to take and tag an antlerless deer by firearms.

D. In managed or intensive deer permit areas, all-season deer hunters may take and tag an antlerless deer with the antlerless tag accompanying the license.

<u>E.</u> A person who is authorized by statute to take an antlerless deer without an either-sex permit and who purchases an all-season deer license may take antlerless deer during the firearms season as authorized in part 6232.1300.

<u>Subp. 2.</u> Management and intensive harvest permits. <u>All-season deer license holders may purchase one deer management per-</u> mit, if they select a managed deer permit area for the regular season at the time of license purchase, and may also purchase intensive harvest permits.

D. Lake Shetek state park in Murray county is open December 6 to December 9 for taking antlerless deer only. No more than 15 permits shall be issued to muzzleloader licensees only. This is special permit area 934;

E. Nerstrand Woods state park and adjacent Prairie Creek Woods scientific and natural area in Rice county are open November 29 to December 1 and December 5 to December 7 for taking antlerless deer and legal bucks. No more than 50 permits shall be issued to muzzleloader licensees only. One intensive harvest permit may be used to take a second deer. This is special permit area 935;

<u>F. Rice Lake state park in Dodge and Steele counties is open November 29 to December 1 and December 5 to December 7 for the taking of antlerless deer only. No more than 15 permits shall be issued to muzzleloader licensees only. One intensive harvest permit may be used to take a second deer. This is special permit area 936; and</u>

<u>G.</u> Myre-Big Island state park in Freeborn county is open November 29 to December 1, December 13, and December 14 for the taking of antlerless deer only. No more than 40 permits shall be issued to muzzleloader licensees only. This is special permit area 937.

Tags must be fastened to fisher pelts in the manner provided by part 6234.2600. Pelts and skinned carcasses of fisher and pine marten are subject to the provisions of part 6234.2600.

#### Services for Victims of Crime Notice of Opportunity to Participate in a Planning Process for Distribution of Grant Funds

The Minnesota Office of Justice Programs distributes funds for the provision of services to victims of crime. These funds include those the state receives through the U.S. Department of Justice from the Victims of Crime Act and the Violence Against Women Act, from the Minnesota Department of Health for sexual assault prevention, and funds appropriated by the Minnesota Legislature for grants to serve victims of crime. These funds are currently awarded to approximately 145 organizations in Minnesota that offer services to victims of child abuse, domestic violence, general crime and sexual assault.

Because of recent reductions in available funding, the Office of Justice Programs is utilizing a new planning process for distribution of grant funds. The amount of funds available for each judicial district is determined based on a formula that compares the district to the state as a whole in total population, total geographic area (density of population), the diversity of the population that resides within the district, and reported crime. The formula also takes into account the amount of grant and corporation funding that has historically been provided within regions of the state. Judicial district planning groups, with facilitation provided through the Office of Justice Programs will meet to plan for the distribution of funds within each district. The new funding distribution would begin in fiscal year 2005, (July 1, 2004).

This notice seeks interested volunteers who wish to serve on judicial district planning groups. Membership is open to individuals from agencies currently receiving grant funds to serve crime victims, those interested in but not currently receiving funding to serve crime victims, law enforcement representatives, judges, county and city attorneys, members of the medical profession and others with a stake in ensuring the availability of comprehensive services to victims of crime. The goal is to put together planning groups that represent as wide an array as possible of the individuals and institutions that provide services to crime victims. To ensure a fair process, membership will be limited to one person per agency. The state also retains the right to limit membership if the number of volunteers is too great to allow for a manageable planning process. Planning meetings will begin early October, 2003.

## Minnesota Pollution Control Agency

#### Applications Accepted for Nonpoint Source Water Pollution Project Grants and Loans Through the State Clean Water Partnership and the Federal Clean Water Act Section 319 Grant Programs

The Minnesota Pollution Control Agency (MPCA) hereby announces that it will accept applications for project implementation (phase II) grants and loans through the state Clean Water Act Section 319 Nonpoint Source grant program (Section 319 program). Typically, Clean Water Partnership (CWP) Program grant funds are available, however, this year they were used to fund continuation projects. CWP loan funds will be available this funding round.

In 1987, the Minnesota Legislature established the CWP Program (*Minnesota Statutes* §§ 103F.70 through 103F.761) to protect and improve surface and ground water in Minnesota through financial and technical assistance to local units of government. Section 319 provides federal grant money for nonpoint pollution abatement and water resource restoration.

#### **Changes to Application Process:**

There are several significant changes to the application process this round that should be noted:

- This funding round will have no CWP grant funding available for this competitive process;
- There will be no funds offered for CWP resource investigation (phase I) diagnostic study projects this year;
- A portion of Section 319 funds available in this funding round will be dedicated to projects implementing Total Maximum Daily Load (TMDLs) that have been approved by the U.S. Environmental Protection Agency;
- First priority will go to demonstration projects located in watersheds with impairments listed on the 2002 list for the pollutants of concern, even if the study has not been completed. This list can be found at *http://www.pca.state.mn.us/water/tmdl.htm/*.
- The cap on loan requests in place for the last two rounds has been lifted, and the cap on grant funds requested is now \$300,000 per project; and
- Applications must be sent in electronic and paper form.

#### **Eligible Applicants**

Applications will be accepted from local units of government interested in leading a nonpoint source water pollution control project. Applications will also be accepted from other entities besides local units of government, but such applications would only be eligible for Section 319 program funding.

Ineligible Section 319 costs include activities addressing National Pollutant Discharge Elimination System permit requirements such as feedlot of storm water permits, any type of point source-related activities, and activities addressing enforcement actions. Any non-permitted feedlots addressed with Section 319 money must have a Comprehensive Nutrient Management Plan.

#### **Types of Projects**

Project funding will be awarded for two types of projects this round:

1) Education projects with statewide or regional applicability demonstrating new or innovative technology or best management practices or for developing educational programs related to nonpoint source pollution.

## 2) Projects implementing the activities identified during a CWP phase I investigation, projects in a watershed with impairments listed on the 2002 list for the pollutants of concern, and projects implementing approved TMDLs.

Note that applications for CWP diagnostic studies are not being accepted this funding round.

#### **Request Limits**

This year there will be a per-project grant cap of \$300,000 (total project grant request regardless of duration, not per year). There will be no cap on loan request this year for qualifying projects.

#### **Criteria for Project Selection**

*Minnesota Rules* 7076.0100 through 7076.0290 and U.S. EPA Section 319 program guidance provide the criteria and procedural condition under which the MPCA may award assistance. In addition, there will be three criteria that will be emphasized to evaluate projects. The first criterion is whether a watershed partnership sponsoring a project is self-sustaining or has plans in place to become self-sustaining within three years of time. The MPCA is attempting to encourage watershed districts or organization, conservation districts, or other entities to become prepared to carry on the necessary work beyond the life of the financial assistance award. This criterion is not applicable to short-term projects with a stated end date. The second criterion the evaluation teams will be using is whether the projects applying for implementation money have done a comprehensive assessment and planning process in the watershed or around the water body of concern. Such assessments might consist of a CWP phase I or equivalent, a TMDL, completed basin or watershed plan specific to the project, wellhead protection plan, or other recent comprehensive studies specific to the project. The third criterion is whether the watershed project has impairments that are listed on the 2002 list for the pollutants of concern.

#### Submission Deadline and Requirements:

All completed applications must be received both electronically and in hard copy by **4:30 p.m. on Monday, October 20, 2003,** in order to be eligible. All applications must be submitted in electronic form (preferred computer file format is Microsoft Word) to the MPCA by **email:** *CWP-319.grant.program@pca.state.mn.us* 

Applicants must also send two hard copies of their application, including the portions of the application that do not transfer readily electronically (signatures, maps, other attachments, etc.), to Markell Lanpher at the address listed below.

Incomplete applications will not be considered for funding. Faxed copies will not be accepted. Any project that is implementing a TMDL should include "TMDL" in the project title to help ensure the project is considered for funding with TMDL dedicated funds.
