## Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ## **Minnesota Environmental Quality Board**

## REQUEST FOR COMMENTS on Possible Amendments to Rules Governing Routing of Proposed Intrastate Pipelines, *Minnesota Rules*, Chapter 4415

**Subject of Rules.** The Minnesota Environmental Quality Board requests comments on possible amendments to the rules in chapter 4415 governing the routing of pipelines in the state of Minnesota. A pipeline routing permit is required from the Minnesota Environmental Quality Board before certain size and type intrastate pipelines can be constructed in this state, including natural gas and petroleum pipelines. The present rules have not been amended since they were first adopted in 1989. The EQB is considering amending the rules to establish new procedures for review of permit applications for new pipelines. In addition, the EQB is considering the adoption of additional rules addressing permit conditions and permit enforcement.

**Persons Affected.** The amendments to the rules would likely affect persons who construct and own intrastate pipelines, local units of government, and landowners.

**Statutory Authority.** *Minnesota Statutes*, section 116I.015, subd. 3 authorizes and directs the Board to adopt rules governing the routing of pipelines.

**Public Comment.** Interested persons or groups may submit comments or information on these possible rules in writing until 4:30 p.m. on March 7, 2005. The Board does not contemplate appointing an advisory committee to comment on the possible rules.

**Rules Drafts.** The Board has prepared a draft of the possible rules amendments to *Minnesota Rules*, Chapter 4415. A public review draft of proposed amendments to the Chapter 4415 rules is available on the Minnesota Environmental Quality Board's **website**:

## Public Notice Regarding Proposed Changes to Payment Rates Related to Nursing Facilities Participating in the Medical Assistance Program

**NOTICE IS HEREBY GIVEN** to recipients, providers of services under the Medical Assistance Program, and the public, of proposed payment rate changes for nursing facilities participating in the Medical Assistance Program.

This notice is published pursuant to 42 *United State Code* §1396(a)(13)(A) (§1902(a)(13)(A) of the Social Security Act), which requires the Department to publish proposed facility payment rates, the methodologies underlying the establishment of such rates, and the justification for such rates. This notice is also published pursuant to title 42, part 447, section 205 (42 CFR §447.205), which requires publication of a notice when there is a proposed change in the methods and standards for setting payment rates for Medical Assistance services.

The Department is notifying interested parties that the Governor's budget for State Fiscal Years 2006 and 2007 contains the following proposed changes to nursing facility payment rates or to rate methodology:

- The budget proposes implementation of a new nursing facility reimbursement system. Effective October 1, 2006, a new system would be implemented for determining nursing facility rates that will pay for services based on price, quality, and a facility's specific costs. The new system will be phased in over four years. Proposed new coding at *Minnesota Statutes* §256B.440.
- The budget proposes to suspend and redirect the automatic Medical Assistance inflation adjustments for operating costs for nursing facilities under contract through the Alternative Payment System (APS) for State Fiscal Years 2006-2009. The inflation adjustments will be redirected to help nursing facilities transition to the new reimbursement system. The money will be used for a 2% flexible funding increase effective October 1, 2005, for partial hold-harmless rate adjustments, for a faster phase-in for high quality nursing facilities and, effective July 1, 2007, for increases in direct care staffing levels. *Minnesota Statues*, §256B.434, subdivision 4.

The net effect of the proposed nursing facility rate changes would be approximately budget neutral to state Medical Assistance expenditures for nursing facility services over a four-year period. The projected impact to the state general fund will be savings of \$236,000 in State Fiscal Year 2006, savings of \$1,360,000 in State Fiscal Year 2007, expenditures of \$1,714,000 in State Fiscal Year 2008, and savings of \$110,000 in State Fiscal Year 2009.

**NOTICE IS HEREBY GIVEN** to recipients, providers of services under the Medical Assistance Program, and to the public, of proposed payment rate changes for hospitals participating in the Medical Assistance Program.

This notice is published pursuant to 42 *United States Code* §1396a(a)(13)(A) (§1902(a)(13)(A) of the Social Security Act), which requires the Department to publish proposed facility payment rates, the methodologies underlying the establishment of such rates, and the justification for such rates. It is also published pursuant to title 42, part 447, section 205 (42 CFR §447.205), which requires publication of a notice when there is a proposed rate change in the methods and standards for setting payment rates for Medical Assistance services.

The Department is notifying interested parties that the Governor's biennial budget for State Fiscal Years 2006-2007 contains the following proposed changes to hospital payment rates.

#### **Official Notices**

• Effective for services provided on or after July 1, 2005, the budget proposes to decrease payments to hospitals by 5% for inpatient hospital services, excluding: 1) inpatient mental health; and 2) inpatient hospital services provided by facilities of the Indian Health Service or facilities operated by a tribe or tribal organization under funding authorized by Title I of the Indian Self-Determination and Education Assistance Act (Public Law 93-638), as amended, or Title V of the Indian Self-Determination and Education Assistance Act (Public Law 106-260), operating as 638 facilities.

The net effect of this proposed change would be a decrease in Medical Assistance inpatient expenditures of \$11,569,000 for State Fiscal Year 2006 and \$16,785,000 for State Fiscal Year 2007.

## Public Notice of Maximum Allowable Costs of Medical Assistance Outpatient Prescribed Drugs

**NOTICE IS HEREBY GIVEN** to recipients, providers of services, and to the public of additions to the state Medical Assistance maximum allowable cost (state MAC) list for certain outpatient prescribed drugs.

At least once each calendar year, the United States Department of Health and Human Services, Centers for Medicare & Medicaid Services, publishes a federal upper limit (FUL) payment schedule for many commonly prescribed multiple-source drugs. The federal upper limit is set at a rate equal to 150 percent of the published price for the least costly therapeutic equivalent that can be purchased by pharmacists. This FUL payment schedule constitutes the federal MAC list. For many multiple-source drugs that are not on the federal MAC list, the Department establishes a state MAC list. Additionally, the Department imposes a state MAC for many multiple-source drugs that are on the federal MAC list, as long as the savings are at least as much as the savings would be using the federal MAC list.

The Department requires Medical Assistance pharmacy providers to submit their usual and customary costs.
