Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. At its regular meeting on February 17, 2005, the Minnesota Environmental Quality Board determined that the Environmental Assessment and the record created at the public hearing had adequately addressed the issues identified in the Scoping Decision. The Board also designated a site and issued a Site Permit for the proposed 357-megawatt, simple cycle, natural gas fuel-fired power plant. The site approved by the EQB in this Permit is a 55 acre site in the northwest quarter of the northeast quarter of Section 6, Township 112 north, Range 17 west, in the Cannon Falls Business Park North.

Minnesota Environmental Quality Board Notice of Route Permit for Air Lake-Empire 115 kV HVTL

RE: EQB grants a Route Permit to Xcel Energy and Great River Energy for a 115 kilovolt High Voltage Transmission Line between the Air Lake Substation in Lakeville and the Empire Substation in Empire Township, and a new Vermillion River Substation in Farmington, all in Dakota County.

The Environmental Quality Board voted 10-3, on February 17, 2005, to designate a route and issue a route permit for the proposed 115 kV high voltage transmission line and associated facilities extending from the Air Lake Substation in Lakeville on the west to the Empire Substation in Empire Township on the east for a distance of approximately nine miles.

Xcel Energy and Great River Energy were granted a route permit that specifies a new 115 kilovolt line along CR 50, along the abandoned railway corridor in Farmington, and along 210th Street in Empire Township. The new Vermillion River Substation will be constructed by Xcel Energy in the city of Farmington, adjacent to Eaton Road. The Air Lake and Empire Substations will require only minor modifications to accommodate the new line.

Structures will be single shaft steel poles for the Xcel Energy portion and single shaft wooden poles for the GRE portion, except GRE will use single shaft steel poles where longer spans are necessary. The proposed transmission line is expected to be in service by the summer of 2006.

The Route Permit for the project contains conditions for site preparation, construction, cleanup, restoration, electrical performance standards, and other restrictions. The Permit and other information about this project may be reviewed on the EQB Web Site:

Description and Statutory Reference: *Minnesota Statutes*, section 62J.581, outlines the standards for the Minnesota uniform health care reimbursement documents. The statute requires all group purchasers, as defined in *Minnesota Statutes*, section 62J.51, to provide a uniform remittance advice report to providers when a claim is adjudicated. The statute also requires group purchasers to provide a uniform explanation of benefits document to patients when the document is provided. Under *Minnesota Statutes*, section 62J.61, the Commissioner of Health is exempt from chapter 14, including section 14.386, in implementing sections 62J.50 to 62J.54, subdivision 3, and 62J.56 to 62J.59. Because the Commissioner of Health has determined that it is unduly cumbersome to publish the entire text of the proposed rules, the Commissioner of Health is publishing this notice of the adopted rule with the modifications to the proposed rule.

Development: The Administrative Uniformity Committee (AUC) and its subcommittee on Explanation of Benefits and Remittance Advice Notice developed this rule. This rule was submitted for public comment in the *State Register*, Volume 29, Number 8, page 217, August 23, 2004. The comment period was from August 23, 2004, until September 22, 2004. The Minnesota Department of Health collected the public comments. Five comments were received. The AUC subcommittee on Explanation of Benefits and Remittance Advice Notice reviewed the comments and made modifications to the rule as listed following this notice.

Required Date of Compliance: The required date of compliance is June 30, 2007.

At least once each calendar year, the United States Department of Health and Human Services, Centers for Medicare & Medicaid Services, publishes a federal upper limit (FUL) payment schedule for many commonly prescribed multiple-source drugs. The federal upper limit is set at a rate equal to 150 percent of the published price for the least costly therapeutic equivalent that can be purchased by pharmacists. This FUL payment schedule constitutes the federal MAC list. For many multiple-source drugs that are not on the federal MAC list, the Department establishes a state MAC list. Additionally, the Department imposes a state MAC for many multiple-source drugs that are on the federal MAC list, as long as the savings are at least as much as the savings would be using the federal MAC list.

The Department requires Medical Assistance pharmacy providers to submit their usual and customary costs. Pharmacy providers are reimbursed at the lower of: 1) the federal or state MAC, plus a dispensing fee; 2) the submitted usual and customary charge to the general public; or 3) a discount off of average wholesale price, plus a dispensing fee.

On January 13, 2003 at 27 SR 1117-1130, the Department published the MAC list, listing the federal and state MACs. Additional changes to the state MAC list were published on February 18, 2003 (27 SR 1331-1334), March 3, 2003 (27 SR 1386-1393), April 21, 2003 (27 SR 1583-1584), August 4, 2003 (28 SR 102-103), October 13, 2003 (28 SR 505-506), October 20, 2003 (28 SR 528-529), December 15, 2003 (28 SR 784-785), January 26, 2004 (28 SR 934-935), March 8, 2004 (28 SR 1089-1090), April 5, 2004 (28 SR 1232), April 19, 2004 (28 SR 1313-1314), May 3, 2004 (28 SR 1367-1368), August 9, 2004 (29 SR 173), August 23, 2004 (29 SR 224-225), November 8, 2004 (29 SR 510), November 15, 2004 (29 SR 534-535), February 7, 2005 (29 SR 923-924), and February 14, 2005 (29 SR 951-952).
