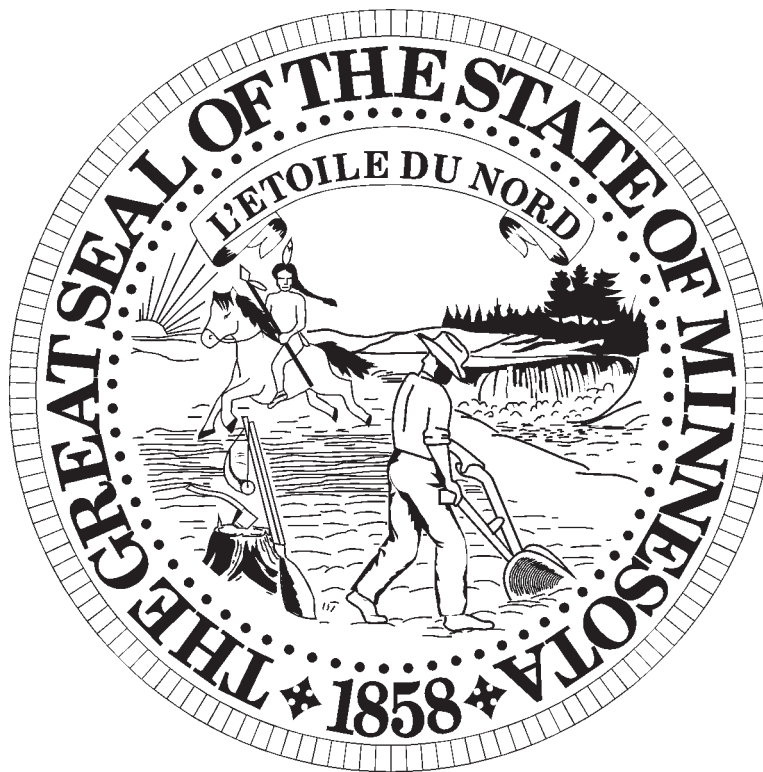

# Minnesota Rules: Amendments and Additions

## NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ## Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

**KEY: Proposed Rules** - Underlining indicates additions to existing rule language. ~~Strikeouts~~ indicate deletions from existing rule language. If a proposed rule is totally new, it is designated "all new material." **Adopted Rules** - Underlining indicates additions to proposed rule language. ~~Strikeout~~ indicates deletions from proposed rule language.

## Department of Health

### Adopted Permanent Rules Relating to Communicable Disease Reporting

The rules proposed and published at *State Register*, Volume 29, Number 26, pages 746-754, December 27, 2004 (29 SR 746), are adopted with the following modifications:

#### 4605.7500 DISEASE INVESTIGATIONS.

The commissioner shall investigate the occurrence of cases, suspected cases, or carriers of reportable diseases or unusual disease occurrences in a public or private place for the purpose of verification of the existence of disease, ascertaining the source of the disease causing agent, identifying unreported cases, locating and evaluating contacts of cases and suspected cases by assessing relevant risk factors and testing and treatment history, identifying those at risk of disease, determining necessary control measures, and informing the public if necessary.

## Revenue Notices

The Department of Revenue began issuing Revenue Notices in July of 1991. Revenue Notices are statements of policy made by the department that provide interpretation, detail, or supplementary information concerning a particular statute, rule, or departmental practice. The authority to issue Revenue Notices is found in *Minnesota Statutes*, Section 270.0604.

## Department of Revenue

### Correction to Modification of Revenue Notice #97-01: Penalties - Abatements - General Policy Policies and Procedures

The notice appearing at *State Register* 30 SR 181 (Monday 22 August 2005) should contain the following correction. On page 182 the sentence about middle of the page should contain strikeouts in its entirety: ~~The taxpayer can be required to pay the tax and interest on the tax before a penalty abatement determination is made by the Department of Revenue.~~

The TIP is prepared jointly by the Metropolitan Council and the Minnesota Department of Transportation. Projects contained in the TIP reflect the region's priorities and help implement the region's transportation plan. Progress made on implementing the region's transportation plan is reported in the TIP. Projects have been analyzed to determine impact on regional air quality.

The Council's Transportation Advisory Board (TAB) initiated the public input process on May 18, 2005, when it adopted the draft 2006-2008 TIP for purposes of a public hearing. The public hearing was held on June 15, 2005. The public comment period closed on July 5, 2005. Copies of all comments received were sent to TAB Members for their consideration. Staff response and recommendations were included in the public hearing report that will also be considered by the Council on September 14, 2005.

**Minnesota Pollution Control Agency****Municipal Division****Municipal Wastewater Section****Notice of Intent to Reissue an Areawide State Disposal System Permit for the  
Rainy River Basin**

This draft permit authorizes the Rainy River Rural Utility Association, Inc. and the Minnesota Rural Utility Services Foundation to plan and design alternative discharging sewage systems (ADSS) within the Rainy River Basin (hydrologic unit code 0903) for individual homeowners, businesses, and local units of government that have entered into a service agreement under *Minnesota Statutes* 471A.03. ADSS are defined by *Minnesota Statutes* 115.58 subd. (1)(b) as a sewage treatment system serving one or more dwellings and other establishments that discharges less than 10,000 gallons of water per day and uses any treatment and disposal methods other than subsurface soil treatment and disposal.

This draft permit does not authorize construction, installation, maintenance, or operation of any wastewater treatment systems that discharge to surface waters, the ground surface, or the subsurface. This permit does not authorize discharge to surface waters, the ground surface, or subsurface discharge of wastewater from ADSS.

The Permittee is authorized to plan and design ADSS for its cooperative members. Work on Individual Sewage Treatment Systems (ISTS) will no longer be a part of this permit. Construction, installation, repair, modification, and discharge of ADSS are not a part of this permit and may be covered in subsequent permits (Tier II Permit).

This permit does not give exclusive planning and design rights to the Permittee for any system but those owned and operated by the Permittee. The Permittee is required to comply with all local ordinances and requirements. Failure to do so will be considered in non-compliance with this permit.

The MPCA Commissioner's determination that the Areawide permit should be issued is tentative. Interested persons are invited to submit written comments upon the proposed permit action. The public comment period begins September 6, 2005, and terminates at 4:30 p.m., on October 5, 2005. Comments should be submitted in writing to:

(1)(b) as a sewage treatment system serving one or more dwellings and other establishments that discharges less than 10,000 gallons of water per day and uses any treatment and disposal methods other than subsurface soil treatment and disposal.

This draft permit does not authorize construction, installation, maintenance, or operation of any wastewater treatment systems that discharge to surface waters, the ground surface, or the subsurface. This permit does not authorize discharge to surface waters, the ground surface, or subsurface discharge of wastewater from ADSS.

The Permittee is authorized to plan and design ADSS for its cooperative members. Work on Individual Sewage Treatment Systems

(ISTS) will no longer be a part of this permit. Construction, installation, repair, modification, and discharge of ADSS are not a part of this permit and may be covered in subsequent permits (Tier II Permit).

This permit does not give exclusive planning and design rights to the Permittee for any system but those owned and operated by the Permittee. The Permittee is required to comply with all local ordinances and requirements. Failure to do so will be considered in non-compliance with this permit.

## Minnesota Pollution Control Agency Public Notice on Proposed Best Available Retrofit Technology Strategy for Minnesota to Address Regional Haze

**NOTICE IS HEREBY GIVEN** that the Commissioner of the Minnesota Pollution Control Agency (MPCA) requests comments on a proposed strategy outlining the MPCA's intent to implement U.S. Environmental Protection Agency's (U.S. EPA) Guidelines for Best Available Retrofit Technology (BART) for qualifying sources in Minnesota. U.S. EPA's BART Guidelines provide each state with discretion in the application of BART. The proposed "BART Strategy for Minnesota" outlines the MPCA's intent in each area of the Guidelines where a state is offered options. This Notice asks for comment on the BART Strategy. BART implementation is a required element of the Regional Haze state implementation plan due to U.S. EPA by December 2007.

### Background

To meet the Clean Air Act's requirements, the U.S. EPA published regulations to address visibility impairment in our nation's largest national parks and wilderness ("Class I") areas in July 1999. This rule is commonly known as the "Regional Haze Rule" [64 Fed. Reg. 35714 (July, 1999)] and is found in 40 CFR part 51, in sections 51.300 through 51.309. Under U.S. EPA's 1999 Regional Haze Rule, certain emission sources "that may reasonably be anticipated to cause or contribute" to visibility impairment in downwind Class I areas, are required to install BART. On July 6, 2005, U.S. EPA published a revised final rule, including Appendix Y to 40 CFR part 51 "Guidelines for BART Determinations Under the Regional Haze Rule". For an emissions source to be considered eligible for BART, it must fall into one of 26 specified categories, must have the potential to emit at least 250 tons per year of certain haze-forming pollutants, and must have been in existence on August 7, 1977, but not in operation before August 7, 1962.

Within its boundary, Minnesota has two Class I areas, the Boundary Water Canoe Area Wilderness and Voyageurs National Park. Minnesota must develop an implementation plan that contains enforceable measures and strategies for reducing visibility-impairing pollution in its two Class I areas, including the BART determinations and the resulting emissions limitations. In order to make reasonable progress towards its 2018 visibility goal, Minnesota may need to implement additional control measures besides BART, as BART applies to a relatively small subset of sources.

The MPCA asks for comment on the following elements contained in the proposed BART Strategy:

- Alternatives to BART
- BART Implementation Strategy Steps
  1. Identify BART-eligible Sources
  2. Identify Sources "Subject to BART"
  3. Perform a BART Determination
- Substituting the Clean Air Interstate Rule (CAIR) for BART

This notice is issued under authority provided in *Minnesota Rules* Parts 9210.0100 to 9210.0180. The purposes of this notice are to solicit applications for projects that meet the CAP Program objectives and to outline the application process.

Eligible applicants are Minnesota cities, counties, solid waste management districts, and sanitary districts. The applicant, or its county, must have an approved County Solid Waste Management Plan.

Eligible projects are facilities that include resource recovery. The project, inclusive of land, building, and equipment, must be owned by the Applicant. Examples of eligible facilities are waste-to-energy facilities, municipal solid waste composting facilities, organics composting facilities, recycling facilities, and transfer stations that will serve waste processing facilities.

The amount of funding available is subject to bonding during the year 2006 Legislative Session. The deadline for preliminary application submittals is November 7, 2005.

Depending on the project type, a project may receive funding of 25 to 50% of the eligible capital cost, up to a maximum of \$2 million. Multi-county projects with an intercounty cooperative agreement may receive 25 to 50% of the eligible capital costs, or up to \$2 million times the number of participating counties, whichever is less. A project to construct a new mixed municipal solid waste transfer station to serve an existing resource recovery facility that also has an enforceable commitment of at least 10 years, or of sufficient length to retire bonds sold for the facility, may receive grant assistance up to 75% of the capital costs of the project. Transfer stations receiving 75% grant assistance must substantially increase the geographical area served by the resource recovery facility.
