Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

KEY: Proposed Rules - <u>Underlining</u> indicates additions to existing rule language. <u>Strikeouts</u> indicate deletions from existing rule language. If a proposed rule is totally new, it is designated "all new material." **Adopted Rules** - <u>Underlining</u> indicates additions to proposed rule language. <u>Strikeout</u> indicates deletions from proposed rule language.

Crime Victims Reparations Board Adopted Permanent Rules Relating to Claims

The rules proposed and published at *State Register*, Volume 31, Number 5, pages 129-133, July 31, 2006 (31 SR 129), are adopted with the following modifications:

3050.3100 LOSS OF SUPPORT.

Subp. 4. Three-year maximum Loss of support benefits. Loss of support benefits shall be paid for a maximum time period of three years or until the child reaches 18 years of age, whichever is shorter. If after three years the child is still younger than 18 years of age, the claim may be resubmitted to the board and the board staff shall reevaluate the claim giving consideration to the child's or spouse's financial need and availability of funds to the board. After benefits are discontinued, they cannot be resumed at a later time.

Request for Comments for Possible Amendment to Rules Governing Credit Life, Accident and Health Insurance, *Minnesota Rules* 2760

Subject of Rules. The Minnesota Department of Commerce requests comments on its possible amendment to rules governing Credit Life, Accident and Health Insurance. The Department is considering rule amendments that will update *Minnesota Rules* chapter 2760 and establish a simpler and more efficient system for determining premium rates for life and disability credit insurance products. The Department intends to propose rules that will streamline the rate approval process, establish new lower prima facie premium rates, improve policy benefits for consumers and ensure a fair and stable market place for credit insurance products.

Persons Affected. The amendment to the rules would likely affect insurance companies that sell life and credit disability insurance in Minnesota; lender and creditor producers of such insurance including banks, finance companies, credit unions, automobile dealers, and retailers and consumers/borrowers.

Statutory Authority. *Minnesota Statutes* §62B.12 authorizes the Department to adopt rules for the supervision of *Minnesota Statutes* §62B.01 and 62B.14 regarding the sale of credit insurance in Minnesota. *Minnesota Statutes* §45.023 also authorizes the Department to promulgate rules whenever necessary or proper in discharging the commissioner's official responsibilities.

Public Comment. Interested persons or groups may submit comments or information on these possible rules in writing until 4:30 p.m. on February 26, 2007. The Department does not contemplate appointing an advisory committee to comment on the possible rules. **Rules Drafts.** The Department has not yet prepared a draft of the possible rules amendments.
