Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

KEY: Proposed Rules - <u>Underlining</u> indicates additions to existing rule language. Strikeouts indicate deletions from existing rule language. If a proposed rule is totally new, it is designated "all new material." **Adopted Rules** - <u>Underlining</u> indicates additions to proposed rule language. Public Notice of Intent for the Reissuance of the National Pollution Discharge Elimination System (NPDES) and State Disposal System (SDS) General Permit Authorizing Discharges of Chemically-Treated, Once-through Non-contact Cooling Waters (NCCW) into Waters of the State

NOTICE IS HEREBY GIVEN of the Commissioner of the Minnesota Pollution Control Agency's (MPCA) preliminary determination to reissue an existing NPDES/SDS General Permit authorizing covered facilities to discharge once-through, non-contact cooling water to in the state of Minnesota, including ground water, but excluding dischargers into waters located on Tribal lands, due to expire at midnight on December 31, 2007. The draft general permit is similar in intent to the existing general permit. The proposed draft general permit will provide for the timely discharge authorization without the delay of drafting and public noticing site-specific individual NPDES/SDS permits. The reissued general permit may potentially cover more than one hundred dischargers, including those currently covered by the existing general permit.

The proposed draft reissued general permit allows for the use of water treatment additives consistent with those used for public water supplies when used for scale and corrosion control, pH adjustment and/or control of microbiological activities. The proposed reissued general permit requires that toxic components such as chlorine bleach or bromine be neutralized prior to discharge to surface waters which need to be protected for the propagation of a balanced population of fish and shellfish and thus the proposed general permit also allows the use of oxygen scavengers as needed for dechlorination.

General permit coverage will only be authorized to those dischargers who meet the following eligibility criteria:

- a) The discharge consists solely of once-through, noncontact cooling water free from cooling tower or boiler blowdown, reverse osmosis reject waters, water softener backflush, contact cooling, industrial process, and other wastewater dischargers. On a case-by-case basis, multiple passes may be authorized.
- b) The cooling water source is a municipal water supply, uncontaminated ground water, or a surface water source to which the wastewater is returned.
- c) Water treatment is limited to those commonly used to treat public water supplies, with an exception for oxygen scavengers when used for dechlorination purposes.
- d) When required, the discharger holds a valid water appropriation permit issued by the Department of Natural Resources authorizing the water's use for once-through cooling purposes.
- e) The activity, the discharge and the pollutant levels in the discharge shall be in accordance with the terms and conditions of the proposed general permit.
- f) Pollutant levels in the discharge shall not cause or contribute to the violation of a water quality standard.
- g) The applicant agrees to furnish to the MPCA such information as the MPCA may request to determine eligibility for coverage, including material safety date sheets, product labels, a listing of product components including the percentage of each component, dosage amount(s) and frequency of use.
- h) The discharge is not to waters located on Tribal lands.
- i) The discharge is not a new point source discharge to waters designated as outstanding resource value waters-prohibited or waters designated as tout waters as defined in *Minnesota Rules* 7050.
- j) The waste stream is not subject to federally promulgated effluent limitation guidelines.
- k) The applicant agrees to furnish to the MPCA any information which the MPCA may request to determine compliance with this general permit, or to determine if the discharge would be more appropriately covered by an alternate general or individual permit.

The proposed draft reissued general permit contains standard and special conditions to ensure the protection of the receiving waters for their designated beneficial uses. The proposed draft reissued general permit establishes monitoring and reporting requirements, as well as numeric and/or narrative effluent limitations for temperature, pH, total phosphorus, total residual chlorine, and total residual oxidant as chlorine. Numeric effluent limitations were based on the more restrictive of technology-based removal of pollutants or protecting receiving water quality for its designated beneficial use(s). The existing general permit contains a 1.0 mg/L effluent limitation for total phosphorus for facilities utilizing a polyphosphonate-based scale and corrosion inhibitor which in accordance with federal anti-backsliding regulations will be carried into the proposed final issued general permit.

A copy of the public notice, fact sheet and draft general permit are available for review at the MPCA office in St. Paul, all MPCA regional offices and on-line at *http://www.pca.state.mn.us/news/data/index.cfm?PN=1*. A copy of the draft general permit, public notice and/or fact sheet will be mailed to you if the MPCA receives your written or oral request at any of these offices. Questions concerning this draft general permit or the Commissioner's preliminary determination to reissue the general permit should be directed to Deborah Schumann at (651) 297-5791.

The Commissioner's determination that the general permit should be reissued is preliminary. Interested persons are invited to submit written comments upon the proposed permit action. The public comment period commences October 29, 2007 and terminates at 4:30 p.m. on December 3, 2007. Comments should be submitted to writing to Deborah Schumann, Staff Permit Writer, Minnesota Pollution Control Agency, Industrial Division, 520 Lafayette Road North, St. Paul, Minnesota 55155-4194. Any comments received in writing no later than 4:30 p.m. on the last day of the public comment period will be considered in the formulation of the final determination.

- e) The activity, the discharge and the pollutant levels in the discharge shall be in accordance with the terms and conditions of the proposed general permit.
- f) Pollutant levels in the discharge shall not cause or contribute to the violation of a water quality standard.
- g) The discharge is not to waters located on Tribal lands.
- h) The discharge is not a new point source discharge to waters designated as outstanding resource value waters-prohibited or waters designated as tout waters as defined in *Minnesota Rules* 7050.
- i) The waste stream is not subject to federally promulgated effluent limitation guidelines.
- j) The applicant agrees to furnish to the MPCA any information which the MPCA may request to determine compliance with this general permit, or to determine if the discharge would be more appropriately covered by an alternate general or individual permit.

The proposed draft reissued general permit contains standard and special conditions to ensure the protection of the receiving waters for their designated beneficial uses. The proposed draft reissued general permit establishes monitoring and reporting requirements, as well as numeric and/or narrative effluent limitations for temperature and pH. Numeric and narrative effluent limitations were based on protecting receiving water quality for its designated beneficial use(s).
