Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. The current 1999 set is a 13-volume bound collection of all adopted rules in effect at the time. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules and withdrawn proposed rules are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety in the *State Register*, only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted. For a more detailed description of the rulemaking process, see the most current edition of the *Minnesota Guidebook to State Agency Services*.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive; issue #26 cumulative for issues #1-26; issues #27-38 inclusive; issue #39, cumulative for issues #1-39; issues #40-51 inclusive; and issues #1-52 (or 53 in some years), cumulative for issues #1-52 (or 53). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Exempt Rules

Exempt rules are excluded from the normal rulemaking procedures (*Minnesota Statutes* §§ 14.386 and 14.388). They are most often of two kinds. One kind is specifically exempted by the Legislature from rulemaking procedures, but approved for form by the Revisor of Statutes, reviewed for legality by the Office of Administrative Hearings, and then published in the *State Register*. These exempt rules are effective for two years only.

The second kind of exempt rule is one adopted where an agency for good cause finds that the rulemaking provisions of *Minnesota Statutes*, Chapter 14 are unnecessary, impracticable, or contrary to the public interest. This exemption can be used only where the rules:

- (1) address a serious and immediate threat to the public health, safety, or welfare, or
- (2) comply with a court order or a requirement in federal law in a manner that does not allow for compliance with *Minnesota Statutes* Sections 14.14-14.28, or
 - (3) incorporate specific changes set forth in applicable statutes when no interpretation of law is required, or
 - (4) make changes that do not alter the sense, meaning, or effect of the rules.

These exempt rules are also reviewed for form by the Revisor of Statutes, for legality by the Office of Administrative Hearings and then published in the *State Register*. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years only. The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

Department of Employment and Economic Development (DEED) Adopted Exempt Permanent Rules Relating to Technical Changes to Unemployment Insurance Evidentiary Hearings

3310.2901 SCOPE AND PURPOSE.

Parts 3310.2901 to 3310.2924 establish procedures for hearings conducted by department unemployment law judges on the appeal of department determinations pertaining to eligibility or ineligibility for unemployment benefits, charges to employers' accounts and tax rate assignments, determinations on an employer's liability to pay taxes, determinations on the erroneous or fraudulent payment of unemployment benefits, and all other appeals which that are decided by unemployment law judges of the appeals office either by law or rule.

3310.2902 **DEFINITIONS.**

Subpart 1. **Scope.** For purposes of parts 3310.2901 to 3310.2926 3310.2924, the terms defined in this part have the meanings given them.

3310.2905 NOTICE OF APPEAL.

Subpart 1. [Repealed, L 2004 c 206 s 53]

Subp. 2. Information. The notice of appeal must also include the following information:

- G. A statement that documents to <u>contained in the department's records that will</u> be introduced at the hearing as department exhibits are available upon request, and an explanation of the process for making the request.
- H. If a decision issued under part 3310.2926 Minnesota Statutes, section 268.105, subdivision 1, paragraph (c), could result in a determination that a party has been an applicant being overpaid unemployment benefits, the notice must contain the following statement: "You have already received unemployment benefits on your benefit account. It is important for you to attend this hearing even if you are back to work and not receiving unemployment benefits now, because if you lose the appeal, you will not be able to receive further unemployment benefits and you will have to pay back all the unemployment benefits you have already received. These unemployment benefits are called overpaid unemployment benefits and they could be deducted from your state income tax refund, rent credit refund, or from a future benefit account."

3310.2908 RESCHEDULING.

Requests to reschedule a hearing must be addressed to the appeals office in advance of the regularly scheduled hearing date. The request

may be made in person, by telephone or other electronic transmission, or in writing. Unless a determination is made by the appeals office that a request to reschedule a hearing is made for the purposes of delay, a hearing must be rescheduled by the appeals office based on a party's need for additional time to obtain necessary evidence or to obtain representation or adequately prepare, inability to be present at the regularly scheduled time due to illness, other judicial or quasi-judicial proceedings which that have previously been scheduled, or other compelling reasons beyond the control of the party which that prevent attendance at the originally scheduled time. A hearing may be rescheduled only once except in the case of an emergency. If requested by the appeals office, a letter written statement by mail or electronic transmission confirming the reasons for requesting that the case be rescheduled must be provided to the appeals office by the requesting party.

Unless a determination is made by the unemployment law judge that a request to reschedule a hearing is made for the purpose of delay, a judge who has been assigned a case for hearing must reschedule a hearing at the request of a party provided grounds for rescheduling as set forth above have been established. The failure of subpoenaed witnesses to appear at the hearing or the failure to produce subpoenaed documents may constitute grounds for rescheduling.

3310.2910 NOTICE OF HEARING; CONSOLIDATION OF ISSUES.

The notice of hearing must be mailed to each party at the last known address at least ten days before the scheduled date of hearing unless otherwise provided by law, or when notice is waived by the parties. The notice must state the time, date, and place of the hearing, the name of the unemployment law judge who will hear the case, the issues to be considered at the hearing, and must contain the information required by part 3310.2905, subpart 2, items B to H. If the issue to be considered at the hearing involves ineligibility for unemployment benefits because of a separation from employment, the notice must explain that either the issue of misconduct or quit for other than a good reason caused by the employer may be heard if the facts brought out at the hearing so warrant, and the parties should be prepared to discuss all incidents which that arose during the course of the employment which that led to the separation. The parties must also be advised of their right to represent themselves or to be represented by an attorney or other duly authorized representative. Upon the motion of a party to a hearing or on the unemployment law judge's motion, the unemployment law judge may consolidate for hearing issues involving the same parties and may take testimony and render a decision on issues not listed on the notice of hearing if each party is so notified on the record at the hearing and does not object on the record.

3310.2912 EXHIBITS IN TELEPHONE CONFERENCE HEARINGS.

Upon receipt of notice of a telephone conference hearing, and no later than five calendar days before the scheduled time of hearing, parties may submit to the department any documents they wish to offer as exhibits at the hearing. Copies of the documents as well as all documents which that are to contained in the department's records that will be introduced as department exhibits must be mailed to all parties by the appeals office in advance of the hearing. If a party moves to introduce additional documents during the course of the hearing, and the unemployment law judge rules that the documents should be admitted into evidence, the moving party must send copies of the documents to the unemployment law judge and the opposing party. The record must be left open for sufficient time for the submission of a written objection and for response to the documents. The response may be in writing sent by mail or electronic transmission or the unemployment law judge may, when appropriate, reconvene the telephone conference hearing to obtain a response or permit cross-examination regarding the late filed exhibits.

3310.2913 ACCESS TO DATA.

The parties to a hearing must be allowed reasonable access to department data necessary to represent themselves properly in proceedings under parts 3310.2901 to 3310.2924 and 5310.2924. Access to data under parts 3310.2901 to 3310.2924 and be consistent with *Minnesota Statutes*, chapter 13; *Minnesota Statutes*, section 268.19, *Minnesota Statutes*, chapter 13; and other laws relating to data practices. Upon oral or written request by a party or the party's representative, the appeals office must provide copies of documents that are to in the department's records that will be introduced as department exhibits. The copies must be provided at no cost and, upon request, must be mailed or sent by electronic transmission to the party or the party's representative.

3310.2915 DISQUALIFICATION OF UNEMPLOYMENT LAW JUDGE.

An unemployment law judge must remove himself or herself from any case where the judge believes that presiding over the case would create the appearance of impropriety. No judge may hear any case where any of the parties to the appeal are related to the judge by blood or marriage. A judge must not hear any case if the judge has a financial or personal interest in the outcome. A judge having knowledge of such a relationship or interest must immediately remove himself or herself from the case.

Any party may move for the removal of a judge by written application of the party together with a statement of the basis for removal. Upon the motion of the party, the director of the appeals office chief unemployment law judge must decide the fitness of the judge to hear

the particular case.

3310.2916 REPRESENTATION BEFORE UNEMPLOYMENT LAW JUDGE.

Any individual may personally appear in any proceeding before an unemployment law judge and may be represented by an attorney or a duly authorized representative. Any partnership may be represented by any of its members, an attorney, or other duly authorized representative. Any corporation or association may be represented by an officer, an attorney, or other duly authorized representative.

The commissioner An unemployment law judge may refuse to allow any person to represent others in any proceeding before an unemployment law judge if that person is unethical in conduct or intentionally and repeatedly fails to observe the provisions of the law or rules relative to such the proceedings or the instructions of the commissioner or an unemployment law judge.

3310.2921 CONDUCT OF HEARING.

The order of presentation of evidence is determined by the unemployment law judge. The judge must inform the parties of their the statutory provisions on burdens of proof before the taking of testimony.

Each party may present and examine witnesses and offer their own documents or other exhibits. To the extent permitted by *Minnesota Statutes*, section 268.19, and other laws pertaining to the protection of data, a party must be provided with a copy of any document or exhibit accepted into evidence upon the request of the party. Opposing parties have the right to examine witnesses, object to exhibits and testimony, and cross-examine the other party's witnesses. The judge should assist unrepresented parties in the presentation of evidence. The judge must rule upon evidentiary objections on the record. The judge must permit rebuttal testimony. Parties have the right to make closing statements. Closing statements may include comments based upon the evidence and arguments of law. The judge may limit repetitious testimony and arguments.

The judge must exercise control over the hearing procedure in a manner that protects the parties' rights to a fair hearing. The judge must ensure that relevant facts are clearly and fully developed.

3310.2922 RECEIPT OF EVIDENCE.

Only evidence received into the record of any hearing may be considered by the unemployment law judge. The parties may stipulate to the existence of any fact or the authenticity of any exhibit.

All competent, relevant, and material evidence, including records and documents in the possession of the parties which that are offered into evidence, are part of the hearing record. A judge may receive any evidence which that possesses probative value, including hearsay, if it is the type of evidence on which reasonable, prudent persons are accustomed to rely in the conduct of their serious affairs. A judge may exclude any evidence which that is irrelevant, immaterial, unreliable, or unduly repetitious. A judge is not bound by statutory and common law rules of evidence. The rules of evidence may be used as a guide in a determination of the quality and priority of evidence offered. A judge may draw adverse inferences from the refusal of a party or witness to testify on the basis of any privilege. A judge may only use reliable, probative, and substantial evidence as a basis for decision.

3310.2923 OFFICIAL NOTICE.

An unemployment law judge may take official notice of adjudicative facts and matters of common knowledge and may take notice of facts within the judge's specialized knowledge in the field of unemployment benefits insurance. Any fact officially noticed must be noticed on the record in the decision. Parties must be notified of any facts officially noticed by the judge and must be given an opportunity to contest the noticed facts.

A judge may officially note any facts which that are subject to judicial notice in the courts of Minnesota.

3315.0200 PURPOSE.

3315.0212 EMPLOYEE EQUIPMENT AND VEHICLES.

Subpart 1. **Trucks, bulldozers, tractors.** The compensation of the operator and supplier of a bulldozer, tractor, or similar equipment, and trucks other than truck owner-operators excluded under part 3315.0525 <u>Minnesota Statutes</u>, section 268.035, subdivision 25b, whose compensation includes wages for personal services as well as the cost of operating and hiring the equipment are wages unless the amount attributable to wages is separately identified either by making separate payments; or, if both wages and equipment hire are combined in a single payment, by a prearranged written agreement or by specifically indicating the separate amounts at the time of each payment.

Subp. 2. **Advances or reimbursements as wages.** Payments to an employee that include advances or reimbursements for use of a personal vehicle of up to 9,000 pounds gross vehicle weight in the employer's business are wages unless the amount attributable to the use of the vehicle is separately paid or stated as prescribed in part 3315.0220, item H Minnesota Statutes, section 268.035, subdivision 29, paragraph (a), clause (10), and the advance or reimbursement is not unreasonable or arbitrary in which case only the amount attributable to services performed is wages.

3315.0805 DEFINITIONS.

Subp. 5. **Farm.** "Farm," unless otherwise excluded in this rule part 3315.0820, means land or buildings if their primary use is for raising agricultural or horticultural commodities or for activities generally associated with the operation of a ranch, range, livestock, or dairy operation. A farm need not be a specific size and it need not be composed of contiguous plots. The performance of agricultural services does not by itself render the place where they are performed a farm.

3315.0810 UNMANUFACTURED STATE.

Minnesota Statutes, section 268.035, subdivision 2, requires that the services described in that elause <u>subdivision</u> be in connection with commodities that are in their unmanufactured state. A commodity that loses its original identity is considered in a manufactured state and services relating to the manufactured product are not agricultural. The following products are considered as being in a manufactured state: cheese; butter; yogurt; ice cream; dried or powdered milk; dried fruits or vegetables; juices, oils, and syrups derived from fruits and vegetables; and dried or powdered eggs.

3315.0901 PURPOSE.

Parts 3315.0901 to 3315.0920 and 3315.0905 further define and clarify terms used in *Minnesota Statutes*, section 268.035, subdivision 20, clause (17), and in parts 3315.0901 to 3315.0920 and 3315.0905.

3315.1001 SCOPE.

Parts 3315.1001 to 3315.1020 and 3315.1010 clarify an employer's duty with regard to records and reports as required under *Minnesota Statutes*, chapter 268.

3315.1010 RECORDS.

Subpart 1. **Record keeping.** Each employer must establish, maintain, and preserve records with respect to individuals performing personal services for it, including individuals who perform or assist in performing the work of any employee of the employer if the employer had actual or constructive knowledge that the work was being performed. The records must be preserved for a period of not less than eight years after the calendar year in which the compensation for the services was paid or payable, and must show for each individual the following:

K. for each calendar month or, if less, the established pay period of the employer, the hours spent performing services in employment and the hours spent performing noncovered employment, by each employee for which the provisions of part 3315.0535 *Minnesota Statutes*, section 268.035, subdivision 15, paragraph (a), clause (5), apply.

Subp. 2. **Instate and outstate.** For services performed within and without Minnesota the records required by subpart 1 must include:

A. the city or county and state in which the employer maintains a base of operations, as defined in part 3315.0550, subpart 3 Minnesota Statutes, section 268.035, subdivision 12, clause (1), used by the individual;

Minnesota Department of Natural Resources (DNR) Classification of State Forest Lands in Becker, Clearwater, and Mahnomen

Counties of Minnesota with Respect to Motor Vehicle Use

NOTICE IS HEREBY GIVEN that the Commissioner of Natural Resources orders the classification of state forest lands described below with respect to motor vehicle use. These classifications of state forest lands with respect to motor vehicle use are pursuant to *Minnesota Laws 2003*, Chapter 128, Article 1, Section 167, (as amended in 2005 and 2007) and *Minnesota Rules* Part 6100.1950.

The commissioner further orders that state forest lands described below be designated as areas with limitations on off-trail and non-designated trail use pursuant to *Minnesota Statutes*, Section 84.926, Subd. 5.

WHEREAS

- 1. *Minnesota Laws 2003*, Chapter 128, Article 1, Section 167, (as amended in 2005 and 2007) and *Minnesota Rules* Chapter 6100.1950 require the Commissioner of Natural Resources to classify all state forest lands with respect to motor vehicle use.
- 2. *Minnesota Statutes 2006*, Section 84.926, Subdivisions 2 and 4 allow some hunting- and trapping-related motor vehicle uses on state forest lands classified as *'limited'* or *'managed'* with respect to motor vehicle use. Section 84.926, Subdivision 5 authorizes the commissioner to designate areas on state forest lands that are not subject to the exceptions provided in Subdivisions 2 and 4.
- 3. The Department of Natural Resources published its proposed motor vehicle use classifications; proposed forest road and trail designations; and proposed areas with limitations for state forest lands in Becker, Clearwater and Mahnomen Counties in a draft plan in May 2008.
 - 4. All notice and procedural requirements in Minnesota Statutes, and other applicable laws and rules have been met.

NOW THEREFORE, IT IS ORDERED that the following state forest lands be classified as '*limited*' with respect to motor vehicle use, pursuant to authority vested in me by Minnesota law:

- · State forest lands in the White Earth State Forest;
- · State forest lands, outside state forest boundaries, in Becker, Clearwater and Mahnomen Counties; and

These state forest lands are depicted as 'limited' on the maps in Exhibits A-1, A-2, A-3 and A-4, attached hereto and incorporated herein.

IT IS FURTHER ORDERED that state forest lands within the areas described below be designated as areas with limitations on off-trail and non-designated trail use pursuant to *Minnesota Statutes*, *Section 84.926*, *Subdivision 5*:

- Upper Rice Lake Approx. 4,710 acres in Sections 34, 35, 36 of T146N, R37W, and in Sect. 1, 2, 3, 4, 9, 10, 11, 12, 14, 15, 16 of T145N R37W inside the White Earth State Forest in southwestern Clearwater County. This area lies North of Co. Road 113, North of the Wild Rice River, West of Upper Rice lake, West of Co. Road 84 and Co. Road 32, South of Co. Road 13 and East of Co. Road 92. The Wild Rice River and Upper Rice Lake form the area's southern and eastern boundaries, respectively.
- Snider Lake Area Approx. 3.360 acres inside the White Earth State Forest in southeastern Mahnomen County. This includes Sections 1-3, 10-12, 13-15, and 22-24 of T143N R40W inside the White Earth State Forest. This area lies north of TH 113; North and West of Town Road 203; West of County Roads 4 and 8; South of Co. Road 6; and, East of Co. Roads 3 and 28.

These areas with limitations on off-trail and non-designated trail use are depicted on the maps in *Exhibits A-5 and A-6*, attached hereto and incorporated herein.

IT IS FURTHER ORDERED that the above motor vehicle use classifications and designations shall become effective December 31, 2009.





Exhibit A-3: Mahnomen County State Forest Land Classification






Exhibit A-4: White Earth State Forest Land Classification

Exhibit A-5: Clearwater County, Upper Rice Lake Area with Motor Vehicle Use Limitations





Exhibit A-6: Mahnomen County, Snider Lake Area With Motor Vehicle Use Limitations





Exhibit A-2: White Earth All-terrain Vehicle (ATV) / Off-highway Motorcycle (OHM) Trail Designations






Exhibit A-3: Becker County Non-motorized Trail Designations

The Metropolitan Council's Transportation Committee at its January 12, 2009 meeting will accept the public comment report and revised draft 2030 Transportation Policy Plan (TPP)and recommend the plan for adoption by the Metropolitan Council at its January 14, 2009 meeting..

The Metropolitan Council is required by federal and state law to prepare a surface transportation plan for the seven-county metropoli-

tan area. The proposed Transportation Policy Plan meets that requirement and supports the 2030 Regional Development Framework, the development plan for the region. The proposed Transportation Policy Plan includes sections on transit, highways, aviation, freight, pedestrian and bicycle movement.

Federal law requires the Council to prepare a fiscally constrained plan in conformance with federal transportation and air quality requirements every four years. The plan must follow federal guidance and has been drafted to address such guidance.

Since the draft plan was adopted in September 2008 significant changes in the national economy have led to calls for Congress to adopt an economic stimulus package which would likely include funding for transportation infrastructure. During the comment period, an issue was raised about how this region could respond to availability of additional federal funding.

Public notice of the January 12 meeting is being made since the Council will consider adding language to the final plan which will allow the region maximum flexibility to take advantage of this potential funding. The Council will list 11 major highway expansion projects beyond the fiscally constrained regional plan that could use these additional funds if they become available. The Council has worked with its partners to address the air quality conformity procedures so any one of these major projects from the 2005 Transportation Policy Plan could take advantage of these additional federal funds. The purpose of this project is to provide Mn/DOT with the ability to locate and track the position of fleet vehicles on or near public roadways anywhere within the Metro District. The system and service to be provided will be able to display current (near real time) and historical vehicle location information in both a graphical and text document format, for both individual and discrete subsets of vehicles. The graphical display will be on scalable (and printable) maps which will include other GIS format base map information. The system will, upon query of either an active or an archived data set, provide the current or historical vehicle location information for any user-selected specific reporting time period and user-selected report interval which may or may not match the actually utilized data collection interval of the particular vehicle.

Responders are encouraged to propose additional tasks or activities if they will substantially improve the results of the project.

Required System Features -

- · In-vehicle hardware will be tamper resistant.
- The vehicle transponders provided will have hard wired power. Cigarette plug or similar plug-type power supply methods will not be allowed.
- In the event of loss of connection to the server, supplied transponders will have the capability to store and forward location and other collected event data for multiple collection intervals, desirably exceeding 4 hours.
- During user operation, the mapping utilized by the system will reside on the workstation computer and will not be continuously pulled from the internet. This is to limit traffic on the Mn/DOT network.

- The mapping provided within the system will be scalable, printable, and layerable to allow user control of legibility and format (photo background vs. map background, etc.).
- The system provided will have capability within its mapping provisions to utilize MnDOT's existing or developed ESRI GIS layers and aerial photography.
- The user will be able to view and print current and historical vehicle location information on a selected mapping background, as noted above.
- The system will have geo-fencing capabilities, with fence definition permissions (for temporary and permanent fences) being controllable through user rights.
- The system will have the ability to associate and disassociate defined geofences with any particular vehicle or vehicles, as well as having an ability to have the fence status set to active or inactive for each vehicle. This is for the purpose of allowing resource sharing without excessive fence penetration reporting.
- Vehicle data recorded and reported by the system will include at a minimum: vehicle identification, vehicle operational status (ignition on or off), vehicle location, vehicle speed, and vehicle penetration of any associated and active geofencing boundaries.
- The system will have the ability to handle a fleet size of up to 1500 Mn/DOT vehicles operating throughout the Metro District.
- The system will have the ability to service up to 30 signed in workstation sites (PC's on the Mn/DOT network) with no appreciable impact on network service speeds.
- The vehicle transponders provided will have a "sleep mode" or have other operational characteristics designed to significantly
 reduce power consumption while the vehicle is turned off. A location report upon vehicle shutdown and periodically after
 that will still be required.

Desired Additional System Features – The following is a listing of system features that Mn/DOT has identified would be beneficial to the Department and would ideally be included within the capabilities of the system. Capability of generating an automated phone or text message notification of a geofence penetration.

- · System expandability to provide additional utility in the future.
- System suitability for upgrading to provide additional event triggers and data collection associated with snow plowing operations. (Plow Up/Down, sanding and salting rates, pavement temperatures, etc.)

Information Output

- a. Selectable Vehicle or Vehicles to be graphically displayed with near real time updating at each reporting interval.
- b. Selectable User Re-Definable Sets of Vehicles to Display (may be system wide vs. individual user), an example of which might be "Mendota Construction Pickups."
- c. Vehicle History Reports will be generated upon request, with those reports having selectable time period and reporting interval which causes the system to extract the first available record after the specified beginning of the time period, then skips others records in between until the next reported time after the request interval, etc. etc. until the specified end of the time period is reached. (e.g. The intent of this provision is so that the user can choose and print say a "half-hour interval report" even though the subject vehicle has data collected on it every two minutes.)
- d. Historical vehicle location information will also be able to be displayed and printed in both graphical and text document formats.

Disposition of Responses
