# Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # **Adopted Rules**

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

**KEY: Proposed Rules** - <u>Underlining</u> indicates additions to existing rule language. <u>Strikeouts</u> indicate deletions from existing rule language. If a proposed rule is totally new, it is designated "all new material." **Adopted Rules** - <u>Underlining</u> indicates additions to proposed rule language. <u>Strikeout</u> indicates deletions from proposed rule language.

# **Executive Orders**

The governor has the authority to issue written statements or orders, called Executive Orders. as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

# Executive Order 11-31: Representation of Licensed Registered Subsidized Family Child Care Providers

**I, MARK DAYTON, GOVERNOR OF THE STATE OF MINNESOTA**, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

WHEREAS, it has been well documented that the first five years of a child's life is a time of phenomenal growth and development, and access to high-quality early childhood education services prepares children for later learning in life, and ensures that they enter kindergarten ready and able to succeed; and

WHEREAS, licensed family child care providers provide invaluable services to working parents and guardians by providing high quality learning environments for their children while they are engaged in work or education opportunities, or both, and are particularly well-suited to meet families' needs, by providing care during flexible hours and schedules, including evenings, overnight, and weekends in a comforting home environment; and

WHEREAS, the State is committed to improving the quality, accessibility, and affordability of early childhood education services; and

**WHEREAS**, despite their important services to Minnesota's families, there has been a troubling decline in the number of licensed family child care providers operating in the State of Minnesota; and

WHEREAS, under *Minnesota Statutes*, Chapters 119B and 245A, the Minnesota Department of Human Services is the lead child care agency and its Commissioner sets the rules by which child care services are administered through the State-supervised and county-administered system; and

WHEREAS, under *Minnesota Statutes*, Section 119A.03, subdivision 2, the Commissioner of Education must develop linkages with other state departments to ensure coordination and consistent state policies promoting healthy development of children and families; must facilitate inclusive processes when designing or implementing guidelines and strategies to achieve agency goals for children and families; and must facilitate intergovernmental and public-private partnership strategies necessary to implement *Minnesota Statutes*, Chapter 119A: and

WHEREAS, unions AFSCME and SEIU have claimed in writing that a majority of licensed family child care providers desire to be represented for the purposes of negotiating their relationship with the State; and

WHEREAS, in light of the foregoing, a labor dispute exists concerning the right of family child care providers to organize for the purpose of representation in their dealings with the State; and

**WHEREAS**, under Minnesota laws and Statutes, including but not limited to, Section 179.02, the Commissioner of the Bureau of Mediation Services has broad authority to make rules, appointments, and to provide technical support in the area of labor relations, including the conduct of elections and the resolution of labor disputes in the State, regardless of whether there is an employer or employee relationship; and

**WHEREAS**, it is essential that a fair and transparent election among licensed family child care providers proceed before the State shall certify or conduct meetings with any representatives of family child care providers.

#### NOW, THEREFORE, I hereby order that:

- 1. Within 60 days after the issuance of this Order, the Commissioner of the Bureau of Mediation Services shall conduct two mail-ballot elections to determine whether AFSCME Council 5 and SEIU shall represent licensed registered subsidized family child care providers in the appropriate units, requested by AFSCME Council 5 and SEIU in their letter dated November 8, 2011. For the purposes of the election, the Bureau of Mediation Services shall utilize the most recent list of licensed registered subsidized family child care providers in the appropriate units. The Commissioner of the Bureau of Mediation Services may designate the American Arbitration Association, subject to his oversight, to conduct all proceedings related to the elections in the appropriate units, in a fair and transparent manner. Any costs incurred by the Bureau of Mediation Services or the American Arbitration Association in carrying out this section shall be borne entirely by AFSCME Council 5 and SEIU.
- 2. "Licensed registered subsidized family child care providers" shall include those family child care and group family child care providers subject to licensure under *Minnesota Statutes*, Chapter 245A; subject to various other requirements under *Minnesota Statutes*, Chapter 119B; governed by *Minnesota Rules*, Chapter 3400 and Chapter 9502; and who are registered as of September 30, 2011 to receive subsidies for providing subsidized child care services pursuant to the Minnesota Child Care Assistance Programs ("CCAP") under Chapter 119B.
- 3. If a majority of licensed registered subsidized family child care providers voting in the mail ballot election provided for herein, vote affirmatively for exclusive meet and confer representation, the Commissioner of the Bureau of Mediation Services shall certify the organization so designated.
- 4. If the Commissioner of the Bureau of Mediation Services certifies a majority exclusive representative in an appropriate unit, the Commissioners of Human Services and Education or their designees, shall meet and confer in good faith with the exclusive representatives of the licensed registered family child care provider units regarding issues of mutual concern, including quality standards and quality rating systems; the availability of training opportunities and funding; reimbursement rates; access to benefits; changes to the state system

of providing early childhood education services; the monitoring and evaluating of family child care providers; and any other matters that the parties agree would improve recruitment and retention of qualified licensed registered family child care providers and the quality of the

programs they provide.

5. All agreements on issues of mutual concern shall be memorialized in writing. If any provision of an agreement negotiated between the Commissioner of Human Services, the Commissioner of Education, and the exclusive representatives requires new legislation,

the adoption or modification of administrative rules of any department or agency of State government to be effective, or the appropriation

of money for their implementation, the parties will seek enactment of the legislation, adoption of the rules or both.

6. Nothing in this Order shall be construed to confer upon licensed family child care providers the right to strike.

7. In affording licensed registered subsidized family child care providers the right to engage in collective action, select a

representative, and jointly engage in negotiations with the State under the terms of this Order, the State intends that the "State Action" exemption from federal antitrust laws be fully available to the State, based on the State's active supervision of licensed family child care

providers to improve the quality, accessibility, and affordability of early childhood education services in the State.

8. Nothing in this Order shall be construed to grant family child care providers status as employees for any purpose.

9. Nothing in this Order shall be construed to interfere with parental rights to select and deselect family child care providers,

or the ability of family child care providers to establish the rates they charge to parents.

10. Nothing in this Order shall be construed to require participation, or the involuntary payment of dues by any family child

care provider.

11. Nothing in this Order shall be construed to interfere with the right or obligation of any state agency to communicate or meet

with any citizen or organization concerning family child care legislation, regulation, or policy.

12. Shall any part of this Order be declared to be invalid or unenforceable, or the enforcement or compliance with it is

suspended, restrained or barred, either by the State or by the final judgment of a court of competent jurisdiction, the remainder of this Order

shall remain in full force and effect.

Under *Minnesota Statutes 2011* § 4.035, subdivision 2, this Executive Order is effective 15 days after publication in the *State Register* and filing with the Secretary of State and shall remain in effect until rescinded by proper authority or it expires in accordance with

Minnesota Statutes 2011 § 4.035, subdivision 3.

**Executive Order 11-32: Directing the Work of the Environmental Quality Board** 

I, MARK DAYTON, GOVERNOR OF THE STATE OF MINNESOTA, by virtue of the authority vested in me by the Constitution

and applicable statutes, do hereby issue this Executive Order:

WHEREAS, the Minnesota Environmental Quality Board (EQB) is composed of nine state agency heads, five citizen members, and a

governor's representative, who serves as chair;

WHEREAS, the EQB is directed by law to:

1. Determine which environmental problems of interdepartmental concern to state government it shall consider and initiate interdepartmental investigations into those matters that it determines are in need of study, including but not limited to topics of future

population and settlement patterns, air and water resources and quality, solid waste management, transportation and utility corridors,

economically productive open space, energy policy and need, growth and development, and land use planning;

2. Review programs of state agencies that significantly affect the environment and coordinate those it determines are interde-

partmental in nature, and ensure agency compliance with state environmental policy; and

WHEREAS, Minnesota's environmental review processes are complex, with multiple policy-setting and governing bodies, and are in

need of review and revision to ensure that they respond to the public value of promoting economic growth, while also protecting

Minnesota's precious natural resources; and

WHEREAS, the EQB by virtue of its composition is uniquely able to align state economic, energy and environmental policies to create

a sustainable future for the our state, our economy, and our environment; and

WHEREAS, a well-functioning EQB can advance this Administration's goal to deliver the best services to the public at the best price;

and

WHEREAS, the EQB does not have sufficient dedicated staff resources to undertake these vital planning and policy coordination

functions.

NOW, THEREFORE, in order to ensure that the EQB fulfills its policy-making and coordination roles I hereby order that:

1. By November 15, 2012, the EQB shall evaluate and make recommendations on how to improve environmental review, given

the changes made in Chapter 4, House File 1, and the recommendations contained in the Office of the Legislative Auditor Environmental

Review and Permitting Report.

2. By November 15, 2012, the EQB will evaluate and make recommendations for improved environmental governance and

coordination.

3. By November 15, 2012, the EQB shall prepare an environmental and energy report card that identifies metrics which the

State of Minnesota can use to measure its performance and progress protecting Minnesota's valuable air, water and land resources. Once initially established, the environment and energy report card shall be an annual report with renewed priorities, initiatives, and goals and an

updated report card.

4. By January 15, 2013, the EQB shall organize and host an environmental congress focused on the current state of Minnesota's

environment, utilizing the elements in the report card.

5. Each member agency of the EQB shall dedicate to the EQB the staff resources requested by the EQB Chair, for purposes of

carrying out the work directed by this Executive Order.

Under *Minnesota Statutes* 2011, Section 4.035, subdivision 2, this Executive Order is effective 15 days after publication in the *State* 

Register and filing with the Secretary of State and shall remain in effect until rescinded by proper authority or it expires in accordance with

Minnesota Statutes 2011, Section 4.035, subdivision 3.

# REQUEST FOR COMMENTS on Possible Amendment to Rules Governing Horse Racing, *Minnesota Rules*, 7876 Stabling, 7890 Horse Medication, and 7897 Prohibited Acts

**Subject of Rules.** The Minnesota Racing Commission requests comments on its possible amendment to rules governing Horse Racing. The Commission is considering rule amendments that require a record of a negative test for Equine Piroplasmosis, extend the time a Certificate of Veterinary Inspection can be used after the initial entry to a racetrack, add or revise definitions to Horse Medication definitions, set regulatory limits on medications, and prohibit acts with regard to feed and medication.

**Persons Affected.** The amendment to the rules would likely affect Class A & B Licensees, Class C licensees, and the betting public, and horsemen.

# Department of Labor and Industry (DLI) Workplace Safety Consultation Unit Notice of Safety Grants for Employers

The Department of Labor and Industry (DLI) announces continuation of its safety hazard abatement matching grant program under *Minnesota Statutes*, section 79.253, and *Minnesota Rules*, parts 5203.0010 through 5203.0070. Employers covered by workers' compensation insurance, and those approved as self-insured employers, are eligible to apply for safety/health matching grants to abate safety hazards in their workplace. The safety/health hazards must have been identified in an on-site survey conducted by one of the following:

- 1) MNOSHA safety/health investigator,
- 2) DLI Workplace Safety Consultation safety/health consultant,
- 3) in-house employee safety/health committee,
- 4) workers' compensation underwriter,
- 5) private safety/health consultant or
- 6) a person under contract with the Assigned Risk Plan.

The on-site safety/health survey must have resulted in specifically recommended safety and/or health practices or equipment, training for purchased equipment, and/or tuition reimbursement designed to reduce the risk of injury to employees. Costs eligible for program participation are all or part of the cost of purchasing and installing recommended safety/health equipment, training for purchased equipment, tuition reimbursement, the cost of operating or maintaining safety/health equipment, and/or the cost of purchasing or renting real property, if necessary, to meet criteria established by the on-site safety/health survey. Automobiles, weapons, or personnel costs, such as salary and benefits, will not be covered by these grants.

Whether we approve your grant application or not, does not diminish, delay, or absolve you of any obligation to abate hazards as required by law. No state funds will be distributed until all grant documents are signed by all parties and the safety grant project is completed, including payments for all items in the project. Costs incurred before all parties have signed the grant document must not rely on grant approval. Invoices dated prior to your fully executed grant agreement are not eligible for this program.

# **State Grants and Loans**

Grants are limited to a total maximum match of up to \$10,000 per project. The employer must provide at least \$1.00 (one dollar) in project costs for every dollar awarded. No grant will be awarded for more than half the amount of the approved project. General Industry; Grain handling equipment.
