## Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ## Revenue Notice # 12-01: Sales and Use Tax – Special Fur Clothing Tax – Revocation of Revenue Notice # 01-04

Revenue Notice # 01-04: Special Fur Clothing Tax, is hereby revoked. This Revenue Notice is no longer needed since *Minnesota Statutes*, section 295.60, which imposed a special tax on fur clothing, was repealed in 2008.

Fur clothing, which is defined in *Minnesota Statutes*, section 297A.61, subdivision 46, is subject to sales and use tax. It does not meet the sales and use tax definition of clothing that is exempt under *Minnesota Statutes*, section 297A.67, subdivision 8.

## Revenue Notice # 12-02: Sales and Use Tax – Home Health Care Services – Combination Contracts

#### **Background**

Home health care service providers often provide a combination of home medical services, personal care services, and services such as laundry and residential cleaning to their clients. *Minnesota Statutes*, section 297A.61, subdivision 3, paragraph (g) (6) (i) and (iii), define "sales and purchases" to include laundry services and residential cleaning, maintenance, and disinfecting services such that these services are subject to sales and use tax. Sales and use tax, however, does not apply to charges for home medical care services or personal care services. This revenue notice explains the department's position when these taxable and nontaxable services are provided as part of a home health care service contract.

#### **Department Position**

When a home health care service contract provides for a combination of medical care, personal care, laundry and residential cleaning services that results in the inclusion of taxable and nontaxable services for a single charge, and the laundry and residential cleaning services included in the contract are provided to clients because their illness, disability or physical condition creates a need for such services at their residences, the taxable laundry and cleaning services are considered incidental to the nontaxable home medical care services and personal care services being provided, and the entire contract price is exempt from sales and use tax.

For purposes of this revenue notice, "home medical care services" means medical care services provided to ill, disabled, or infirm persons in their residence whether the client resides in a private home, nursing home, or assisted living care center. "Medical care services" includes all services rendered because of illness or disability, which are reasonably necessary for care, comfort and proper treatment of the client. If the services are certified by Medicare/Medicaid and the charges for the services are reimbursed in full by Medicare/Medicaid, the department will presume the services are medical care services. For purposes of this revenue notice, "personal care services" includes services such as grooming, dressing, preparing meals, providing shopping assistance, accompanying the client to medical appointments, and providing companionship, but do not include massages that are taxable under *Minnesota Statutes*, section 297A.61, subd. 3.

A home health care provider sometimes contracts with a third party to perform laundry, residential cleaning, or other taxable services for the provider's client. If the home health care provider has an agreement with that client in which multiple services, including those taxable services, are provided for a single charge, then the home health care provider, in contracting with the third party to perform those services, cannot purchase those services exempt for resale. However, the home health care provider may purchase those services exempt

for resale if the home health care provider's agreement with its client separately itemizes the taxable services, instead of having a single charge for all services.

Commissioner's Order for Pictorial Stamp Fee

Date: 22 February 2012

Statutory authority: Minnesota Statutes, section 97A.405, subd. 2(d)

X Supersedes. The pictorial stamp fee was \$2.00. New legislation now only allows for the cost to produce and mail the stamp.

#### BACKGROUND

97A.405 subd. 2(d) A license issued electronically and not immediately provided to the licensee shall be mailed to the licensee within 30 days of purchase of the license. A pictorial migratory waterfowl, pheasant, trout and salmon, or walleye stamp shall be provided to the licensee after purchase of a stamp validation only if the licensee pays an additional fee that covers the costs of producing and mailing a pictorial stamp. A pictorial turkey stamp may be purchased for a fee that covers the costs of producing and mailing the pictorial stamp.

Notwithstanding section 16A.1283, the commissioner may, by written order published in the State Register, establish fees for providing the pictorial stamps. The fees must be set in an amount that does not recover significantly more or less than the cost of producing and mailing the stamps. The fees are not subject to the rulemaking provisions of chapter 14, and section 14.386 does not apply.

Analysis shows that the fee to produce and a mail a pictorial stamp is \$0.755 based on 2011 costs and current postage rates. Suggested fee to cover costs at this time is \$0.75.

#### ORDER

**NOW, THEREFORE, IT IS HEREBY ORDERED**, pursuant to authority vested in me by law, including but not limited to *Minnesota Statutes*, section 97A.405, subdivision 2 (d), that the additional fee for a pictorial stamp is \$0.75.

### Commissioner's Order PLF- 11 -2: Designation of Fish Health Service Fees

Effective Date: March 1, 2012

Statutory authority: Minnesota Statutes, section 17.4988, subd. 3

These fees supercede all previously established fees or designations.

#### BACKGROUND

Pursuant to the provisions of *Minnesota Statutes*, sections 17.4988, subdivision 3 and 97C.342, the following order describes the fees private commercial businesses will be charged when the Department of Natural Resources provides fish health inspection and fish collection services. The fish health inspection fee schedule is based on the number of fish per standard lot as listed. When sample sizes other than those listed occur, fees will be prorated. Fish collection fees include mileage and staff time.

#### **ORDER**

**NOW, THEREFORE, IT IS HEREBY ORDERED**, pursuant to authority vested in me by law, including but not limited to *Minnesota Statutes*, sections 17.4988, subdivision 3 and 97C.342, that the fees described below will be used to assess charges to private commercial business that obtain fish health services from the Department of Natural Resources.

Commissioner's Order 12-001: Motorized Watercraft Restriction on Pelican Lake in Wright County for 2012

Date: February 10, 2012
Statutory authority: Minnesota Statutes, 97A.101, subd. 4

#### **BACKGROUND**


For the purposes of enhancing the use and value of Pelican Lake (DOW #86003100) in Wright County (a Wildlife Management Lake designated pursuant to *Minnesota Statutes*, section 97A.101) for migratory waterfowl, and to limit the disturbance of migratory waterfowl that are feeding and resting during the spring migration particularly Lesser and Greater Scaup, Canvasbacks, Redheads, Ring necks, and Ruddy ducks the following motorized watercraft restrictions are effective March 15, 2012 thru May 15, 2012 as authorized by *Minnesota Statutes*, section 97A.101 subdivision 4. The statutory requirements in *Minnesota Statutes*, section 97A.101 subdivision 4 have been met.

#### **ORDER**

**NOW, THEREFORE, IT IS HEREBY ORDERED**, pursuant to authority vested in me by law, including but not limited to *Minnesota Statutes*, section 97A.101 subdivision 4, that:

- 1. Portions of the surface waters of Pelican Lake in Wright County (DOW# 86003100) are closed to all motorized watercraft, from March 15, 2012 to May 15, 2012 except as otherwise provided by this notice or special permit. The closed zone is described as the portion of Pelican Lake located in Sections 11, 12, and 13 of Township 120 N., Range 25 W. and Sections 5, 6, 7, 8, 17, 18 of Township 120 N., Range 24 W., Wright County, Minnesota.
- 2. Motorized watercraft use by agents of the Commissioner of the Department of Natural Resources (DNR), the United States Fish and Wildlife Service or local law enforcement agencies are authorized in the closed zone as described in #1 and #4 respectively except that airboats used during non emergency situations by agencies other than DNR must be authorized by a special permit from its Director of the Division of Fish and Wildlife.
- 3. Special permits may be issued by the DNR to riparian resident landowners and their immediate family members or tenants to operate motorized watercraft in the closed zone.
- 4. Within the closed zone described in #1, all motorized watercraft are only permitted to operate within a perimeter surface area that extends 100 feet lakeward from the shoreline or shoreline emergent vegetation in a manner and speed that does not create a wake.
