Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Proposed Rules

Comments on Planned Rules or Rule Amendments. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, and within 60 days of the effective date of any new statutory grant of required rulemaking.

Rules to be Adopted After a Hearing. After receiving comments and deciding to hold a public hearing on the rule, an agency drafts its rule. It then publishes its rules with a notice of hearing. All persons wishing to make a statement must register at the hearing. Anyone who wishes to submit written comments may do so at the hearing, or within five working days of the close of the hearing. Administrative law judges may, during the hearing, extend the period for receiving comments up to 20 calendar days. For five business days after the submission period the agency and interested persons may respond to any new information submitted during the written submission period and the record then is closed. The administrative law judge prepares a report within 30 days, stating findings of fact, conclusions and recommendations. After receiving the report, the agency decides whether to adopt, withdraw or modify the proposed rule based on consideration of the comments made during the rule hearing procedure and the report of the administrative law judge. The agency must wait five days after receiving the report before taking any action.

Rules to be Adopted Without a Hearing. Pursuant to *Minnesota Statutes* § 14.22, an agency may propose to adopt, amend, suspend or repeal rules without first holding a public hearing. An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public. The agency then publishes a notice of intent to adopt rules without a public hearing, together with the proposed rules, in the *State Register*. If, during the 30-day comment period, 25 or more persons submit to the agency a written request for a hearing of the proposed rules, the agency must proceed under the provisions of §§ 14.14-14.20, which state that if an agency decides to hold a public hearing, it must publish a notice of intent in the *State Register*.

Proposed Expedited Permanent Rules Relating to Health Quality Measures NOTICE OF INTENT TO ADOPT EXPEDITED RULES WITHOUT A PUBLIC HEARING Proposed Expedited Amendments to Permanent Rules Relating to Health Care Quality Measures, *Minnesota Rules*, Chapter 4654

Introduction. The Department of Health intends to adopt rules under the expedited rulemaking process following the rules of the Office of Administrative Hearings, *Minnesota Rules*, part 1400.2410, and the Administrative Procedure Act, *Minnesota Statutes*, section 14.389. You may submit written comments on the proposed expedited rules until September 14, 2011.

Subject of Rules and Statutory Authority. The Minnesota Department of Health adopted *Minnesota Rules* Chapter 4654 in December 2009 and amended it in November 2010 to implement part of the comprehensive 2008 state health reform law. Consistent with *Minnesota Statutes* 62U.02, these rules established a standardized set of quality measures that the Department will use to assess the quality of services offered by health care providers. These measures include the specific details for the data physician clinics and hospitals must submit to the Minnesota Department of Health or to the Commissioner's designee for public reporting. The rules also specify:

- · requirements for physician clinics and hospitals to submit quality data to the Minnesota Department of Health or its designee;
- · obligations for physician clinics and hospitals to cooperate with data validation procedures;
- a restriction on health plans prohibiting them from requiring providers to use and report data on quality measures not included in the standardized set; and
- annual review by the Minnesota Department of Health of existing quality measures and evaluation and adoption of new measures into the standardized set.

The Commissioner is required to review the adopted quality measures annually and propose any additions, deletions, or modifications by August 15 through the expedited rulemaking process. Consequently, the Commissioner is proposing several amendments to the existing rules, including its appendices:

- · a technical clarification to the definition of "ambulatory surgical center" in Part 4654.0200, Subpart 2a.
- an updated reference to the appendices incorporated into the rule by reference in Part 4654.0800.

Proposed Rules =

• additional data physician clinics and hospitals must submit related to both existing and new measures that this rulemaking will add to the rule, as well as modifications and clarifications to existing measures. These changes are part of the appendices to the rule, which may be found at: www.health.state.mn.us/healthreform/measurement/index.html

The statutory authority to adopt this rule is *Minnesota Statutes* §62U.02. The statutory authority to adopt this rule under the expedited rulemaking process is *Minnesota Statutes* §62U.06, subd. 3. Comments. You have until 4:30 p.m. on Wednesday, September 14, 2011, to submit written comment in support of or in opposition to the proposed expedited rules and any part or subpart of the rules. Your comment must be in writing and received by the agency contact person by the due date. The Department encourages comment. Your comment should identify the portion of the proposed expedited rules addressed and the reason for the comment. In addition, you are encouraged to propose any change desired. You must also make any comments about the legality of the proposed rules during this comment period.

Modifications. The Department may modify the proposed rules as a result of public comment. The modifications must be supported by comments and information submitted to the agency, and the adopted rules may not be substantially different than these proposed rules, unless the agency follows the procedure under *Minnesota Rules*, part 1400.2110. If the proposed rules affect you in any way, the Department encourages you to participate in the rulemaking process. The Department will publish any changes in the *State Register*.

Alternative Format. Upon request, this information can be made available in an alternative format, such as large print, Braille, or audio. To make such a request, please contact the agency contact person at the address or telephone number listed above.

Lobbyist Registration. *Minnesota Statutes*, chapter 10A, requires each lobbyist to register with the State Campaign Finance and Public Disclosure Board. Subject of Rules, Statutory Authority, and Agency Contact Person. The proposed rules are about the licensure requirements for teachers of Special Education. Summary of Proposed Rules. The Board of Teaching has purview over all teacher preparation and licensure requirements in Minnesota. The proposed rules reflect the work of the Board of Teaching and its stakeholders in developing new and revised licensure requirements for teachers of Special Education. The Board has been working steadily since 2008 with stakeholders to develop the proposed rules; the proposed rules include revisions to ten existing licensure fields and the establishment of two new licensure fields, as shown in the table below. The Board is also seeking a technical correction in the effective date of the proposed rules, from September 1, 2012, to January 1, 2013.

As noted, the Board has relied heavily on stakeholder input throughout this process. A description of the processes, stakeholder engagement, and the resulting recommendations for rule changes is available in the Rule-By-Rule Analysis portion of the SONAR.

NOTICE IS HEREBY GIVEN that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rule is *Minnesota Statutes*, sections 97A.311, 97A.401, 97A.411, 97A.465, 97A.535, 97B.111, 97B.301, 97B.305, and 97B.311.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that population data needed to establish quotas and classify deer areas are not available until June. New hunt conditions are provided for on a short-term basis and will be re-evaluated in three years. Disabled and special hunt areas open or closed to hunting are not established until harvest and population data are evaluated in May and June. Other changes in are being made to simplify regulations, improve deer harvest and manage diseases.

6232.0200 DEFINITIONS.

- Subp. 4a. **Deer permit area.** "Deer permit area" means an area of the state consisting of one or more deer registration blocks. Deer permit areas open for taking legal bucks and antlerless deer during the regular firearms deer season are defined as follows:
- A. "intensive deer permit area" means a deer permit area where taking deer of either sex is authorized by a regular firearms license and where multiple bonus permits are authorized;
- B. "managed deer permit area" means a deer permit area where taking deer of either sex is authorized by a regular firearms license and where bonus permits are authorized; and
- C. "lottery deer permit area" means a deer permit area where taking legal bucks is authorized by a regular firearms license and taking antlerless deer is authorized by an either-sex permit. Either-sex deer may be taken by archery deer hunters in a lottery deer permit area; and
 - D. "hunter choice deer permit area" means a deer permit area where taking a single deer of either sex is authorized.

- Subp. 12. **Either-sex permit.** "Either-sex permit" is a permit obtained according to part 6232.1800 that allows taking an either-sex deer during the firearm or muzzleloader season provided the applicant possesses a license for that season.

6232.0300 GENERAL RESTRICTIONS FOR TAKING DEER.

- Subpart 1. **Season options.** A firearm deer hunter may purchase a firearm license valid for the regular firearms deer season or a youth firearms license. A muzzleloader deer hunter may purchase a muzzleloader license valid for the muzzleloader season or a youth muzzleloader license. For the regular firearm season, a hunter must select either the A or B season and this option will be printed on the license at the time of purchase. A person may only hunt deer by firearms within the season option indicated on the person's firearm license, except:
 - A. as prescribed in part 6232.1970, subpart 2; and
 - B. a firearm license for any season option is valid in:
 - (1) the Metropolitan Deer Management Zone under part 6232.4700, subpart 158;
 - (2) deer permit areas open for early antlerless hunting; and
 - (3) (2) the special bovine tuberculosis area (deer permit area 101):; and
 - (3) the special chronic wasting disease area (deer permit area 602); and
 - C. youth firearm license holders may hunt deer in both the statewide A and late southeast B seasons.

Subp. 3. Party hunting.

<u>A.</u> A party is a group of two or more licensed deer hunters who are afield hunting together and are all using firearms or all using archery equipment. A member of a party may kill a <u>legal buck or antlerless</u> deer for another member of the party who has an unused tag valid for that deer, except as provided by:

- (1) as provided by Minnesota Statutes, section 97B.301:; and
- (2) in 300 series deer permit areas as prescribed in part 6232.1300, subpart 3, where unused tags may be used only on antlerless deer.
- B. A mixed-weapons group is considered two separate parties. Multizone buck licensees may party hunt with regular firearms licensees.
- <u>C.</u> Persons issued permits under *Minnesota Statutes*, section 97B.055, subdivision 3, who are hunting in a lottery deer permit area and do not have an either-sex permit may not tag antlerless deer for another member of the party.

Subp. 8. **Bag limit.** A person may not tag more than one legal buck per calendar year using any combination of licenses. A person may not tag more than one deer during a license year by any method, except as authorized in items A to HI.

 - (3) the total aggregate bag limit for intensive deer permit areas is five deer; and

6232.0350 SPECIAL RESTRICTIONS FOR TAKING DEER; 300 SERIES DEER PERMIT AREAS.

Notwithstanding part 6232.0200, subpart 6, in all 300 series deer permit areas, "legal buck" means a deer with a minimum of four antler points on at least one antler. Bucks with fewer antler points than the minimum defined points are protected and not legal for harvest. Youth hunters age ten to 17 are exempt from this part.

6232.0400 REGISTRATION OF DEER.

Subp. 6. Deer taken in the special chronic wasting disease area.

- A. Deer taken in the special chronic wasting disease area (deer permit area 602) must be presented for mandatory chronic wasting disease testing. - H. Portions of the city of Canby are open September 17 to December 31 for taking antlerless deer and legal bucks in an earn-a-buck hunt. No more than 20 permits shall be issued by the city of Canby. The bag limit is two deer.
- I. Crow-Hassan Park Reserve in Hennepin County is open November 11 to 13 for taking antlerless deer and legal bucks. No more than 130 permits shall be issued. The bag limit is five deer.
- J. Murphy-Hanrehan Park Reserve in Scott County is open November 11 to 13 for taking antlerless deer and legal bucks. No more than 90 permits shall be issued. The bag limit is five deer.
- K. Cleary Lake Regional Park in Scott County is open November 11 to 13 for taking antlerless deer and legal bucks. No more than 55 permits shall be issued. The bag limit is five deer.
- L. Portions of the city of Red Wing are open September 17 to December 31 for taking antlerless deer and legal bucks. The bag limit is five deer.
- M. Portions of the city of Sandstone are open September 17 to December 31 for taking antlerless deer and legal bucks by special permit from the city of Sandstone. The bag limit is five deer.
- N. Portions of the city of Rochester are open September 17 to December 31 for taking antlerless deer and legal bucks. The bag limit is five deer.
- O. Portions of the city of Duluth are open September 17 to December 31 for an earn-a-buck hunt. Party hunting is not allowed for antlered bucks. The bag limit is five deer.

- S. The Bemidji Regional Airport is open September 17 to December 31 for taking antlerless deer and legal bucks in an earn-a-buck hunt. No more than 30 permits shall be issued by the city of Bemidji. The bag limit is five deer.
- T. Greenleaf State Recreation Area in Meeker County is open September 17 to December 31 for taking antlerless deer and legal bucks. The bag limit is one deer.
- <u>U. Kellogg Weaver Dunes Scientific and Natural Area in Wabasha County is open September 17 to December 31 for taking antlerless deer only. No more than ten permits shall be issued. The bag limit is five deer.</u>

All deer taken at the park must be registered at St. Croix State Park and presented for inspection on the day of harvest. The bag limit is two deer. This is special hunt area 902.
- D. Portions of Savanna Portage State Park in Aitkin County are open from November 12 to 16 for taking antlerless deer and legal bucks. Areas specified on maps provided by the park manager are open for hunting. For purposes of this hunt, "legal buck" means a male deer with a minimum of three antler points on at least one antler, notwithstanding part 6232.0200, subpart 6. No more than 15 permits shall be issued to individuals authorized to hunt the statewide A season. All harvested deer must be registered at Savanna Portage State Park and presented for inspection. The bag limit is one either-sex deer. This is special hunt area 903.

- E. Gooseberry Falls State Park in Lake County is open north and west of U.S. Highway 61 from November 5 to 20 for taking antlerless deer and legal bucks. - N. Lake Carlos State Park in Douglas County is open November 5 to 8 for taking antlerless deer only. No more than 20 permits shall be issued to individuals authorized to hunt the statewide A season. The bag limit is two deer. This is special hunt area 913.
- O. William O'Brien State Park in Washington County is open November 5 and 6 for taking antlerless deer and legal bucks. The park is open only to individuals with a special hunt permit. No more than 70 permits shall be issued to individuals authorized to hunt the statewide A season. The bag limit is five deer. All hunters must attend a mandatory orientation on October 27. This is special hunt area 914.
- P. Lake Bronson State Park in Kittson County is open November 5 to 13 for taking antlerless deer and legal bucks. No more than 30 permits shall be issued to individuals authorized to hunt the statewide A season. The bag limit is one either-sex deer. This is special hunt area 915.
- Q. Maplewood State Park in Otter Tail County is open November 5 to 8 for taking antlerless deer and legal bucks. No more than 100 permits shall be issued to individuals authorized to hunt the statewide A season. The bag limit is two deer. This is special hunt area 916.
- R. Rydell National Wildlife Refuge in Polk County is open November 5 to 13 for taking antlerless deer only. No more than five permits shall be issued to individuals authorized to hunt the statewide A season. The bag limit is one either-sex deer. This is special hunt area 917.
- S. Lake Alexander Scientific and Natural Area in Morrison County is open November 5 to 13 for taking antlerless deer and legal bucks. No more than 40 permits shall be issued to individuals licensed to hunt the statewide A season. The bag limit is five deer. This is special hunt area 918.

After the emergency amendments expire, the permanent rules as they read prior to these amendments again take effect, except as they may be amended by permanent rule. *Minnesota Rules*, part 6232.0350, expires December 31, 2011.

Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders. as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

Emergency Executive Order 11-24: Declaring an Emergency and Providing Assistance for Search and Rescue

I, MARK DAYTON, GOVERNOR OF THE STATE OF MINNESOTA, by virtue of the authority vested in me by the Constitution and applicable statutes, including *Minnesota Statutes* 2010, Chapter 12, do hereby issue this Emergency Executive Order:

WHEREAS, on Tuesday, August 2, 2011, a 13 year-old boy dove into the water at a popular swimming area called "The Deeps" within the Lester River Basin and was pulled under and swept away by the raging waters; and

WHEREAS, the Lester River at the time of the incident was especially high and fast due to the heavy rains in the area; and

WHEREAS, the St. Louis County Sheriff has conducted search and rescue operations with assistance from the surrounding counties, Douglas County, Wisconsin, and the United States Coast Guard; and

WHEREAS, the St. Louis County Sheriff has requested the use of the Minnesota National Guard to support the search and rescue operation along the Lester River;

NOW, THEREFORE, I hereby declare an emergency and order that:

- 1. On or about August 6, 2011, the Adjutant General of Minnesota shall order to state active duty, in the service of the state, such personnel and equipment of the military forces of the state as required to provide assistance in responding to the emergency and in providing emergency relief services.
- 2. The Adjutant General is authorized to purchase, lease, or contract for goods and services necessary to accomplish the mission.
- 3. The cost of subsistence, transportation, fuel, pay, and allowances of said individuals shall be paid, as provided for in *Minnesota Statutes*, sections 192.49, 192.52, and 192.54.

Pursuant to *Minnesota Statutes* section 4.035, subdivision 2, this Emergency Order is effective immediately and must be filed with the Secretary of State and published in the *State Register* as soon as possible after its issuance and will remain in effect until the conclusion of the emergency.
