## Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ## **Adopted Rules**

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

**KEY: Proposed Rules** - <u>Underlining</u> indicates additions to existing rule language. <u>Strikeouts</u> indicate deletions from existing rule language. ## **Board of Teaching**

### **Adopted Permanent Rules Relating to Special Education Teacher Standards**

The rules proposed and published at *State Register*, Volume 36, Number 4, pages 113-115, August 15, 2011 (36 SR 113), are adopted with the following modifications:

#### 8710.5000 CORE SKILLS FOR TEACHERS OF SPECIAL EDUCATION.

- Subp. 2. **Core skill areas.** A teacher of special education possesses understandings and skills in special education foundations: referral, evaluation, planning, and programming processes; instructional design, teaching, and ongoing evaluation; and collaboration and communication in items A to D.
- A. Foundational knowledge: A teacher of special education understands the foundations of special education, including information about students served by special education. The teacher must demonstrate knowledge of the:
- (9) medical terminology and educational implications of medical conditions, including the <u>provision effect</u> of medication and specialized health care in educational settings;
- (11) the importance and utility of parent involvement in student academic achievement, and the implications for the provision of educational services; and
- (12) legal, judicial, medical, and educational systems and their terminologies and implications in serving students with disabilities: and
- (13) roles and organizational structures of general and special education and the part they play in providing total services to all students.
- C. Instructional design, teaching, and ongoing evaluation: A teacher of special education understands how to provide and evaluate specially designed instruction to meet the unique needs of students in special education through individualized educational plans. The teacher must be able to:
- (2) lead individual education plan teams through statewide assessment options and to make appropriate decisions for a learner's participation within the statewide assessment system;
- Subp. 4. **Effective date.** The requirements in this part are effective September 1, 2012 January 1, 2013, for all applicants for licensure in areas or fields in special education.

#### 8710.5050 TEACHERS OF SPECIAL EDUCATION: ACADEMIC AND BEHAVIORAL STRATEGIST.

Subp. 5. **Effective date.** The requirements in this part for licensure as a teacher of special education: academic and behavioral strategist are effective September 1, 2012 January 1, 2013, and thereafter.

#### 8710.5100 TEACHERS OF SPECIAL EDUCATION: BLIND OR VISUALLY IMPAIRED.

Subp. 5. Effective date. Requirements in this part for licensure as a teacher of special education: blind or visually impaired are effective

on September 1, 2012 January 1, 2013, and thereafter.

#### 8710.5200 TEACHERS OF SPECIAL EDUCATION: DEAF OR HARD OF HEARING.

- Subp. 2. **License requirements.** A candidate for licensure to teach, from birth through age 21, infants, children, and youth who are deaf or hard of hearing shall:
- E. demonstrate proficiency in American Sign Language communication fluency commensurate with an Intermediate-Plus level of American Sign Language proficiency on the Sign Language Proficiency Interview (SLPI) or a comparable American Sign Language evaluation jointly approved by the Board of Teaching and commissioner of education in consultation with the Minnesota Association of Deaf Citizens and the Commission of Deaf, DeafBlind, and Hard of Hearing Minnesotans, in accordance with Minnesota Statutes, section 122A.28, subdivision 1.
- Subp. 3. **Subject matter standard.** A candidate for licensure as a teacher of special education: deaf or hard of hearing must complete a preparation program under subpart 2, item D, that must include the candidate's demonstration of the knowledge and skills in items A to F
- B. Communication systems. A teacher of special education: deaf or hard of hearing demonstrates knowledge of communication systems used by infants, children, and youth who are deaf, hard of hearing, deaf-blind, and those with additional disabilities coexisting with hearing loss. The teacher must demonstrate knowledge of:
  - (4) understand theories of linguistics, including linguistics of American Sign Language and English.
- E. Collaboration and communication. A teacher of special education: deaf or hard of hearing cultivates and maintains positive, collaborative relationships with students, families, other professionals, and the community to support student development and educational progress. The teacher must be able to:
- (4) <u>identify</u> sources of unique services, networks, agencies, and organizations for individuals who are deaf or hard of hearing. <u>deaf-blind</u>, those with additional disabilities coexisting with hearing loss, and those from diverse cultural and language backgrounds;
- Subp. 6. **Effective date.** Requirements in this part for licensure as a teacher of special education: deaf or hard of hearing are effective on September 1, 2012 January 1, 2013, and thereafter.

#### 8710.5250 TEACHERS OF SPECIAL EDUCATION: ORAL/AURAL DEAF EDUCATION.

Subp. 5. **Effective date.** All requirements in this part for licensure as a teacher of special education: oral/aural deaf education are effective on September 1, 2012 January 1, 2013, and thereafter.

#### 8710.5300 TEACHERS OF SPECIAL EDUCATION: DEVELOPMENTAL ADAPTED PHYSICAL EDUCATION.

- Subp. 3. **Subject matter standard.** A candidate for licensure as a teacher of special education: developmental adapted physical education must complete a preparation program under subpart 2, item D, that must include the candidate's demonstration of the knowledge and skills in items A to E.
- A. Foundational knowledge. A teacher of special education: developmental adapted physical education understands the foundations of special education services for students with disabilities relating to physical and motor fitness on which to base practice. The teacher must demonstrate knowledge of the:
  - (6) (7) impact of single, multiple, coexisting conditions or disabilities on motor functioning and motor skill acquisition; and
- (7) (8) impact of typical and atypical motor development and function on the educational, social, and psychological well-being of students.
- Subp. 5. **Effective date.** Requirements in this part for licensure as a teacher of special education: developmental adapted physical education are effective on September 1, 2012 January 1, 2013, and thereafter.

## - Adopted Rules

#### 8710.5400 TEACHERS OF SPECIAL EDUCATION: DEVELOPMENTAL DISABILITIES.

- Subp. 3. **Subject matter standard.** A candidate for licensure as a teacher of special education: developmental disabilities must complete a preparation program under subpart 2, item D, that must include the candidate's demonstration of the knowledge and skills in items A to E.
- B. Referral, evaluation, planning, and programming. A teacher of special education: developmental disabilities understands and applies principles of prevention and intervening early and procedures for referral, assessment, evaluation, individualized planning, programming, and placement specific to teaching students with developmental disabilities. The teacher must be able to:
- (2) select, administer, and interpret assessments for students with developmental disabilities, accounting for technical adequacy, ethical concerns, and expressive and receptive communication needs, use of necessary assistive technologies, and communicate the results to students, families, educators, and other professionals;
- C. Instructional design, teaching, and ongoing evaluation. A teacher of special education: developmental disabilities understands how to use individualized education program plans to design, implement, monitor, and adjust instruction for students with developmental disabilities. The teacher must be able to:
- (2) apply evidence-based instructional strategies and practices, including functional, community-based instruction, task analysis, multisensory, and concrete or manipulative techniques, to <a href="mailto:promote\_facilitate">promote\_facilitate</a> acquisition of academic and functional skills in the least restrictive environment;
- D. Collaboration and communication. A teacher of special education: developmental disabilities cultivates and maintains positive, collaborative relationships with students, families, other professionals, and the community to support student development and educational progress. The teacher must be able to:
- (9) access and evaluate information, research, and emerging practices relevant to the field of developmental disabilities through consumer and professional organizations, peer-reviewed journals, and other publications; and
- (10) engage in continuing professional development and reflection to increase knowledge and skill as a special educator and inform instructional practices, decisions, and interactions with students and their families: and
- (11) promote peer acceptance, social participation, and achievement by training, coaching, supporting, structuring, and modeling evidence-based strategies for developmental disabilities to peers, parents, paraprofessionals, and other school staff.
- Subp. 5. **Effective date.** Requirements in this part for licensure as a teacher of special education: developmental disabilities are effective on September 1, 2012 January 1, 2013, and thereafter.

## **Exempt Rules**

  - (4) make changes that do not alter the sense, meaning, or effect of the rules.

These exempt rules are also reviewed for form by the Revisor of Statutes, for legality by the Office of Administrative Hearings and then published in the State Register. In addition, the Office of Administrative Hearings must determine whether the agency has provided adequate justification for the use of this exemption. Rules adopted under clauses (1) or (2) above are effective for two years only. The Legislature may also exempt an agency from the normal rulemaking procedures and establish other procedural and substantive requirements unique to that exemption.

**NOTICE IS HEREBY GIVEN** that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rules is *Minnesota Statutes*, sections 97A.045, subd. 2, 97C.005, and 97C.401.

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that under the terms of the Federal District Court the Mille Lacs Band, Fond Du Lac Band, and six Wisconsin Bands of Chippewa are not required to declare their harvest intentions on inland waters until mid-March. The Mille Lacs proposed regulations are based on a safe harvest level determined for 2012. Final harvest threshold levels to be included in the proposed rules were not available until March. Regulations to stay within the threshold were not able to be calculated until two weeks after the season opener. These new threshold levels and regulations need to be put in place as soon as possible to ensure that angler harvest does not exceed State angler harvest thresholds for the 2012 open water fishing season.

## Notice of Proposed Determinations Regarding the Occurrence of Chlorpyrifos in Surface Waters of Minnesota

**NOTICE IS HEREBY GIVEN** that the Commissioner (Commissioner) of the Minnesota Department of Agriculture (MDA) has determined that the insecticide chlorpyrifos is a surface water "Pesticide of Concern" in accordance with the state Pesticide Management Plan (PMP). With this notice, the MDA seeks initial comment on a proposed action by the Commissioner to direct MDA staff to develop and promote voluntary Best Management Practices (BMPs) to protect surface water from the impacts of the insecticide chlorpyrifos.

The Commissioner has statutory responsibility and authority to: "determine the impact of pesticides on the environment, including the impacts on surface water and groundwater" (*Minnesota Statutes* § 18B.04 subd. 1); to "develop best management practices involving pesticide...use" (*Minnesota Statutes* § 18B.04 subd. 2); and to ensure that pesticide use "will not cause unreasonable adverse effects on the environment" (*Minnesota Statutes* § 18B.07 subds. 1 & 2).

In fulfillment of these responsibilities, the Commissioner has reviewed recent surface water and groundwater monitoring data for the occurrences of pesticides and pesticide degradates in Minnesota, and proposes to develop and promote BMPs to prevent and minimize the potential for surface water resource degradation by chlorpyrifos based on the following:

MDA monitoring results from 2005 through most of 2011 indicate chlorpyrifos detections in several state watersheds, accompanied by multiple concentrations that exceed or approach the Minnesota Pollution Control Agency (MPCA) chronic or acute water quality standards for chlorpyrifos.

Following consultation with the multi-stakeholder MDA Pesticide Management Plan Committee, and an MPCA decision to include Seven-Mile Creek (Nicollet County) on the draft 2012 list of impaired waters for violating the MPCA's acute 1-day aquatic life exposure standard for chlorpyrifos, the Commissioner has determined that voluntary BMPs are needed to minimize observed chlorpyrifos impacts in all affected watersheds.

Because chlorpyrifos concentrations in Seven-Mile Creek exceed the MPCA's regulatory acute surface water standard, an analysis may be conducted to determine an allowable amount (or Total Maximum Daily Load allocation) of chlorpyrifos that can be generated from all sources within the watershed while still maintaining water quality and designated uses of the water body.

Chlorpyrifos is used to control a number of important agronomic insect pests in crop production systems throughout Minnesota. The EPA is currently reviewing the registration status of all agricultural uses. Chlorpyrifos water quality impacts from homeowners have largely been addressed by the U.S. Environmental Protection Agency (EPA) through cancellations of non-agricultural chlorpyrifos products.

The Commissioner has previously determined that two corn herbicides are surface water "Pesticides of Concern." The MDA developed voluntary, pesticide-specific BMPs to protect water resources from these pesticides and, with the cooperation of stakeholders, currently promotes and evaluates BMP adoption and effectiveness through a variety of methods.

REQUEST FOR COMMENTS on Possible Amendment to Rules Governing Vending Stands and Business Enterprises- Services for the Blind, *Minnesota Rules*, 3321.0100 to 3321.1400

**Subject of Rules.** The Minnesota Department of Employment and Economic Development requests comments on its possible amendment to and repeal of rules governing vending stands and business enterprises (the "Business Enterprises Program"), an activity of the Division of State Services for the Blind. The department is considering rule amendments and repealing some rule parts. The rules were last amended in 1990. The department is interested in removing and updating archaic language; clarifying terms and processes; ensuring consistent use of terminology; modifying rule format; and considering policy changes. Comments on other areas of the current rule are welcome but will only be considered for this rule revision as the agency has time.

**Persons Affected.** The amendment to and repeal of rules would only affect: legally blind, eligible individuals receiving vocational rehabilitation services from State Services for the Blind who have applied to the Business Enterprises Program; and current licensed blind vendors operating vending stands and business enterprises in the Business Enterprises Program. The latter group is significantly affected.

**Statutory Authority.** *Minnesota Statutes*, section 248.07, subd. 14a, requires the department to adopt rules to set standards for the provision of rehabilitation services, including program definitions; basic eligibility; financial need; definition of legal blindness; formal rehabilitation plans; placement in training programs; tools and equipment; and for appeals including timely agency response.

**Public Comment.** Interested persons or groups may submit comments or information on these possible rules in writing until 4:30 p.m. on May 25, 2012. The department does plan to appoint an advisory committee to comment on the possible rules. The advisory committee will consist of the Operator Management Committee, an elected body representing all current licensed blind vendors operating vending stands and business enterprises in the Business Enterprises Program. The Operator Management Committee is constituted pursuant to Code of Federal Regulations, title 34, section 395.14, to, among other duties, "...actively participate with the State licensing agency in major administrative decisions and policy and program development decisions affecting the overall administration of the State's vending facility program." The advisory committee is expected to commence and finish its work in June, 2012.

**NOTICE IS HEREBY GIVEN**, that the Commissioner of the Minnesota Pollution Control Agency (MPCA) has determined that a State Implementation Plan (SIP) revision must be submitted to meet Minnesota's requirements under Section 110(a) and Section 172 of the Clean Air Act with regards to the National Ambient Air Quality Standards (NAAQS) for lead (40 CFR 50.16). The draft SIP Revision is now available for public comment.

**Background.** The United States Environmental Protection Agency (EPA) has promulgated a NAAQS for lead of 0.15 μg/m³. On November 22, 2010, the EPA designated a portion of Dakota County bounded by: Lone Oak Rd. (County Rd. 26) to the north, County Rd. 63 to the east, Wescott Rd. to the south, and Lexington Ave. (County Rd. 43) to the west as being in nonattainment with the NAAQS for lead (75 FR 71033). The main source of lead in this area is Gopher Resource, LLC.

**Purpose of the SIP Revision.** This SIP revision contains both the required infrastructure and nonattainment plans for lead. The infrastructure portion of the SIP demonstrates that the MPCA has the ability to implement and enforce measures to ensure that the NAAQS is maintained in areas where air quality already meets the standards. The nonattainment plan portion contains information showing how the nonattainment area will be brought into attainment with the standard. The nonattainment plan includes new requirements for Gopher Resource, LLC, that are included in an Administrative Order (Order) that will be issued to the facility, and modeling to demonstrate that these conditions will allow the area to attain the NAAQS. The MPCA will be formally requesting that the U.S. Environmental Protection Agency (EPA) amend Minnesota's SIP to include the new conditions in this Order.

The MPCA will consider changing the contents of the proposed SIP revision based on comments received during the comment period. Following the end of the comment period, the Commissioner will decided whether to submit the proposed SIP revision to the EPA unless, as provided by *Minnesota Statutes* 116.02, the MPCA Citizens' Board makes this decision.

The Minnesota Pollution Control Agency (MPCA) is requesting comments on the draft Greater Blue Earth River Basin Turbidity Total Maximum Daily Load (TMDL). The draft Turbidity TMDL Report for the Greater Blue Earth River Basin is available for review at <a href="http://www.pca.state.mn.us/water/tmdl.html#drafttmdl">http://www.pca.state.mn.us/water/tmdl.html#drafttmdl</a>.

Following the comments, the MPCA will revise the draft TMDL Report and submit it to the Environmental Protection Agency (EPA) for approval. Comments must be sent to the MPCA contact person listed below by 4:30pm on May 29, 2012.

Required by the federal Clean Water Act, a TMDL is a scientific study that calculates the maximum amount of a pollutant that a waterbody can receive and still meet water quality standards for that pollutant. It is a process that identifies sources of the pollutant causing an impairment and allocates necessary reductions among them. This multi-year effort results in a pollution reduction plan and engages stakeholders and the general public. An approved TMDL is followed by implementation activities for achieving the necessary reductions.

This TMDL study covers 39 reaches within the Greater Blue Earth River Basin area that are currently listed for aquatic life impairments due to turbidity. Turbidity is a measure of the water's clarity and is caused by the amount of particles in the water, such as sediment. Higher turbidity reduces the penetration of sunlight in the water and can harm aquatic life.

The Greater Blue Earth River Basin is comprised of three major watersheds; the Le Sueur, the Watonwan, and the Blue Earth, with a total land area of 3,540 square miles. Contained within the watershed are approximately 3,384 miles of streams and rivers. The Greater Blue Earth's watersheds have been the subject of numerous studies, research efforts, and water quality improvement projects due to the disproportionately high levels of sediment and nutrients they supply to the Minnesota River.

A draft TMDL Report and fact sheet are available for review at the MPCA office at the address listed below, and at the MPCA website: <a href="http://www.pca.state.mn.us/water/tmdl.html#drafttmdl">http://www.pca.state.mn.us/water/tmdl.html#drafttmdl</a>. Suggested changes will be considered before the final TMDL Report is sent to the EPA for approval.

**Written Comments:** You may submit written comments on the conditions of the draft TMDL Report or on the Commissioner's preliminary determination.

Written comments must include the following:

- 1. A statement of your interest in the draft TMDL Report;
- 2. A statement of the action you wish the MPCA to take, including specific references to sections of the draft TMDL that you believe should be changed; and
- 3. The reasons supporting your position, stated with sufficient specificity as to allow the Commissioner to investigate the merits of your position.

**Petition for Public Informational Meeting:** You also may request that the MPCA Commissioner hold a public informational meeting. A public informational meeting is an informal meeting that the MPCA may hold to solicit public comment and statements on matters before the MPCA, and to help clarify and resolve issues.

A petition requesting a public informational meeting must include the following information:

- 1. A statement identifying the matter of concern;
- 2. The information required under items 1 through 3 of "Written Comments," identified above;
- 3. A statement of the reasons the MPCA should hold a public informational meeting; and
- 4. The issues that you would like the MPCA to address at the public informational meeting.

**Petition for Contested Case Hearing:** You also may submit a petition for a contested case hearing. A contested case hearing is a formal evidentiary hearing before an administrative law judge. In accordance with *Minnesota Rules* 7000.1900, the MPCA will grant a petition to hold a contested case hearing if it finds that: (1) there is a material issue of fact in dispute concerning the application or draft TMDL Report; (2) the MPCA has the jurisdiction to make a determination on the disputed material issue of fact; and (3) there is a reasonable basis underlying the disputed material issue of fact or facts such that the holding of the contested case hearing would allow the introduction of information that would aid the MPCA in resolving the disputed facts in making a final decision on the draft TMDL Report. A material issue of fact means a fact question, as distinguished from a policy question, whose resolution could have a direct bearing on a final MPCA decision.

A petition for a contested case hearing must include the following information:

- 1. A statement of reasons or proposed findings supporting the MPCA decision to hold a contested case hearing according to the criteria in *Minnesota Rules* 7000.1900, as discussed above; and
- 2. A statement of the issues proposed to be addressed by a contested case hearing and the specific relief requested or resolution of the matter.

In addition and to the extent known, a petition for a contested case hearing should also include the following information:

- 1. A proposed list of prospective witnesses to be called, including experts, with a brief description of proposed testimony or summary of evidence to be presented at a contested case hearing;
- 2. A proposed list of publications, references, or studies to be introduced and relied upon at a contested case hearing; and
- 3. An estimate of time required for you to present the matter at a contested case hearing.

MPCA Decision: You may submit a petition to the Commissioner requesting that the MPCA Citizens' Board consider the TDML Report approval. To be considered timely, the petition must be received by the MPCA by 4:30 p.m. on the date the public comment period ends, identified on page 1 of this notice. Under the provisions of *Minnesota Statutes* § 116.02, subd 6(4), the decision whether to submit the TMDL Report and, if so, under what terms will be presented to the Board for decision if: (1) the Commissioner grants the petition requesting the matter be presented to the Board; (2) one or more Board members request to hear the matter before the time the Commissioner makes a final decision on the TMDL Report; or (3) a timely request for a contested case hearing is pending. You may participate in the activities of the MPCA Board as provided in Minn. R. 7000.0650.

The written comments, requests, and petitions submitted on or before the last day of the public comment period will be considered in the final decision on this TMDL Report. If the MPCA does not receive written comments, requests, or petitions during the public comment period, MPCA staff as authorized by the Board, will make the final decision on the draft TMDL Report.

**Deferred Loan Funds** are generally in the form of a zero (0) percent, 30 year deferred or subordinate loan, forgivable loan or grant. Actual interest rate, term and type of loan or grant will vary depending upon recommended funding source (s) and will be discussed with sponsors/applicants upon selection for funding.

Long term fixed rate mortgages for acquisition, refinance, or new construction of multifamily housing for developments that generate adequate income to service debt are also available. These mortgages are offered through the LMIR program. First mortgages may be used in conjunction with housing tax credits for new construction or acquisition/rehabilitation.

**Operating Subsidies** are available through the Department of Human Service's Housing with Supports for Adults with Serious Mental Illness fund. Operating subsidies are awarded in the form of a grant to the owner and may be awarded for a term of up to two years.

Section 8 Project-Based Voucher (PBV) Rental Assistance. The Saint Paul Public Housing Agency offers the availability of federal rent subsidy. The PBV program is a HUD Section 8 housing subsidy program that ties rental assistance directly to a specific unit or project. To be eligible, projects must be located in the city of St. Paul.

#### Eligible Applicants, Projects, and Activities:

Eligible applicants for the majority of resources include Minnesota cities, city and county Housing and Redevelopment Authorities, other public bodies authorized to act under *Minnesota Statutes*, chapter 462C, limited dividend entities, for-profit organizations, nonprofit organizations, private developers, corporations, partnerships, natural persons, Indian tribes or tribal housing corporations, public housing agencies, joint powers boards established by two or more cities, and cooperative housing corporations.

Funding sources available for capital funding can be used for a variety of activities and housing types. Eligible projects must contain a minimum of four units. Scattered site developments must be located in the same city or county and contain a minimum of four units. Eligible activities include new construction, acquisition of land or existing structures, rehabilitation of housing, refinancing of existing loans, preservation of federally assisted housing, conversion to housing from another use, demolition, construction financing, permanent financing. Eligible housing types include emergency shelters, transitional housing, permanent supportive housing, service-enriched housing, and permanent affordable housing. Section 8 PBV Rental assistance and operating subsidies are eligible activities, however funding is limited.

Housing Infrastructure Bond Proceeds may be available to address affordable housing needs in communities throughout the state. If available, funds for multi-family activities will be used to:

- o Preserve existing federally subsidized rental housing
- o Stabilize communities impacted by the foreclosure crisis by creating new affordable housing opportunities through the construction or acquisition and rehabilitation of rental units, and
- Construct or acquire and rehabilitate supportive housing, particularly for persons experiencing or at risk of experiencing longterm homelessness.

Housing Infrastructure bond proceeds will be used to rehabilitate, stabilize or construct privately owned affordable housing. Housing must be affordable to and occupied by low-and moderate income households. Funding will be provided to the extent that the property, due to occupants' low incomes, cannot support debt and no other resources are available. Priority will be given to projects that are ready to proceed, leverage non-state resources and demonstrate cost containment measures without compromising overall housing quality. Minnesota Housing is committed to using bond proceeds for competitive projects for each of the eligible activities. Affordability must be maintained for at least the term of the bonds (20 year).

## State Grants & Loans=

Minnesota Housing has funding priorities for certain developments (e.g. housing in which all or a portion of units will be targeted to households experiencing long-term homelessness, workforce housing in areas of job and population growth).

Developments with age restrictions of 55 and older are not a funding priority under most funding sources. In addition, nursing homes, board and care facilities, and supervised living facilities licensed by the Minnesota or a delegated local Department of Health are not eligible for funding, nor are properties where residents require a 24-hour plan for supervision and/or medical/health care.

#### **Income and Rent Limits:**

The overall goal of the RFP process is to serve low to moderate income households. Priority will generally be given to those developments serving the lowest income households. The relationship between proposed rent levels and Fair Market Rents/Payment Standards is an important factor because it is crucial that Section 8 voucher holders are able to rent units in Minnesota Housing financed developments. For individual program rent and income limits, refer to the Multifamily Consolidated Request for Proposal Guide on the Minnesota Housing website.

#### 2013 HOUSING TAX CREDIT PROGRAM (HTC)

Minnesota Housing is accepting 2013 Round 1competition applications for reservation and allocation of 2013 Housing Tax Credits, authorized by the Federal Tax Reform Act of 1986, as revised. Housing Tax Credits offer a ten-year reduction in tax liability to owners and investors in eligible low-income rental housing developments involving new construction, rehabilitation, or acquisition with rehabilitation. Total estimated 2013 tax credits available for the State of Minnesota is approximately \$11.6 million. #### 2013 PROGRAM, QAP, PROCEDURAL MANUAL AND SCORING CHANGES

As part of its annual revisions process, Minnesota Housing's 2013 Housing Tax Credit Program, Qualified Allocation Plan, Procedural Manual, Self-Scoring Worksheet and various related programmatic documents have been revised in several key respects. #### Credit Formula:

The Minnesota Legislature designated Minnesota Housing as the primary allocating agency for housing tax credits for the state and authorized eligible cities and counties to administer the tax credits in their respective jurisdictions based on the *Minnesota Statutes* Section 462A.222 and 462A.223.

#### Minnesota Housing Administration of Tax Credits:

In both tax credit rounds, applicants with eligible buildings in the balance of the state, not within the jurisdiction of a suballocator, may apply to Minnesota Housing for an allocation of housing tax credits.

Each year, 10 percent of the state ceiling is set aside by Minnesota Housing for allocation to nonprofit sponsored developments with a Section 501(c)(3) or 501(c)(4) status or appropriate designation approval by the IRS as required by Section 42(h)(5). Qualified nonprofit organizations can apply to Minnesota Housing for these credits, regardless of the geographic location of the proposed low income housing development, as specified in the Qualified Allocation Plan.
