Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Minnesota Pollution Control Agency (MPCA) Adopted Permanent Rules Relating to Water and Wastewater Treatment Certification

The rules proposed and published at *State Register*, Volume 36, Number 27, pages 835-839, January 23, 2012 (36 SR 835), are adopted with the following modifications:

9400.1500 CONDITIONAL CERTIFICATE.

Subpart 1. **Purpose and eligibility.** The purpose of the conditional certificate is to allow the current operator with direct responsibility of a system or facility time to gain necessary years of experience after passing all required examinations for the operator to achieve certification at the facility's higher class level. The operator of a system or facility that is reclassified to a higher class pursuant to part 9400.0600 may shall be issued a conditional certificate in the higher class that is effective for three years from the date of issue when the following conditions are met:

Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

Department of Natural Resources (DNR) Adopted Expedited Emergency Game and Fish Rules: Prohibited Invasive Species

Notice is hereby given that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13 (b). The statutory authority for the contents of the rules is *Minnesota Statutes*, section 84D.12

The emergency conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are that this action is part of an ongoing effort to prevent the spread of invasive species. Largescale silver carp, western mosquitofish, faucet snails, red swamp crayfish, and quagga mussels are being added to the list of prohibited invasive species and banded mystery snails are being added to the list of regulated invasive species. Adding species to the prohibited invasive species list will make the transport of these species illegal (M.S. 84D.05). A person may not introduce a regulated invasive species without a permit issued by the DNR (M.S. 84D.07). These species being added to the prohibited and regulated invasive species lists are currently classified as "unlisted nonnative species". Listing these invasive species will increase the state's authority to rapidly respond to situations involving the transportation and potential spread of invasive species to other water bodies.

Each of the species being added to the prohibited and regulated invasive species lists has unique ecological and economic impacts. As an example, Faucet Snail (*Bithynia tentaculata*) is an aquatic snail native to Europe and was introduced to the Great Lakes in the 1870s. The snail is host for three intestinal trematodes, or flukes, (*Sphaeridiotrema globulus*, *Cyathocotyle bushiensis*, *Leyogonimus polyoon*) that cause mortality in ducks and coots. Duck mortality has been recorded due to the intestinal parasites in Lake Winnibigoshish and Lake Pepin where faucet snail populations are established. On July 9, 2012, White Earth Nation and DNR responded to a report that faucet snails had been discovered in a container of leeches purchased at a bait shop. An investigation traced the source of the faucet snail to a series of small ponds used for leeching and duck hunting. Adding faucet snails and the other species to the prohibited invasive species list would make transport of these species illegal therefore helping to prevent the spread to uninfested waters.

Notice of Request for Public Comment on Proposed Budget for the Clean Water Fund

The Clean Water Council (Council) is seeking public comment on their proposed Clean Water Fund budget for the 2014-2015 biennium. The Council will make recommendations to the Governor and the Legislature in December. A public comment period begins September 4, and continues through September 28, 2012. The Council is specifically asking the public to comment on questions found online at:

www.pca.state.mn.us/cleanwatercouncil.

The Council needs to meet a \$185 million target for fiscal years 14-15 and wants public input on budget trimming ideas. The Council is also seeking comments on how to build the long-term capacity of local government agencies to improve their ability to implement water-quality practices.

Proposed budget recommendations are in these major categories:

- Monitoring and assessment programs (11-15% of total budget) continue steady funding levels to systematically determine the health of Minnesota's waters over 10 years, the first cycle of which ends in 2017.
- Watershed restoration and protection strategies (11-14%) continue steady funding levels for this program to determine the causes and solutions to pollution problems and threats, until strategies have been completed in all the state's 81 watersheds (about 10 years).
- Groundwater/drinking water protection (7-9%) increase funding over the minimum of five percent required by the
 constitutional amendment to protect groundwater and drinking water sources
- Point and non-point source implementation activities (57-60%) increase funding for on-the-ground activities that address runoff from fields and streets, as well as to improve infrastructure for sewage treatment and urban stormwater.
- Applied research and tool development (6-8%) steady funding to better target and ensure that implementation efforts are successful.

The Clean Water Council, created through the 2006 Clean Water Legacy Act, advises on the administration and implementation of the Clean Water Fund dollars that are to protect, enhance and restore our water resources. Approved by the voters in 2008, the Clean Water Fund is constitutionally-dedicated funding that is appropriated every two years by the Legislature. For more information contact Jeff
