

# Minnesota Rules: Amendments and Additions

## NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

**KEY: Proposed Rules** - Underlining indicates additions to existing rule language. ~~Strikeouts~~ indicate deletions from existing rule language. If a proposed rule is totally new, it is designated "all new material." **Adopted Rules** - Underlining indicates additions to proposed rule language. ~~Strikeout~~ indicates deletions from proposed rule language.

## Department of Natural Resources (DNR) Adopted Permanent Game and Fish Rules: Northern Pike and Border Waters

The rules proposed and published at *State Register*, Volume 37, Number 13, pages 444-448, September 24, 2012 (37 SR 444), are adopted with the following modifications:

### 6262.0575 WATERS WITH RESTRICTIONS ON TAKING FISH.

Subp. 8. **Annie Battle Lake including inlets and outlets.** While on or fishing in the following waters, ~~the daily and possession limit for sunfish is five and for black crappie is five. All black crappie in possession must be 11 inches or greater in length. All black crappie less than 11 inches in length must be immediately returned to the water.~~ angling for northern pike ~~and largemouth bass~~ is limited to catch and release only, whereby any northern pike ~~or largemouth bass~~ caught must be immediately returned to the water. Catch and release angling for northern pike ~~and largemouth bass~~ is legal during the open season for ~~these~~ this species in inland waters. It is unlawful for anyone to have in possession, regardless of where taken, any northern pike ~~or largemouth bass~~ while on or fishing in the following waters. A person may not possess a motorized ice auger or electronic fish finding devices while on or fishing in the following waters. Electronic fish finding devices include depth finders; fish finders; underwater videos or cameras; sonars; global positioning systems; and temperature, oxygen, and pH meters.

## Minnesota Department of Natural Resources (DNR) Cedar Rock Scientific and Natural Area Commissioner's Designation Order #232

**Date:** April 1, 2013  
**Statutory Authority:** *Minnesota Statutes* 84.033, 86A.05, Subd. 5, and 97A.093

### BACKGROUND

**WHEREAS**, certain lands in Redwood County, Minnesota, described as:

The Southeast Quarter of the Southwest Quarter, Section 3, Township 113, Range 36, Redwood County, Minnesota, except the east 70 feet thereof.

AND

That part of Government Lot 8, Section 3, Township 113, Range 36, Redwood County, Minnesota, described as follows: Beginning at the southwest corner of said Government Lot 8, thence on an assumed bearing of North along the west line of said Government Lot 8, a distance of 802.04 feet; thence South 87 degrees 08 minutes East, a distance of 1278.92 feet; thence North 00 degrees 33 minutes 30 seconds East, a distance of 527.01; thence easterly to the southwest corner of Government Lot 7 of said Section 3 and the east line of said Government Lot 8; thence southerly along said east line to the south line of said Government Lot 8; thence westerly along said south line to the point of beginning.

containing 62.0 acres, more or less, is under the control and possession of the Department of Natural Resources;

and

**WHEREAS**, such lands contain native plant communities, such as Crystalline Bedrock Outcrop (Prairie) – Minnesota River Subtype, Spikerush-Bur Reed Marsh (Prairie), Mesic Prairie (Southern), and Sedge Meadow; an amphibolite and granite gneiss rock outcrop; and potential habitat for rare plant and animal species, such as Carolina foxtail (*Alopecurus carolinianus*), water hyssop (*Bacopa rotundifolia*), mousetail (*Myosurus minimus*), plains prickly pear (*Opuntia macrorhiza*), tumblegrass (*Schedonnardus paniculatus*), and Ottoe skipper (*Hesperia ottoe*);

and

**WHEREAS**, the most effective means by which such lands can be protected and perpetuated in their natural state and used for educational and research purposes in such a manner as will leave them conserved for future generations is by designation as a Scientific and Natural Area;

### ORDER

**NOW, THEREFORE, IT IS HEREBY ORDERED**, pursuant to authority vested in me by law, including but not limited to *Minnesota Statutes*, sections 84.033; 86A.05, subd. 5; and 97A.093; that the above-described lands are designated as the Cedar Rock Scientific and Natural Area.

**FURTHERMORE**, the Cedar Rock Scientific and Natural Area is designated as a Public Use unit, open to the public for nature observation and general educational and research activities.

# Commissioner's Orders

**IT IS FURTHER ORDERED** that the provisions of *Minnesota Rules* 6136.0100 through 6136.0600 shall apply to the above-designated area, except that hunting, trapping, and dogs under control are allowed (with the condition that dogs are only allowed on leash from April 16 through July 14) with such limitations as the Commissioner determines are necessary for protection of the values for which the site was designated.

This order takes effect upon publication in the *State Register*.



The MPCA is interested in obtaining all available sulfate and wild rice water quality data. To ensure that your data are available for the 2013 assessment process, **please provide your data to MPCA by May 1, 2013** in accordance with the following instructions.

### How to submit sulfate data

To be included in the assessment, sulfate data must be uploaded to the state's Environmental Quality Information System (EQIS) prior to data analysis. All applicable, credible sulfate data must be submitted using the Sulfate Data Submittal Template which is accessible by clicking the assessment tab on this MPCA website <http://www.pca.state.mn.us/ktqh1083>. **Do not** include data that have been previously stored in the EQIS database under other projects. The Sulfate Data Submittal Template includes three worksheets: Instructions, Sulfate Data Submittal, and Location Establishment.
