# Minnesota Rules: Amendments and Additions

### NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # **Executive Orders**

The governor has the authority to issue written statements or orders, called Executive Orders. as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

### Office of the Governor Emergency Executive Order 13 - 05: Providing for Assistance to the Minnesota Interagency Fire Center

**I, MARK DAYTON, GOVERNOR OF THE STATE OF MINNESOTA**, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

WHEREAS, on Monday, May 13th, the Minnesota Interagency Fire Center (MIFC) was managing suppression of 25 wildfires, including a major uncontrolled fire exceeding 4,000 acres in the vicinity of Red Lake, Minnesota; and

WHEREAS, the National Weather Service has issued Red Flag Fire weather warnings for significant portions of northwest, west central and south central Minnesota due to high temperatures, low humidity, and strong winds and these conditions are expected to remain extreme for the next several days; and

WHEREAS, changing wind directions are making it difficult to predict what property and infrastructure may be threatened; and

**WHEREAS**, state agencies, the State Emergency Operations Center, the Minnesota Department of Natural Resources, and the MIFC do not have adequate aviation resources for widespread wildfire suppression; and

WHEREAS, the MIFC has requested fire suppression and support assets from the Minnesota National Guard.

NOW, THEREFORE, I hereby order that:

1. The Adjutant General of Minnesota order to state active duty on or about May 14<sup>th</sup>, 2013, in the service of the State, such personnel and equipment of the military forces of the State as required and for such period of time as necessary to support wildfire suppression in Minnesota; and

2. The Adjutant General is authorized to purchase, lease, or contract goods and services necessary to accomplish the mission; and

3. The cost of subsistence, transportation, fuel, pay, and allowances of said individuals shall be defrayed from the general fund of the State, as provided for in *Minnesota Statutes*, sections 192.49, 192.52, 192.54, and as otherwise permitted by law.

Pursuant to *Minnesota Statutes*, section 4.035, subdivision 2, this Emergency Order is effective immediately and will remain in effect until such date as elements of the military forces of the State are no longer required.

### **Department of Human Services (DHS)** Health Care Purchasing and Delivery Systems Division Health Care Administration Public Notice of Maximum Allowable Costs of Medical Assistance Outpatient

NOTICE IS HEREBY GIVEN to recipients, providers of services, and to the public of additions to the state Medical Assistance maximum allowable cost (state MAC) list for certain outpatient prescribed drugs.

At least once each calendar year, the United States Department of Health and Human Services, Centers for Medicare & Medicaid Services, publishes a federal upper limit (FUL) payment schedule for many commonly prescribed multiple-source drugs. The federal upper limit is set at a rate equal to 150 percent of the published price for the least costly therapeutic equivalent that can be purchased by pharmacists. This FUL payment schedule constitutes the federal MAC list. For many multiple-source drugs that are not on the federal MAC list, the Department establishes a state MAC list. Additionally, the Department imposes a state MAC for many multiple-source drugs that are on the federal MAC list, as long as the aggregate savings are at least as much as the savings would be using the federal MAC list.

The Department requires Medical Assistance pharmacy providers to submit their usual and customary costs. ### Metropolitan Council Notice of Adoption of Revisions to Waste Discharge Rules (WDR) for the Metropolitan Disposal System (MDS)

The Metropolitan Council on February 13, 2013, adopted revisions to the Waste Discharge Rules (WDR) for the Metropolitan Disposal System (regional wastewater collection and treatment system). The WDR specify standards and requirements which must be met by affected persons, including permittees and customer communities. The adopted revisions involve three main categories:

- 1. Requirements involving "customer communities," which are the cities and townships served by the Metropolitan Disposal System. The revisions generally serve to codify existing requirements or procedures.
- 2. Revisions required by the Minnesota Pollution Control Agency, resulting from the adoption of "Minnesota Pretreatment Rules" in 2008 (*Minnesota Rules*, Chapter 7049).
- 3. Other additions, updates and improvements.

The Metropolitan Council designs, constructs, and operates the Metropolitan Disposal System (MDS), a publicly owned system of interceptor sewers and wastewater treatment facilities, for the conveyance, treatment and disposal of domestic waste, industrial waste and other waste from residential, commercial, institutional and industrial users in the metropolitan area. To achieve efficient and effective use of the Metropolitan Council's facilities, the Metropolitan Council regulates the quantity and quality of waste discharges into public sewers. The Metropolitan Council implements applicable provisions of *Code of Federal Regulations*, title 40, chapter I, subchapter N and applicable provisions of *Minnesota Rules*, chapter 7049, and enforces national and State of Minnesota pretreatment standards and requirements. The Metropolitan Council maintains a program to regulate use of public sewers, enforces applicable standards and requirements, and charges for services and activities necessary to carry out its obligations under federal and state law.

The WDR are adopted by the Metropolitan Council Board pursuant to *Minnesota Statutes*, chapter 473, and are declared to be necessary for the efficient, economic, and safe operation of the MDS, and for protection of the health, safety, and general welfare of the public in the Twin Cities metropolitan area. The Metropolitan Council is the delegated control authority under the General Pretreatment Regulations and Minnesota Rules, chapter 7049, and these rules, therefore, supersede any customer community rules or requirements related to federal pretreatment standards and requirements. The WDR apply to the use of the MDS by all persons and facilities whether served directly or indirectly by the MDS.
