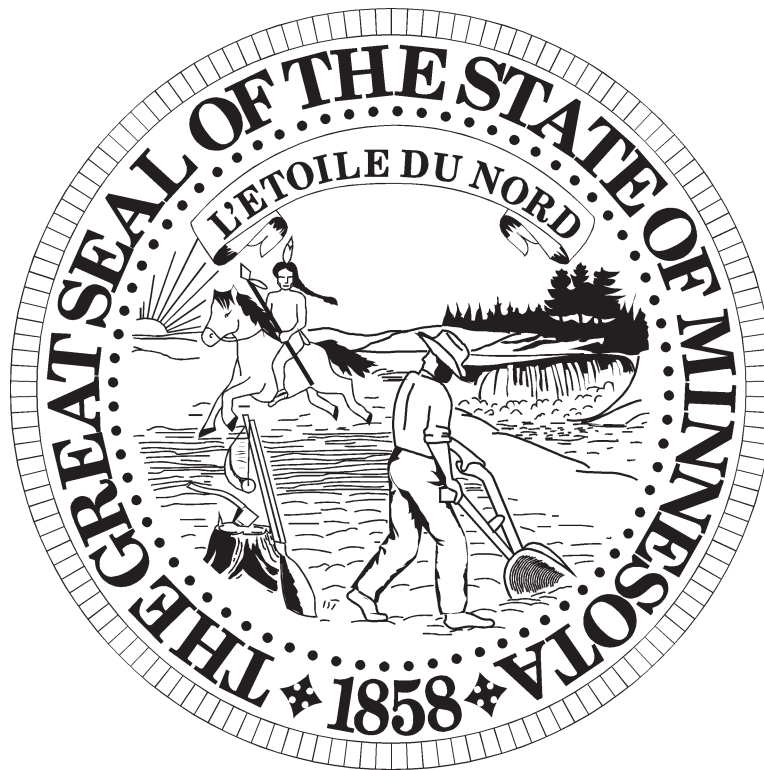

# Minnesota Rules: Amendments and Additions

## NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. ## Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

**KEY: Proposed Rules** - Underlining indicates additions to existing rule language. ~~Strikeouts~~ indicate deletions from existing rule language. If a proposed rule is totally new, it is designated "all new material." **Adopted Rules** - Underlining indicates additions to proposed rule language. ~~Strikeout~~ indicates deletions from proposed rule language.

## Executive Orders

The governor has the authority to issue written statements or orders, called Executive Orders, as well as Emergency Executive Orders. The governor's authority is specified in the *Constitution of the State of Minnesota*, Article V, and in *Minnesota Statutes* § 4.035. Emergency Executive Orders, for protection from an imminent threat to health and safety, become effective immediately, are filed with the secretary of state, and published in the *State Register* as soon as possible after they are issued. Other Executive Orders become effective 15 days after publication in the *State Register* and filing with the secretary of state. Unless otherwise specified, an executive order expires 90 days after the date the governor who issued the order vacates office.

## Executive Order 14-15

### Establishing the Governor's Task Force on the Protection of Children

**I, Mark Dayton, Governor of the State of Minnesota**, by virtue of the authority vested in me by the Constitution and applicable statutes, do hereby issue this Executive Order:

**Whereas**, the protection of the children of the state of Minnesota is a top priority for law enforcement, human services providers, and citizens of this State; and

**Whereas**, recent cases have brought to the forefront of the State's collective conscious the maltreatment of children, and the need to review the standards of child protection at a state, county, and local level.

**Now, Therefore**, I hereby order that:

1. The Governor's Task Force on the Protection of Children is created to advise the Governor and Legislature on system and practice improvements in the child protection system at all levels of government within the State of Minnesota.
2. The Task Force will consist of members appointed by the Governor.

3. The purpose of the Task Force is to:
  - a. Review the current child welfare system to assess practices, especially at critical decision points, to ensure child safety.
  - b. Make initial recommendations on three areas:
    - i. Are pre-court protection protocols, including screening decisions and the family assessment process, adequate, and if so, are they being adhered to?
    - ii. Does the child protection system have the capacity and resources to address child maltreatment reports, and to serve families?
    - iii. Is there adequate supervisory oversight of local agency practices?
  - c. In addition, the Task Force will address:
    - i. Screening decisions when children are reported to child protection;
    - ii. Training of staff, child welfare training system, and workforce development;
    - iii. Workload of staff and supervisors;
    - iv. Cross reporting to law enforcement;
    - v. State capacity to review county decisions/quality assurance;
    - vi. Handling of substantial child endangerment cases;
    - vii. Child protection protocols and adherence;
    - viii. Resources and funding; and
    - ix. Assessment of what Minnesota does well and where it needs to improve.
  - d. The Task Force will not examine court practices or procedures.
4. The Task Force will provide initial recommendations on the first three questions and convey its findings in a report to the Governor's Office, the Legislature, and the public by December 31, 2014, and final recommendations by March 31, 2015.
5. The Commissioner of the Department of Human Services will provide general administrative and technical support to the Task Force.
6. The Task Force will make its meetings open to the public and provide opportunities for public comment.

This Executive Order is effective fifteen days after publication in the State Register and filing with the Secretary of State, and shall remain in effect until rescinded by proper authority or until it expires in accordance with Minnesota Statutes, section 4.035, subdivision 3.

Laws of Minnesota 2013, Chapter 114, Article 4, Section 105, (a) directs the agency in part as follows: "The commissioner of the Pollution Control Agency shall adopt rules pertaining to the control of particulate emissions from silica sand projects."

This is the agency's second request for comments (RFC) for this rulemaking and comprises an opportunity for public comment and input. This RFC relates solely to the agency's planned rulemaking regarding particulate emissions from silica sand projects. The agency's rulemaking potentially affects any owner or operator of an existing or proposed silica sand project and those persons who may be impacted by particle emissions from silica sand projects.

The agency published its first RFC for this proposed rulemaking on July 22, 2013, prior to having any rule concepts on which to comment, and closed that comment period on September 30, 2013. The agency has since sought input from an advisory panel representing the public, local government and industry on pollution issues related to silica sand projects. The Minnesota Pollution Control Agency (MPCA) is requesting comments on the draft Rice Creek Watershed District Southwest Urban Lakes Total Maximum Daily Load (TMDL) Report. The draft TMDL report is available for review at:

Following the comment period, the MPCA will revise the draft TMDL report and submit it to the U.S. Environmental Protection Agency (EPA) for approval. Comments must be sent to MPCA contact person listed below by 4:30 p. m. on October 21, 2014.

A TMDL is a scientific study, conducted on waters designated as impaired, required by the federal Clean Water Act. A TMDL study calculates the maximum amount of a pollutant that a waterbody can receive and continue to meet water quality standards for designated beneficial uses. It is a process that identifies all the sources of the pollutant causing the impairment and allocates allowable loads among them. This multi-year effort results in a pollution reduction plan and engages stakeholders and the general public. An approved TMDL is followed by implementation activities for achieving the necessary reductions.

This TMDL study addresses seven nutrient (phosphorus) impaired lakes. Excess phosphorus in lakes leads to nuisance algae blooms which affect the desirability of water for swimming and other recreation.

The lakes addressed in the study are as follows: Island Lake, North Basin (62-0075-02), Island Lake, South Basin (62-0075-01), Little Lake Johanna (62-0058-00), Long Lake, South Basin (62-0067-00), Moore Lake, East (02-0075-01), Pike Lake (62-0069-00), and Lake Valentine (62-0071-00).

These waterbodies and the land area that drains to them are located in the southwest portion of the Rice Creek watershed in Ramsey County and Anoka County. The predominant source of phosphorus to the waterbodies from the watershed is urban stormwater runoff. In-lake sources of phosphorus (e.g., carp and sediment release) are also important contributors for some of the lakes. This report was largely based on a previous study completed by the Rice Creek Watershed District. Lake Management Action Plans for implementation projects have been completed by the district and these projects are ongoing.

**Preliminary Determination on the Draft TMDL Report:** The MPCA Commissioner has made a preliminary determination to submit this TMDL report to the EPA for final approval. A draft TMDL report is available for review at the MPCA office at the address listed below, and at the MPCA Web site: <http://www.pca.state.mn.us/water/tmdl/tmdl-draft.html>

A material issue of fact means a fact question, as distinguished from a policy question, whose resolution could have a direct bearing on a final MPCA decision.

A petition for a contested case hearing must include the following information:

1. A statement of reasons or proposed findings supporting the MPCA decision to hold a contested case hearing according to the criteria in *Minnesota Rules* 7000.1900, as discussed above; and
2. A statement of the issues proposed to be addressed by a contested case hearing and the specific relief requested or resolution of the matter.
