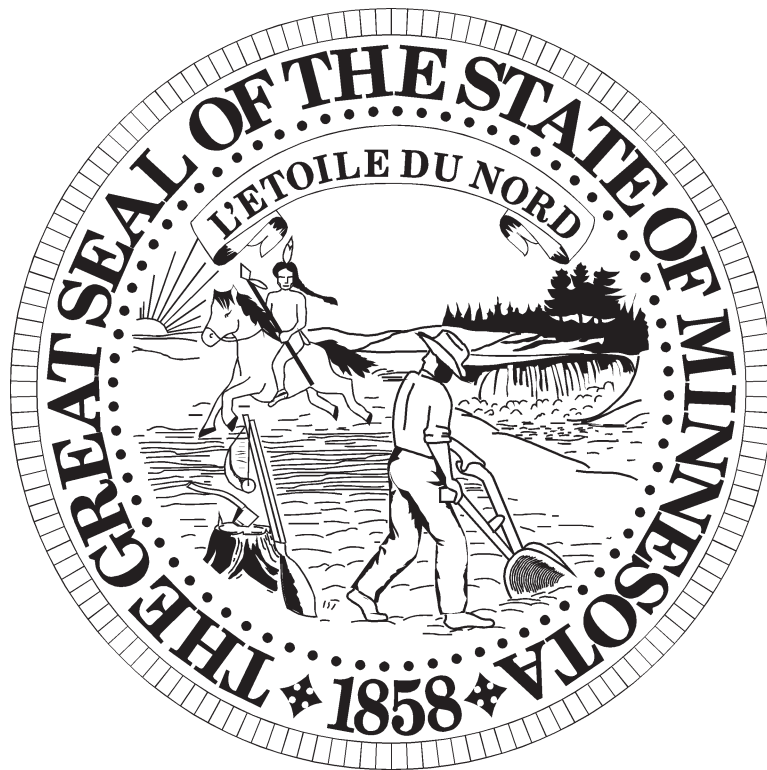

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The *State Register* is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the *State Register*. Published every Monday, the *State Register* makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific **Minnesota Rule** chapter numbers. Every odd-numbered year the **Minnesota Rules** are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the *State Register*.

An agency must first solicit **Comments on Planned Rules** or **Comments on Planned Rule Amendments** from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (*Minnesota Statutes* §§ 14.101). It does this by publishing a notice in the *State Register* at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as **Proposed Rules**, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the *State Register*. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the *State Register* as **Adopted Rules**. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the *State Register*, the issue the rule appeared in as proposed, and later as adopted.

The *State Register* features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. Adopted Rules

A rule becomes effective after the requirements of *Minnesota Statutes* §§ 14.05-14.28 have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule. If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous *State Register* publication will be printed. If an adopted rule differs from its proposed form, language which has been deleted will be printed with strikeouts and new language will be underlined. The rule's previous *State Register* publication will be cited.

Minnesota Department of Corrections (DOC) **Adopted Permanent Rules Relating to Municipal Lockup Facilities**

The rules proposed and published at *State Register*, Volume 39, Number 10, pages 308-323, September 08, 2014 (39 SR 308), are adopted with the following modifications:

2945.0120 INTENDED USE AND NONCOMPLIANCE.

Subp. 1a. Rule compliance.

C. A Class II or III municipal lockup facility must comply with at least 90 percent of parts 2945.0120 to 2945.5490 that are not listed in item B or do not specifically exclude that type of facility. For each rule part, every subpart, item, and subitem is counted as a separate regulatory standard toward the required percentage totals.

2945.2520 DETAINEE VISITATION.

Subpart 1. **Initial visits for juveniles.** The initial visit for parents, guardians, and attorneys must be permitted at any time. Visits by parents, guardians, and attorneys with juvenile detainees must be as unrestricted as administratively possible. The facility administrator shall address how to regulate access to juvenile detainees by the detainee's parents, guardians, and attorneys in the facility's visiting plan.

Expedited Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited rules when conditions exist that do not allow the Commissioner to comply with the requirements for normal rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the conditions. Expedited rules are effective upon publication in the State Register, and may be effective up to seven days before publication under certain conditions.

Expedited rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited rules detail the agency's rulemaking authority.

NOTICE OF INTENT TO ADOPT EXPEDITED RULES WITHOUT A PUBLIC HEARING Proposed Amendments to Permanent Game and Fish Rules Relating to the Control and Prevention of the Wildlife Disease Viral Hemorrhagic Septicemia (VHS) Transmission from Bait, *Minnesota Rules*, parts 6216.0400, 6254.0600, 6262.0100, 6262.0300, 6262.0576, and 6262.0577 and to Inland Waters Fishing Regulations and Designated Spawning Beds and Fish Preserves, *Minnesota Rules*, parts 6262.0200, 6262.0300, and 6264.0125

Introduction. The Department of Natural Resources intends to adopt rules under the expedited rulemaking process in the rules of the Office of Administrative Hearings, *Minnesota Rules*, part 1400.2410, and the Administrative Procedure Act, *Minnesota Statutes*, section 14.389. You may submit written comments on the proposed expedited rules until Friday, March 27, 2015.

Subject of the Expedited Rules and Statutory Authority. The proposed expedited rules are about:

- Control and prevention of the wildlife disease known as viral hemorrhagic septicemia (VHS) that affects fish populations in Minnesota waters. The rules were previously put in place through the emergency rule process. Much of the content is dealing with bait use, harvest, possession, and transportation. The statutory authority to adopt the rules is *Minnesota Statutes*, sections 84.027, subdivisions 13a; 84D.12; 97A.045; 97A.551; 97C.205; 97C.341; 97C.342; 97C.505, subd 1 (b); and 97C.805.
- Addition of other water bodies to the list of designated spawning beds and fish preserves and technical changes in the legal descriptions of those water bodies already listed. The statutory authority to adopt the rules is *Minnesota Statutes*, section 97C.025.

The statutory authority to adopt the rules under the expedited rulemaking process is in *Minnesota Statutes*, section 84.027, subd. 13a. A copy of the proposed rules is published in the *State Register* and may be viewed at:

If you wish to have a hard copy sent to you, please contact the person listed as the agency contact person.

Comments. You have until 4:30 p.m. on Friday, March 27, 2015, to submit written comment in support of or in opposition to the proposed expedited rules and any part or subpart of the rules. Your comment must be in writing and received by the agency contact person by the due date. The department encourages comment. Your comment should identify the portion of the proposed expedited rules addressed and the reason for the comment. In addition, you are encouraged to propose any change desired. You must also make any comments on the legality of the proposed rules during this comment period.

Expedited Rules

Modifications. The agency may modify the proposed expedited rules using either of two avenues: The agency may modify the rules directly so long as the modifications do not make them substantially different as defined in *Minnesota Statutes*, section 14.05, subdivision 2, paragraphs (b) and (c). Or the agency may adopt substantially different rules if it follows the procedure under *Minnesota Rules*, part 1400.2110. If the final rules are identical to the rules originally published in the *State Register*, the agency will publish a notice of adoption in the *State Register*. If the final rules are different from the rules originally published in the *State Register*, the agency must publish a copy of the changes in the *State Register*. If the proposed expedited rules affect you in any way, the agency encourages you to participate in the rulemaking process.

6216.0400 RESTRICTED ACTIVITIES ON INFESTED WATERS; PERMITS.

Subpart 1. **Taking bait from infested waters.** The taking of wild animals from infested waters for bait or aquatic farm purposes is prohibited, except:

A. by permit according to part 6254.0200 and *Minnesota Statutes*, sections 84D.03, subdivision 3, and 84D.11, subdivision 2a; ~~and~~

B. harvest for bait purposes from waters that are designated as infested waters solely because they contain Eurasian water milfoil is allowed for noncommercial personal use; ~~and~~

C. harvest of rainbow smelt or cisco for bait purposes from Lake Superior or its tributaries below the posted boundaries, except those streams listed in part 6262.0300, subpart 4, item C, for use as fresh, dead, frozen, or preserved bait only on Lake Superior or its tributaries below the posted boundaries, in accordance with *Minnesota Statutes*, section 97C.341, paragraph (c).

6254.0600 REQUIREMENTS TO HOLD AND MOVE MORE THAN 24 DOZEN MINNOWS.

Subp. 7. **Permit documents required.**

A. Before a licensed minnow dealer is allowed to harvest and transport cisco, rainbow smelt, and animals on the official list of viral hemorrhagic septicemia susceptible species published by the United States Department of Agriculture, Animal and Plant Health Inspection Services, the dealer must obtain one of the following permit documents:

(1) a state-issued live fish transportation, importation, and stocking permit from the local fisheries area or regional office; or

(2) a valid fish health certification for the source water body showing no presence of viral hemorrhagic septicemia within the past year.

B. The permit documents may be used for multiple shipments within the term of the permit as long as the source water body remains the same. The transportation permit must have a single destination. A fish health certification may be used for multiple destinations.

Subp. 5. **Prohibition on taking fish for bait purposes.**

C. Notwithstanding *Minnesota Statutes*, section 84D.03, subdivision 3, and as provided in *Minnesota Statutes*, section 97C.341, paragraph (c), cisco or rainbow smelt may be taken for use as bait from Lake Superior or its tributaries below the posted boundaries, except those streams listed in subpart 4, item C. The cisco and rainbow smelt may be used only on Lake Superior or its tributaries below the posted boundaries, as fresh, dead, frozen, or preserved bait. Preserved cisco and smelt may be used as prescribed in part 6262.0576 on all waters of the state.

6262.0576 BAIT RESTRICTIONS.

Subpart 1. **Definitions.** For purposes of this part:

A. “cisco” means all *Coregonus*, including lake herring and tullibee;

B. “restricted bait” means fresh, live, dead, frozen, or preserved cisco, smelt, or VHS susceptible species;

C. “smelt” means all *Osmerus*, *Spirincus*, *Hypomesus*, and *Allosmerus*; and

D. “VHS susceptible species” means all species on the official list of viral hemorrhagic septicemia (VHS) susceptible species published by the United States Department of Agriculture, Animal and Plant Health Inspection Services.

Subp. 2. **Possession and use.**

A. A person may take, possess, and use restricted bait on Lake Superior or its tributaries below the posted boundaries.

B. A person shall not take, possess, or use restricted bait in water bodies other than Lake Superior or its tributaries below the posted boundaries unless:

(1) the restricted bait is being used on the same body of water where caught and while still on that water body. The restricted bait must not be transported off the water body, alive or dead, for any purpose;

(2) the water body where the restricted bait originated is listed on the department’s Web site as having no presence of VHS in all species in the last year or the person has in the person’s immediate possession:

(a) a valid fish health certification for the source water body showing no presence of VHS in the last year; or

(b) labeling as specified in subpart 3, item B, for frozen restricted bait;

(3) the restricted bait is preserved and labeled according to part 6262.0577 or as further prescribed by the commissioner in a permit. The labeling must be in the person’s immediate possession;

(4) the restricted bait was purchased from a licensed minnow dealer or minnow retailer; or

(5) cisco or smelt are being transported dead or on ice for personal consumption only.

C. Item B does not apply to licensed minnow dealers, aquatic farms, or private fish hatcheries when taking, possessing, or transporting minnows in compliance with *Minnesota Statutes*, section 97C.342.

Subp. 3. **Labeling requirements.**

A. Restricted bait harvested for personal use does not require labeling until it leaves the source water body.

B. Restricted bait harvested by a person for personal use as dead or frozen bait must be labeled with:

(1) the name and Department of Natural Resources certified water body number for the source water body;

(2) the date of harvest from the source water body;

(3) the date of packaging and labeling; and

(4) the disease-free certification date for the source water body.

C. Restricted bait harvested under a minnow dealer license for use as dead or frozen bait must be labeled according to Minnesota Statutes, section 97C.342, subdivision 7.

D. Preserved restricted bait must be labeled according to part 6262.0577, subpart 4.

E. A person must retain the required labeling until the restricted bait is no longer in the person's possession.

Subp. 4. **Permit required to preserve cisco and smelt.** A person must obtain a bait preservation permit under part 6262.0577 to preserve cisco and smelt for use as bait in waters of the state.

Subp. 5. **Cisco or smelt for consumption.** Notwithstanding part 6262.0300, subpart 5, and *Minnesota Statutes*, sections 84D.03, subdivision 3, 84D.11, subdivision 2a, and 97C.341, cisco or smelt may be taken and transported dead for personal consumption.

6262.0577 BAIT PRESERVATION.

Subpart 1. Permit required to preserve bait.

A. For purposes of this part, "bait" has the meaning given under *Minnesota Statutes*, section 97C.341, paragraph (b).

B. A person must obtain a bait preservation permit to preserve bait for use in waters of the state if the bait is:

(1) cisco or smelt that are from waters that have not been certified disease free according to *Minnesota Statutes*, section 97C.342, except those being used on Lake Superior or its tributaries below the posted boundaries;

(2) from known positive viral hemorrhagic septicemia waters, except cisco and smelt being used on Lake Superior or its tributaries below the posted boundaries;

(3) imported bait that does not have a valid fish health certification showing no presence of viral hemorrhagic septicemia; or

(4) a species on the viral hemorrhagic septicemia-susceptible species list published by the United States Department of Agriculture, Animal and Plant Health Inspection Service, and has not been harvested from certified disease-free sources.

C. Only persons with a minnow dealer, minnow retailer, aquatic farm, private fish hatchery, commercial netting of fish, fish packer, or Lake Superior fishing guide license issued by the commissioner are eligible for a bait preservation permit.

Subp. 2. **Preservation methods.** Preservation methods that are permitted include use of isopropyl alcohol, a salt and borax mixture, or other methods determined by the commissioner to effectively inactivate the viral hemorrhagic septicemia (VHS) virus. Freezing or refrigeration is not an approved preservation method. Methods may include a minimum processing time to ensure complete inactivation of the virus. A permittee, or out-of-state person working under a permittee under subpart 5, must follow all preservation procedures prescribed in the permit and may not distribute or sell preserved bait until all permit requirements are met.

Subp. 3. **Reporting requirements.** A holder of a bait preservation permit must maintain records within the state on forms provided by the commissioner for each lot of fish preserved. The records must include the method of preservation, the lot number for each batch of fish preserved, the source water body of the fish preserved, and other information as specified on the reporting form. A permittee must enter required records into forms within 24 hours of processing each lot of fish. A permittee must retain records for three years following the date of creation. All records required to be retained must be open to inspection by the commissioner at any reasonable time.

Subp. 4. **Labeling requirements.** A bait preservation permittee must label each container or package of preserved bait with the following information:

A. Department of Natural Resources bait preservation permit number;

B. lot number; and

C. date of processing.

Expedited Rules

Subp. 5. **Out-of-state preservation.** Persons located outside the state may preserve bait for use in Minnesota waters only under a permit held by a Minnesota resident age 16 years or older. Complete preservation records must be created for each lot of fish preserved. The records must be transferred to the permit holder prior to or along with shipment of the product. The permit holder must retain the records as provided in subpart 3. A permittee is responsible for ensuring that all persons working under the permittee's permit preserve, report, and label as prescribed by the bait preservation permit.

WHEREAS, pursuant to *Minnesota Statutes*, section 84D.03, subdivision 1, the designation of infested waters by the commissioner shall be by written order published in the State Register prior to August 1, 2014; after that date, the commissioner shall maintain a list of infested waters and provide access to a copy of the listed waters.

WHEREAS, the following described waters in the state meet the criteria established in Minnesota Statutes, section 84D.03, subdivision 1, for designating infested waters, and the following explanations apply to the list:

1. A lake in more than one county is listed under the county corresponding to its public waters inventory number, but the designation applies to the entire lake. Lake Superior and designated portions of rivers that flow through more than one county are listed under the heading Multiple Counties.
2. Ponds and wetlands that are not on the public waters inventory are listed with "none" in the number column.
3. Rivers and streams on the public waters inventory are listed without a number in the number column.
4. Changes to previous designations of infested waters are shown by underlining the new text and strikethrough of deleted text.

Notice of Proposed Update of the State Superfund Priority List (Superfund List) (also known as the Permanent List of Priorities (PLP)) Among Releases or Threatened Releases of Hazardous Substances or Pollutants or Contaminants

NOTICE IS HEREBY GIVEN that the Minnesota Pollution Control Agency (MPCA) is publishing for public comment proposed deletions from the State Superfund List which lists releases or threatened releases of hazardous substances, pollutants, or contaminants for which the MPCA may take removal or remedial actions under the Minnesota Environmental Response and Liability Act (MERLA), *Minnesota Statutes* §§ 115B.01-115B.20.

Pursuant to *Minnesota Statutes* §115B.17, the MPCA is authorized to take any removal or remedial action which the MPCA deems necessary to protect the public health, welfare or the environment whenever there is a release, or substantial threat of release, from a facility of any pollutant or contaminant which presents an imminent and substantial danger to the public health, welfare, or the environment, or whenever a hazardous substance is released or there is a threatened release of a hazardous substance from a facility.

Minnesota Statutes §115B.17, subd. 13 required the MPCA to establish priority rules regarding releases or threatened releases of hazardous substances, and pollutants or contaminants. These rules, *Minnesota Rules* chapter 7044, became effective on April 5, 1993.

Minnesota Statutes §115B.17, subd. 13 also requires the MPCA to adopt the State Superfund List and to update the list annually according to the criteria set forth in the priority rules. Before any update of the State Superfund List is adopted by the MPCA, it must be published in the *State Register* and a 30-day public comment period must be provided.

This notice is, therefore, published to inform the public that the MPCA proposes to update the Superfund List and to solicit public comment on the proposed deletions.

Official Notices

Pursuant to *Minnesota Statutes* § 115B.17 (2014) and *Minnesota Rules* 7044.0950 (2013), the MPCA is proposing the following changes to the Superfund List.

The MPCA is proposing to delete portions of the following Sites from the Superfund List: Naval Industrial Reserve Ordinance Plant (NIROP), Fridley, Anoka County; and Superior Plating, Minneapolis, Hennepin County.

In October 1984, the MPCA listed the NIROP Site on the State Superfund List. In November 1989, the United States Environmental Protection Agency (U.S. EPA) listed the NIROP Site on the Federal Superfund List, or National Priorities List (NPL). The MPCA and U.S. EPA divided the NIROP Site into three operable units for purposes of management of response actions. Operable Unit 1 includes the contaminated groundwater within and originating from the NIROP Site. Operable Unit 2 includes the unsaturated soils within the legal boundaries of the NIROP Site exclusive of the unsaturated soils underlying the former Plating Shop Area of the Site. Operable Unit 3 includes the unsaturated soils underlying the former Plating Shop. For purposes of this proposed deletion, the MPCA is proposing to delete only Operable Unit 2 of the NIROP Superfund Site from the State Superfund List. The U.S. Navy, under a March 1991 Federal Facilities Agreement with the MPCA and U.S. EPA, has completed all appropriate and necessary response actions at Operable Unit 2, as prescribed in the September 2003 Record of Decision for Operable Units 2 and 3. Land use controls, in the form of deed restrictions, limits future use of the NIROP site to industrial or restricted commercial use, unless determined by the U.S. EPA and MPCA that concentrations of hazardous substances in soil have been reduced to allow for a less restrictive use. On August 29, 2014, the U.S. EPA delisted Operable Unit 2 from the NPL. The areas designated as Operable Unit 1 and Operable Unit 3 will remain listed on both the State and Federal Superfund Lists.

Redevelopment plans are underway for the Operable Unit 2 area of the Site and adjacent land area, which is consistent with land use controls currently in place. The MPCA's Voluntary Investigation and Cleanup (VIC) Program will oversee any redevelopment and associated response actions to ensure the NIROP Site remains protective of public health and environment.

In October 1984, the MPCA listed the Superior Plating Site on the State Superfund List. The MPCA divided the Superior Plating Site into two operable units for purposes of management of response actions. Operable Unit 1 is defined as the unsaturated soils above bedrock and within the legal boundaries of the Superior Plating Site. Operable Unit 2 is defined as the contaminated groundwater originating from past operations of Superior Plating. Operable Unit 2 includes an off-site groundwater plume of trichloroethylene (TCE) associated with past solvent use and an off-site plume of leachate primarily consisting of chromium, nickel, copper, cyanide, and zinc associated with past plating operations. First and University Investor LLC (FUI), a non-responsible party, through a Voluntary Response Action Agreement with the MPCA has completed appropriate and necessary response actions to address releases of hazardous substances to Operable Unit 1, as part of redevelopment activities planned for the Superior Plating Site. The response actions taken at the Superior Plating Site were outlined in the MPCA approved Minnesota Decision Document (March 2014). A Certificate of Completion was issued by the MPCA to FUI for response actions taken at Operable Unit 1 on December 19, 2014.

For purposes of this proposed deletion, the MPCA is proposing to only delist Operable Unit 1 of the Superior Plating Site from the State Superfund List. The MPCA, in conjunction with FUI as specified in a Voluntary Response Action Agreement between the MPCA and FUI, will continue to manage and address releases of hazardous substances associated with Operable Unit 2. An environmental covenant filed on the property provides the MPCA an easement to conduct groundwater remediation activities and operation of the leachate collection system. Therefore, Operable Unit 2 will remain on the State Superfund List and be renamed the Superior Plating Ground Water Plume Site.

Therefore, the MPCA has determined that all appropriate MERLA response actions have been completed at those portions of each Site proposed for delisting and those portions of each Site do not pose a threat to public health or welfare or the environment. Thus no further MERLA funded response actions will be necessary and deletion of that portion of each Site from the Superfund List is appropriate pursuant to *Minnesota Rules* 7044.0950.

The MPCA invites members of the public to submit written comments on the proposed partial deletions from the State Superfund Priority List. All written comments with regard to these proposed changes to the Superfund List must be received by the MPCA no later than 4:30 p.m. on March 19, 2015.

NOTICE IS HEREBY GIVEN that Aurora Distributed Solar, LLC (Aurora) has filed a Site Permit application for the construction and operation of a new 100 MW distributed solar project at up to 24 locations in 16 counties in Minnesota including Benton, Blue Earth, Carver, Chippewa, Chisago, Dodge, Goodhue, Kandiyohi, Le Sueur, McLeod, Pipestone, Rice, Stearns, Waseca, Washington, and Wright counties. The proposed power plant locations range in nameplate capacity from 1.5 to 10 megawatts. Preliminary estimates of developed area range from approximately 13 to 108 acres. Aurora proposes to construct the Aurora Distributed Solar Project to provide distributed solar energy to meet Xcel Energy's needs for additional capacity in the 2017 to 2019 timeframe. While the proposed project meets the definition of a large energy facility requiring a certificate of need under *Minnesota Statute* § 216B.2421, Subd. 2, the project is exempt from the certificate of need requirement because it was selected by the Commission through a competitive resource acquisition process to meet Xcel Energy's electricity generation needs.

The proposed project is a large electric power generating plant under *Minnesota Statute* 216E.01, Subd. 5 because the power generating equipment and associated facilities are designed for or capable of operation at a capacity of 50,000 kilowatts or more. Under *Minnesota Statute* § 216E.03, subd. 1 no person may construct a large electric generating plant without a Site Permit from the Commission.

As a large electric power generating plant powered by solar energy, the Aurora Distributed Solar Project qualifies for review under the alternative permitting process. Review under the alternative process is outlined in *Minnesota Statute* 216E.04, rather than the procedures for a full process under *Minnesota Statute* 216E.03. The Application was submitted pursuant to the provisions of the Alternative Permitting Process outlined in *Minnesota Rules* 7850.2800-3900.

NOTICE IS HEREBY GIVEN that Minnesota Pipe Line Company, LLC (MPL) has filed a Certificate of Need application to increase the capacity of its 305-mile long, 24-inch diameter Line 4 petroleum pipeline through construction of six pump stations and upgrades at two existing pump stations in order to improve reliability of crude oil supply to Minnesota’s two refineries located in the Twin Cities. The new pump stations would be located in rural areas of Hubbard, Wadena, Morrison, Meeker, McLeod, and Scott counties in Minnesota.

The project would increase annual average capacity on the line from 165,000 barrels per day (bpd) to 350,000 bpd while the maximum operating pressure is not expected to change from the current 1,470 psig. The proposed project will not require acquisition of new right-

of-way or any pipeline construction; all work would be limited to pump stations.

MPL describes the project as a reliability project. The Company expects the project to provide excess capacity that will be utilized when MPL must remove one of its other lines from service for testing, maintenance, or other reasons. MPL believes that construction of this project will prevent disruption of the supply of crude oil to Minnesota refineries. There are no expected out-of-state recipients for the oil transported on MPL's system, which includes Line 4.

The estimated construction start date is January 1, 2016, with a full in-service date of fourth quarter of 2017.

Before increasing the capacity of a large energy facility, including increasing, within a period of two years, an existing large petroleum pipeline in excess of either 20 percent of its rate capacity or 10,000 barrels per day, a person must apply for a certificate of need demonstrating that the upgrade is needed. Because the company's proposed upgrade would increase capacity by more than 20 percent and by more than 10,000 barrels per day, the company filed an application for a certificate of need.

This project has been deemed a Large Energy Facility, increasing the pipeline capacity by 185,000 bpd (approximately 112 percent), and, therefore, a certificate of need is required as described in *Minnesota Rules*, part 7853.

Minnesota Rule Ch. 7853 sets forth the requirements for making an application for a certificate of need, as well as the ultimate criteria for demonstrating need. Where material facts are in dispute, the Commission refers cases to the Office of Administrative Hearings for a contested case proceeding under *Minnesota Rule* 7829.1000. Otherwise, the Commission may develop the record using its informal proceedings under *Minnesota Rule* 7829.1200.

NOTICE IS HEREBY GIVEN that the Minnesota Department of Human Services is requesting proposals to provide: 1) direct and culturally affirmative mental health services to children and adolescents in Minnesota (both Twin Cities and Greater Minnesota) who are deaf, deafblind or hard of hearing experiencing a behavioral disorder or are coping with a mental illness, and 2) to ensure that these consumers who have no other means of paying for direct mental health services have access to specialized services provided. In an effort to expand mental health services in Greater Minnesota particularly in a region in the state that has not been served on a regular basis, it is DHHS's goal to identify a qualified Responder(s) who share the same goal and are fully committed to see this into fruition.

In order to ensure the delivery of the most effective and efficient services, the Department will focus on providers that have demonstrated a commitment to: (a) prioritization of services and care of consumers with behavioral/emotional disorders or mental illness; (b) implementing evidence-based treatments or services; (c) the practice of continuous quality improvement for all services; and (d) cultural competency in service delivery. All projects proposed must include performance indicators that will demonstrate the ability of qualified or licensed mental health clinician(s) to provide direct mental health services to deaf, deafblind, and hard of hearing children and adolescents living in the Twin Cities and Greater Minnesota, the ability to develop a network of professional service providers and contacts that can assist deaf, deafblind, and hard of hearing consumers with mental health needs and their families to obtain appropriate services, and to offer telemental health services via secure videoconferencing when needed. The funding offered is up to \$336,375 per year for State Fiscal Years (SFY) 2016 and 2017.
