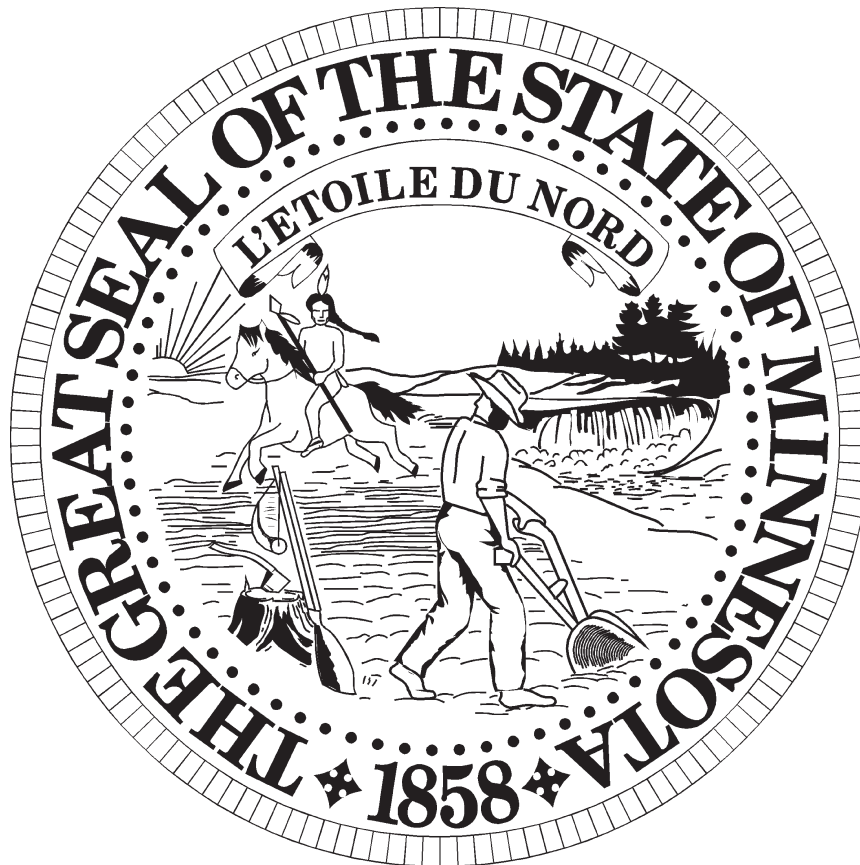

# Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-13 inclusive; issues #14-25 inclusive (issue #26 cumulative for issues #1-26); issues #27-38 inclusive (issue #39, cumulative for issues #1-39); issues #40-52 inclusive, with final index (#1-52, or 53 in some years). An annual subject matter index for rules was separately printed usually in August, but starting with Volume 19 now appears in the final issue of each volume. # Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

### Adopted Expedited Emergency Game and Fish Rules: Mille Lacs Lake Regulations

Notice is hereby given that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, sections 97A.045, subd. 2; 97C.005; and 97C.401.

The conditions that do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459, are as follows: Each year a harvestable surplus is set for walleye in Mille Lacs Lake pursuant to the procedures set forth in the 1996 Stipulated Settlement and Federal Consent Decree adopted by the Minnesota Federal District Court in 1997 and affirmed by the U.S. Supreme Court in 1999. The harvest surplus is the volume of fish that can safely be harvested from Mille Lacs Lake while ensuring sufficient remaining walleye in the lake for a healthy fishery. The harvest surplus is then divided between the state of Minnesota and the eight Chippewa Tribal Bands. The Mille Lacs Band, Fond Du Lac Band, and six Wisconsin Bands of Chippewa are not required to declare their harvest intentions on inland waters until mid-March. The proposed fishing regulations for Mille Lacs Lake are based on a safe harvest level determined for 2016. Final harvest threshold levels to be included in the proposed rules were not available until March. These new threshold levels and regulations need to be put in place as soon as possible to ensure that angler harvest does not exceed state angler harvest thresholds for the 2016 open water fishing season.

### Adopted Expedited Emergency Game and Fish Rules: Mille Lacs Lake Fishing

#### 6264.0400 DESIGNATED SPECIAL MANAGEMENT WATERS.

*[For text of subs 1 to 3, see M.R.]*

##### Subp. 4. Mille Lacs Lake and associated tributaries special management regulations.

A. While a person is on or fishing in Mille Lacs Lake or its associated tributaries to the posted boundaries, the possession limit for northern pike is five. Only one northern pike in possession may be greater than 40 inches in length. All northern pike in possession must be less than ~~24~~ 30 inches in length or greater than ~~36~~ 40 inches in length. All northern pike that are ~~24~~ 30 to ~~36~~ 40 inches in length, inclusive, must be immediately returned to the water. ~~A person's possession limit may not include more than one northern pike over 36 inches in length.~~ Beginning December 1, 2016, the possession limit for northern pike is five. At least two northern pike less than 30 inches in length taken the same day from Mille Lacs Lake must be in immediate possession before possessing a northern pike greater than 30 inches in length, and only one northern pike in possession may be greater than 30 inches in length. The angling season for northern pike commences at 12:01 a.m. on the Saturday two weeks before the Saturday of Memorial Day weekend and runs to 11:59 p.m. on the last Sunday in March.

B. ~~The possession limit for smallmouth bass is one.~~ While a person is on or fishing in Mille Lacs Lake or its associated tributaries to the posted boundaries, the possession limit for largemouth and smallmouth bass in aggregate is four. Only one largemouth or smallmouth bass in possession may be greater than 21 inches in length. All largemouth and smallmouth bass in possession must be ~~2~~ less than 17 inches or greater than 21 inches in length. All largemouth and smallmouth bass ~~less than that are 17~~ to 21 inches in length, inclusive, must be immediately returned to the water. These size and possession restrictions for largemouth and smallmouth bass are waived by the Department of Natural Resources permit for a limited number of bass-fishing tournaments each year. Selection of tournaments for this exemption is based on tournament size, expected participation, and potential to

generate public interest and local economic activity. Unless otherwise authorized by special permits for fishing tournaments, the angling season for largemouth and smallmouth bass commences at 12:01 a.m. on the Saturday two weeks before the Saturday of Memorial Day weekend and runs to 11:59 p.m. on the last Sunday in February. All largemouth and smallmouth bass before the Saturday of Memorial Day weekend must be immediately returned to the water. Notwithstanding part 6262.0200, subpart 1, item A, subitem (2), the catch and release season beginning the second Monday in September to the last Sunday in February does not apply to Mille Lacs Lake or its associated tributaries to the posted boundaries.

C. Mille Lacs Lake is closed to the taking of fish between the hours of 10 p.m. and 6 a.m. daily (night closure) during the period commencing at 10 p.m. on the Monday following the Saturday two weeks prior to the Saturday of Memorial Day weekend and ending at 12:01 a.m. on Monday, four weeks after the date of commencement. During the closure, no person shall be on the waters of Mille Lacs Lake while having in possession any equipment whereby fish may be taken. Spearing is prohibited from December 1 through April 30. A person may not have a spear in possession while on or fishing in Mille Lacs Lake during this period. December 1, except as provided in subitems (1) and (2).

(1) Beginning June 6 at 10 p.m., fishing for muskellunge is allowed between the hours of 10 p.m. and 6 a.m. Only artificial muskellunge lures greater than eight inches in length, measured from the front of the eye of the lure to the end of the trailing hook, or sucker minnows greater than eight inches in length may be used or in possession. While fishing for muskellunge under this subitem, no person may have in possession tackle or bait other than that specifically used for muskellunge. Angling for, harvest of, and possession of species other than muskellunge are prohibited.

(2) Beginning June 6 at 10 p.m., bowfishing for rough fish is allowed between the hours of 10 p.m. and 6 a.m. No person shall have in possession any angling equipment while bowfishing under this subitem. Angling for, harvest of, and possession of species other than rough fish while bowfishing are prohibited.

E. While a person is on or fishing in Mille Lacs Lake or its associated tributaries to the posted boundaries;

(1) the possession and daily limit for Northern cisco (tullibee) is ten fish; and

(2) angling for walleye is limited to catch and release only. Any walleye caught must be immediately returned to the water.

F. Fish that are taken by angling and not immediately released into the water after capture are considered to be in possession and part of the bag limit. Once a fish has been reduced to possession, culling or live-well sorting (the act of exchanging one fish for another) is not allowed, except that culling or live-well sorting, before meeting a bag limit of fish reduced to possession, is allowed for largemouth and smallmouth bass.

"Specific questions about the map's depiction of waters and buffers on private land should go to **local soil and water conservation districts** or drainage authorities," DNR Buffer Mapping Project Manager Dave Leuthe said. "Soil and water conservation districts are ready to work with landowners on these issues."

The preliminary map displays public ditches only in counties and watershed districts that have submitted their data and had them incorporated into the map by the DNR.

A status map is available at [www.mndnr.gov/buffers](http://www.mndnr.gov/buffers). The status map displays the progress of each Minnesota county and watershed district in getting their data on the preliminary buffer map. As of April 26, 84 of the 95 drainage authorities had submitted the required data.

Landowners in counties whose information is not yet displayed on the preliminary map should continue to check on the status of their county. The DNR is working with counties and watershed districts that have not yet submitted data. Their information will be added to the map as it becomes available.

Minnesota's buffer law establishes a requirement for perennial vegetation buffers of up to 50 feet along rivers, streams, lakes and public ditches to help filter out phosphorus, nitrogen and sediment. The Department of Natural Resources' role is to produce a map of the public waters and public ditches that require permanent vegetation buffers.

**Possible Amendment to Rules Governing the Special Supplemental Nutrition Program for Women, Infants and Children (WIC Program), *Minnesota Rules*, 4617.0002, 4617.0065, 4617.0066, 4617.0067, 4617.0068, 4617.0070, 4617.0075, 4617.0084, 4617.0088, 4617.0090, 4617.0100, 4617.0121, and 4617.0176; Revisor's ID Number RD4388.**

**Subject of Rules.** The Minnesota Department of Health (MDH) requests comments on its possible amendment to rules governing the Special Supplemental Nutrition Program for Women, Infants and Children (WIC Program). This planned amendment in part responds to recent changes in the federal law and regulations that substantially revise the way that WIC foods are provided to WIC participants. These changes, which MDH must implement no later than October 1, 2020, require that the program provide WIC foods using an electronic benefits transfer (EBT) system. MDH intends to make other amendments that respond to changes in the federal regulations governing the WIC foods. Additional amendments will strengthen certain vendor-violation provisions, ease the WIC Program's administrative burden, and address other issues that arise during the rulemaking process.

Accommodating the changes in the federal regulations could result in MDH's modifying the following subjects in existing rules: definitions; vendor application process; change of vendor ownership; name or business site; vendor eligibility requirements; operating requirements; vendor stamps; vendor agreements; vendor sanctions; maximum prices of vouchers; rejection of vouchers and cash-value vouchers and reimbursement by vendors; appeals; transition period; and approval process for WIC foods other than infant formula. The Department expects to make other modifications as time allows.

**Persons Affected.** The amendments would directly affect WIC participants and potential WIC participants, WIC vendors, applicants to become WIC vendors, and wholesalers and distributors of WIC foods. Other persons who might be indirectly affected are food manufacturers and employees of local WIC agencies.

MDH is particularly interested in advice on whether the cost of complying with proposed rules in the first year after the rules take effect will exceed \$25,000 for any small business or small city. [A small business is a business (either for profit or non-profit) with fewer than 50 full-time employees and a small city is a city with fewer than ten full-time employees.] MDH also seeks advice on the cumulative effect of the rule has with regard to other federal and state regulations related to the specific purpose of the rule.

**Statutory Authority.** *Minnesota Statutes*, section 144.894(k), requires the Department to adopt all rules necessary to carry out the provisions of sections 145.891 to 145.897 (the Maternal and Child Nutrition Act of 1975). *Minnesota Statutes*, section 144.11, authorizes the Department to adopt reasonable rules necessary to carry out the provisions of section 144.10.

**Public Comment.** Interested persons or groups may submit comments or information on these possible rules in writing or orally until further notice is published in the State Register that the Department intends to adopt or to withdraw the rules. The Department will not publish a notice of intent to adopt the rules until more than 60 days have elapsed from the date of this request for comments. The Department will seek comment on the planned rules from its established WIC Vendor Advisory Group. The Department hopes that the WIC Vendor Advisory Group will complete its review of the planned rules by the end of July 2016.
