NOTICE

How to Follow State Agency Rulemaking Action in the State Register

State agencies must publish notice of their rulemaking action in the *State Register*. If an agency seeks outside opinion before promulgating new rules or rule amendments, it must publish a NOTICE OF INTENT TO SOLICIT OUTSIDE OPINION. Such notices are published in the OFFICIAL NOTICES section. Proposed rules and adopted rules are published in separate sections of the magazine.

The PROPOSED RULES section contains:

- Calendar of Public Hearings on Proposed Rules.
- Proposed new rules (including Notice of Hearing and/or Notice of Intent to Adopt Rules without A Hearing).
- Proposed amendments to rules already in existence in the Minnesota Code of Agency Rules (MCAR).
- Proposed temporary rules.

The ADOPTED RULES section contains:

- Notice of adoption of new rules and rule amendments (those which were adopted without change from the proposed version previously published).
- Adopted amendments to new rules or rule amendments (changes made since the proposed version was published).
- Notice of adoption of temporary rules.
- Adopted amendments to temporary rules (changes made since the proposed version was published).

All ADOPTED RULES and ADOPTED AMENDMENTS TO EXISTING RULES published in the *State Register* will be published in the Minnesota Code of Agency Rules (MCAR). Proposed and adopted TEMPORARY RULES appear in the *State Register* but are not published in the MCAR due to the short-term nature of their legal effectiveness.

ADOPTED RULES

The adoption of a rule becomes effective after the requirements of Minn. Stat. § 15.0412, subd. 4, have been met and five working days after the rule is published in the *State Register*, unless a later date is required by statutes or specified in the rule.

If an adopted rule is identical to its proposed form as previously published, a notice of adoption and a citation to its previous State Register publication will be printed.

If an adopted rule differs from its proposed form, language which has been deleted will be printed with strike outs and new language will be underlined, and the rule's previous *State Register* publication will be cited.

A temporary rule becomes effective upon the approval of the Attorney General as specified in Minn. Stat. § 15.0412, subd. 5. Notice of his decision will be published as soon as practicable, and the adopted temporary rule will be published in the manner provided for adopted rules under subd. 4.

81-726/Sp. State of Minnesota v. Jerome Scott Zuehlke, Appellant. Faribault County.

Where a person is separately charged in county court and in district court for offenses which were committed in a unitary course of criminal conduct, the defendant's conviction of one of the offenses ordinarily will operate as a bar to continuing the prosecution of the other offense.

Conviction vacated. Otis, J.

81-889 State of Minnesota v. Charles L. Nading, Appellant. Big Stone County.

Under the circumstances of this case the fact that defendant was ordered to lie on the ground did not convert what was intended to be a temporary detention into an arrest.

Affirmed. Otis, J.

81-145/Sp. Lee H. Schander v. Northern States Power Company, et al., Relators. Workers' Compensation Court of Appeals.

The coverage of the Workers' Compensation Act does not extend to an employee while returning to his home from a retraining course, and injuries sustained in an automobile accident during such travel are not compensable.

Reversed. Otis, J.

81-954 Richard Novitsky, Relator, v. Department of Natural Resources, Commissioner of Economic Security. Department of Economic Security.

Wages which are "due and payable but not paid," Minn. Stat. § 268.04, subd. 26 (1980), includes wages earned by an employee before the effective date of a claim for unemployment compensation benefits but paid thereafter.

Reversed. Otis, J.

81-888/Sp. Norbert Osendorf v. American Family Insurance Company, Appellant. Stearns County.

Evidence was sufficient to support jury findings of misrepresentation and negligence.

Illegal employment exclusion in insurance policy requires factual determination of whether certain farm employment was "dangerous" within the meaning of applicable statute.

Affirmed in part, reversed and remanded in part. Peterson, J.

81-168 State of Minnesota v. Andrew Luna, Appellant. Freeborn County.

Evidence was sufficient to support conviction of criminal sexual conduct in the first degree.

Trial court did not commit prejudicial error in admitting *Spreigl* evidence or in requiring state's rebuttal witness, who had earlier testified for the defense, to retake the oath before she testified again.

Trial court properly departed from presumptive sentence established by Minnesota Sentencing Guidelines and Commentary, 1980.

Affirmed. Yetka, J.

81-934, 81-997 Bernette Minogue, widow of Rebert J. Minogue, Relator, v. City of St. Paul (self-insured), and State Treasurer, Custodian of the Special Compensation Fund. Workers' Compensation Court of Appeals.

Under the law in effect on July 12, 1978, dependents of an employee are not entitled to recover workers' compensation disability benefits that were not paid to the employee prior to his death.

The matter of attorneys' fees is remanded because the record does not contain fully adequate information to justify the fee. Affirmed in part, remanded in part. Scott, J.

81-1105 Victor H. Nibbe, Relator, v. City of St. Paul (Self-Insured). Workers' Compensation Court of Appeals.

The finding that employee intended to and did retire from an active labor market at the age of 65 does not have sufficient evidentiary support since consideration of the evidence as a whole and the reasonable inferences permissible therefrom clearly requires reasonable minds to adopt a contrary conclusion.

Reversed. Scott, J.

81-199/Sp. James I. Posz, Appellant, v. State of Minnesota. Hennepin County.

District court properly denied postconviction petition for resentencing according to the Minnesota Sentencing Guidelines where petitioner failed to meet his burden of proving that his early release from sentence would not present a danger to the public and would not be incompatible with the welfare of society.

Affirmed. Amdahl, C. J.

Decisions Filed Friday, May 28, 1982

82-206/Sp. Dennis Marlowe Hanson, petitioner, Appellant, v. State of Minnesota. Hennepin County.

District court justifiably refused to find that petitioner's early release from sentence would not present a danger to the public and would not be incompatible with the welfare of society, and therefore the court properly denied the petition for resentencing according to the Minnesota Sentencing Guidelines.

Affirmed. Amdahl, C. J.

82-324/Sp. State of Minnesota v. Paul Walter Boman, Appellant. Pennington County.

District court properly denied petition for resentencing according to the Minnesota Sentencing Guidelines where petitioner failed to meet his burden of proving that his early release would not be incompatible with the welfare of society.

Affirmed. Amdahl, C. J.

STATE CONTRACTS=

Pursuant to the provisions of Minn. Stat. § 16.098, subd. 3, an agency must make reasonable effort to publicize the availability of any consultant services contract or professional and technical services contract which has an estimated cost of over \$2,000.

Department of Administration procedures require that notice of any consultant services contract or professional and technical services contract which has an estimated cost of over \$10,000 be printed in the *State Register*. These procedures also require that the following information be included in the notice: name of contact person, agency name and address, description of project and tasks, cost estimate, and final submission date of completed contract proposal.

Department of Administration State Building Construction Division

Nctice of Availability of Contracts for Registered Professional Testing Services

The Department of Administration (DOA) intends to retain the services of qualified professionally registered individuals to conduct site surveys, materials testing and soil borings and tests during the year commencing July 1, 1982. These projects will be varied in nature and scope. The fees associated with these projects will generally be less than \$2,000.00 although the fees for some projects may exceed this amount.

As projects arise, it is the intention of DOA to contact firms who have expressed an interest in providing such services to the state. The final selection will be made on the basis of the background and experience of the firm, the geographic proximity of the firm to the project site, and an estimate of the fees to be charged for the specific project. Such estimates will be requested when a specific project exists.
