Laws of Minnesota 1937, Chapter 234, Laws of North Dakota 1937, Chapter 258, and Laws of South Dakota 1937, Chapter 262, were concurrent acts of the legislatures of the three states, providing for a compact between the said states authorizing the creation of the Tri-State Waters Commission. The compact was signed by the governors of the three states June 23, 1937, and was consented to by an Act of Congress dated April 2, 1938, Public No. 456 - 75th Congress; Chapter 59-3d Session-S. 1570.
