ABSENT AND DISABLED VOTERS

203.01 ABSENT AND DISABLED VOTERS MAY VOTE BY MAIL.

This section is applicable to a city election in a city of the fourth class operating under a home rule charter. "Any city election" is not restricted to city elections held solely for the purpose of electing city officers. 1928 El. Op. 195.

If a person who takes advantage of the absent voters law dies before election day and this fact is known to the election judges, his ballots should not be deposited by the election judges in the appropriate ballot boxes. 1928 El. Op. 197.

A person confined in jail for a misdemeanor may cast his ballot under the absent voters law. 1930 OAG 229.

It was not the legislative intent that this section should apply to village elections. The election machinery in villages is not readily adapted to the provisions of the absent voters law. The word "city" was used by the legislature in its limited meaning and does not include villages. 1928 El. Op. 196.

The absent voters law does not apply to village elections. OAG Jan. 6, 1933. This section does not apply to special village elections. OAG June 24, 1933.

A citizen cannot vote by radio. OAG Oct. 24, 1934.

The soldiers voting act, Laws 1917, Chapter 68, is available to soldiers, 1940 OAG 89.

For a general discussion of the absent voters law, see 1934 OAG 400.

A soldier who regularly files for office may be legally elected though he is absent in service and is outside the state during the campaign and on election day. 1940 OAG 89, Aug. 5, 1940 (639e).

Section 203.01 may apply to city elections. OAG March 15, 1944 (639L).

Except by members of the armed forces, a voter's ballot may not be mailed from Alaska. OAG May 27, 1944 (639a).

Ballots may not be mailed from Europe. 1928 OAG 182.
