WAREHOUSES IN CERTAIN CITIES AND VILLAGES

231.01 DEFINITIONS.

The railroad and warehouse commission determine as a question of fact whether or not a certain person is a warehouseman. OAG Nov. 2, 1934 (645b-21).

Where merchandise brokers maintain a warehouse for the convenience of customers, a broker is a warehouseman. OAG Nov. 27, 1934 (371b-14).

A federal bonded warehouse is not within the purview of this act. 1936 OAG 441, May 24, 1934 (645b-25).

A company operating "field" warehouses on the premises of manufacturers desiring to borrow money on their commodities is a "warehouseman." OAG May 1, 1936 (645b-21).

Warehouses are public utilities when under control of the railroad and warehouse commission. OAG March 13, 1944 (371b-14).

Chapter 231, continues to operate as to both owner and operator when a key to the space occupied by the owner of the property is placed with him. OAG Aug. 29, 1944 (645b-25).
