STORAGE OF GRAIN ON FARMS

Greer sought to obtain a government loan from the Commodity Credit Corporation on 300 bushels of corn being his share rental which is stored in a bin on the farm. He made application for the loan and the corn was located and sealed in the bin and warehouse certificates were issued against it by the state grain inspection department pursuant to the farm grain warehousing act. Before any loan was made on the corn, the warehouse receipts which had been issued against it were lost either by Mr. Greer or they went astray in the office of the Commodity Credit Corporation. If procedure is taken under section 227.14, it would be necessary to give a bond to protect the warehouseman even though the warehouseman and the owner of the grain are the same person. 1934 OAG 730, June 2, 1934 (215c-9).
