# 248.02 SCHOOL FOR THE DEAF; WHO MAY BE ADMITTED; EXPENSES.

County of legal settlement of parent with whom minor is residing is responsible for payment of \$50.00 at school for the deaf or blind under this section. OAG June 11, 1934.

The ordinary laws relating to poor relief have no application to the placing of a deaf girl in the state school for the deaf at Faribault, and the county of residence and not the county of settlement is liable for the maintenance of the child. OAG Sept. 3, 1931.

The cost of an emergency operation performed on a deaf child in the state school for the deaf is chargeable to the municipality in which the child has his settlement for poor relief purposes. OAG Dec. 12, 1933.

Where a minor was admitted to the school for the deaf from one county and thereafter parents separated and the father took up residence in another county, where the child visited him in the summer time, the latter county was liable for the support of the child, the father being indigent. OAG June 11, 1934 (3320).

"Residence" means "settlement" under the poor laws. OAG Sept. 15, 1934 (339d-1).

County in which parent of child committed to the state school for the deaf has settlement is liable for the support of the child, whether under the county or town system of poor relief. OAG Aug. 29, 1935 (339d).

County cannot pay claim for care of deaf minor at a school other than that for the deaf at Faribault. OAG June 2, 1936 (482h).

Payment by county must be used for pupil while in school and not for pauper relief purposes after the pupil has left the school. OAG June 24, 1936 (88a-5).

If the director of social welfare spends any money on behalf of the blind for medical examination, corrective surgery and the like it must be from money received from the federal government. The state has made no appropriation for such expenditures. OAG April 9, 1944 (9a-10).

The state board of control (director of public institutions) does not have the legal authority to send a deaf and blind child to a private institution and pay therefor, though there is only one such pupil in the Minnesota school for the deaf. OAG April 11, 1937 (482a).
