Board of control (director of social welfare) has no control over the inmates of a maternity hospital unless they are under commitment, and there is no law compelling or prohibiting work to pay for confinement. OAG Feb. 1, 1937 (88a-27).

Ex. Laws 1919, Chapter 50, is not unconstitutional, as embracing more than one subject within Article 4, Section 27, of the Constitution. The statute is a police regulation. Its purpose is to secure the health, comfort, and well-being of the inmates of the hospital and to safeguard the interests of the public. State v Women's and Children's Hospital Assn. 150 M 247, 184 NW 1022.

Ex. Laws 1919, Chapter 50, authorizes the director of social welfare to grant a license for a maternity hospital even though a city council may refuse to grant it a license. OAG Nov. 18, 1922.
