#### 31.02 UNLAWFUL TO SELL CERTAIN FOODS.

In an action to recover damages for injuries to plaintiff caused by eating impure food purchased at defendant's bakery, there was a proper recovery. Cermak v Sevcik, 211 M 432, 1 NW(2d) 399; 215 M 203, 9NW(2d) 508.

Sale by farmer. A farmer who sells a steer to another who he knows intends to butcher it for food cannot be prosecuted for selling deleterious food when the animal is later found to be tubercular. 1924 OAG 101.

Since the adoption of the federal rules of civil procedure a complaint is not defective merely because it joins causes of action in tort and in contract. Federal Rules Service, Page 238.

Brief at length on constitutionality of delegation of power by the legislature permitting the commissioner to make rules and regulations having the force and effect of law. 1942 OAG 85, Feb. 18, 1942 (135-B-1).

While the provisions of sections 31.02 to 31.17 and 31.28 to 31.43 broaden the duties of the county attorney, he is not required to act as a police officer or detective or to institute criminal proceedings unless evidence or information is furnished to him. 1942 OAG 189, Nov. 10, 1942 (121B-7).

The offering for sale of confectionery labeled "gems, rum and butter", which was artificially flavored, but contained no rum or butter, is illegal. OAG June 9, 1944 (135b-5).

Courts may refrain from exercising power to render an in personam judgment against parties before court in an in rem proceeding if by doing so it would impair substantial rights, but where it will further the ends of justice and eliminate multiplicity of actions, and save expense to the parties, the power should be invoked. United States v 184 Barrels of Dried Eggs, 53 F. Supp. 652.

Foods Inc., 2 FRD 238.
