CONSTITUTIONALITY. This statute violates the liberty of contract guaranteed by the 14th amendment. *Fairmont Cry. Co. v Minn.*, 274 U. S. 1, 47 Sup. Ct. 506, 71 L. Ed. 894, reversing 168 M 378, 210 NW 163, 608, affirming 162 M 146, 202 NW 714, 42 ALR 548 and note.

The power of a state to regulate business in the public interest extends to control and regulation of prices for which commodities may be sold, where price regulation is a reasonable and appropriate means of rectifying the evil calling for the regulation. *Nebbia v New York*, 291 US 553.

A city cannot compel the pasteurization within the city of all pasteurized dairy products sold therein. *State ex rel v City of Minneapolis*, 190 M 138, 251 NW 121.

A city can charge a reasonable fee for inspection of herds and milk, 1936 OAG 20; but see *City of St. Paul v Peck*, 78 M 497, 81 NW 392 and *State v Elofson*, 86 M 103, 90 NW 309, decided under a similar earlier statute, which held that the city could exact no fee.
