AERONAUTICS

Sections 360.01 to 360.53 repealed by Laws 1943, Chapter 653, Section 24. Laws 1943, Chapter 653, Sections 3 to 19, repealed by Laws 1945, Chapter 303, Section 38.

Following are annotations relating to laws prior to enactment of Laws 1943, Chapter 653.

A city may by ordinance require a permit to carry on an occupation liable to become a nuisance in certain localities. State v Dirnberger, 152 M 44, 187 NW 972; State v Amor, 153 M 244, 190 NW 59; Meyers v City of Minneapolis, 154 M 238, 189 NW 709, 191 NW 609.

Special Laws 1879, Chapter 338, was not an indivisible act, and it was repealed in part by General Laws 1919, Chapter 252. This did not contravene Minnesota Constitution, Article 4, Section 33. Taxation for municipal purposes is purely a matter of municipal concern, and it was within the powers of the electors of the city of Minneapolis to withdraw the city from the operation of Laws 1879, Chapter 338, by the adoption of a home rule charter. State ex rel v Erickson, 157 M 200, 195 NW 919.

As the record does not disclose a contract between plaintiff and defendant, there can be no recovery for injuries received in an emergency landing made by a plane operated by another company. Roberts v Northwest Airlines, Inc., 201 M 89, 275 NW 410.

Airplanes are taxed as personal property. OAG March 30, 1931.

Relating to payment of license fees "air schools" include schools furnishing training in either flying or ground instruction. 1934 OAG 344, May 21, 1934 (234d).

A city or village may erect poles and lines outside the corporate limits for the purpose of lighting an airport without submitting the propostion to the voters. 1934 OAG 48, Dec. 27, 1934 (234b).

City council may acquire land outside the city limits for an airport without submission of the question to the voters. 1934 OAG 128, Jan. 11, 1934 (234b); 1934 OAG 77, Aug. 3, 1934 (817f); OAG May 20, 1939 (59a-40).

The classification of airports for contiguous cities of the first class, as distinguished from single cities or non-contiguous ones, was justified as based on a substantial distinction germane to the subject matter. Authorizing, transfer without compensation, by the park board of a municipal airport to the commission is not a violation of Minnesota Constitution, Article 1, Section 13. Monaghan v Armatage, 218 M 108, 15 NW(2d) 241.
