40.07 POWERS OF DISTRICTS AND SUPERVISORS.

Where the district holds an easement from landowners, it may enter into a cooperative agreement with the game and fish department, for improvement of a trout stream. OAG April 14, 1944 (208b-4).

Supervisors are not liable in damages for injuries resulting, except where there is evidence of negligence in which the supervisor personally participated. OAG June 28, 1944 (705a-8).

A soil conservation district may not enter into a contract with a town relative to cleaning a ditch. OAG Feb. 16, 1945 (705a).
