A vacancy in the office of assessor in the village of Litchfield must be filled by a special election. OAG April 14, 1932.

A village assessor should be paid the same compensation as a town assessor. OAG Dec. 22, 1933.

The village council may authorize the payment of the expenses of the village assessor when attending the school for assessors at the State university, under the direction of the tax commissioner. 1942 OAG 187, Nov. 13, 1941 (12-B-1).

The village of Golden Valley adopted civil service for its police force Jan. 1, 1941. Prior to that date by resolution all employees were notified they were temporary employees. Such notice was without effect. All employees as of Jan. 1, 1941, were blanketed in. 1942 OAG 202, Oct. 8, 1941 (788-E-2).

Where town and village constitute a single election and assessment district, the assessor must be paid by the town. OAG July 21, 1944 (12c-1).
