A city of the third class, such as South St. Paul, operating under a home rule charter, need not establish police pensions under sections 1436 to 1442 (423.01 to 423.07) but may establish pensions for all city employees under section 254-23 (353.01), et seq. OAG Aug. 19, 1936 (785j).

Pension and retirement acts are remedial in nature and are entitled to a liberal construction which will meet the essential legislative purpose. That part of Laws 1915, Chapter 199, Section 9, reading: "return to the work of teaching in said public schools", is construed to mean a return to the work of teaching in the public schools of the state of Minnesota. *Mattson v Flynn*, 216 M 354, 13 NW(2d) 11.

subsequently come within its classification, or because it keeps permanently within its provisions a city which has elected to come under them, regardless of its subsequent change of status. Nichols v City of Eveleth, 204 M 352, 283 NW 539.

A resolution of city council adopted October 22, 1935, to take effect as of July 1, 1936, became operative at once upon adoption, and it is doubtful whether the council may suspend or rescind the resolution by July 1, 1936. OAG June 25, 1936 (336).
