A municipality may not exact more from one charged with an assessment for the extension of its gas and water mains than is permissible under the terms of the ordinance under which the extension was made, and where excess payments have been exacted, the municipality may be held as for money had and received. Sloan v City of Duluth, 194 M 48, 259 NW 393.

A village may extend its water-works system to connect with its own cemetery outside its limits. OAG May 31, 1933.

The Stillwater board of water commissioners may contract with persons living outside the corporate limits for the distribution of water and fix the price and the rates therefor. OAG July 6, 1937 (59b-13).

Water pipes may extend beyond village limits but except as a health measure, sewers may not so extend. OAG Aug. 25, 1944 (624d-11); OAG Oct. 23, 1944 (59a-36).
