## CHAPTER 491

### CONCILIATION COURTS

#### 491.01 CONCILIATION AND SMALL DEBTORS COURTS.

Nothing in this chapter shall be construed as repealing, amending, or modifying the provisions of Laws 1917, Chapter 263, amended by Laws 1925, Chapter 90, relating to Minneapolis. See Laws 1925, Chapter 17, creating small debtors court in Duluth.

Laws 1921, Chapter 525, Section 3, as amended refers to the conciliation court of St. Paul.

Notwithstanding the law provides no appeal from the municipal court of Minneapolis on judgments rendered in controversies appealed from the conciliation court, the writ of certiorari is available for review. Ridgeway v Vaughan, 187 M 552, 246 NW 115; Goodrich v Pratt, 198 M 259, 269 NW 464.

Judgments in the conciliation court of Minneapolis are judgments in the municipal court and laws relating to enforcement of municipal courts apply. 1918 OAG 158, Dec. 3, 1917.
