# 56.12 LIMITATIONS ON ADVERTISING; TAKING OF SECURITY; PLACE OF BUSINESS.

A parent foreign corporation having no license to conduct a small loan business under section 56.12, but owning all the stock of defendant, a subsidiary corporation organized under section 56.12, has no right to intervene in this action brought by plaintiff licensed under said law to conduct its business in the same city as defendant.

It being shown that because of defendant's name, window, and neon signs, and the advertising of its business, mail and telephone messages intended for the plaintiff went to the defendant, and mail and telephone messages intended for the defendant came to the plaintiff.
