CHAPTER 138

HISTORICAL SOCIETY: HISTORIC SITES: ARCHIVES

NOTE: Minnesota Historical Society is a corporation created by L. 1849 c. 44, as amended by L. 1856 c. 15. Laws 1878 c. 97 attached to the state appropriation for the society a proviso that before the sum appropriated be made available a determination be had before a competent tribunal determining which group claiming control were legally entitled to manage the affairs of the society. The dispute was determined by the decision in State v Sibley, 25 M 387. The court found that the charter of the society was an executed contract between the state and the incorporators; the society is a private corporation of an eleemosynary character, incorporated for the purpose of perpetuating the application of the bounties or donations received. It is not a department of the state. The corporation was made a state agency by L. 1925 c. 426, art. 19 s. 1.

The Minnesota historic sites and marker commission was created by L. 1941 c. 418; and the Minnesota State Archives Commission by L. 1947 c. 547.
