

CHAPTER 154

BARBERS

154.01 BARBERS MUST BE REGISTERED.

It must be accepted as settled law in this state that the trade or vocation of barbers as well as that of beauty culturists has such relation to public health that in virtue of the police powers of the state it may be regulated and those engaged therein licensed. State v Zeno, 79 M 80, 81 NW 748; Luzier'v State Board, 189 M 151, 248 NW 664; State v DeGuile, 160 M 191, 199 NW 569; Johnson v Ervin, 205 M 84, 285 NW 77.

Barber employed at veterans hospital must be registered and licensed. OAG April 19, 1933 (33-A-3).

154.02 WHAT CONSTITUTES BARBERING.

Orderlies in hospitals may under certain circumstances shave or cut hair, but not for beautification purposes. OAG March 29, 1940 (33-A-1).

154.03 APPRENTICES MAY BE EMPLOYED.

There is no statutory regulation forbidding any person from owning a barber shop but only a registered and licensed barber may conduct it. OAG July 27, 1932 (33-A-1).

154.065 BARBER SCHOOLS AND COLLEGES.

Persons employed as instructors in barber schools prior to enactment of L. 1945 c. 159, upon return from service in the armed forces are not entitled to license without examination. OAG March 14, 1946 (33-A-6).

Only two examinations per year are authorized for applicants for license to instruct in barber schools. OAG June 26, 1946 (33-A-8).

154.07 QUALIFICATION OF STUDENTS IN BARBER SCHOOLS.

Person must have had ten years of continued experience in the barber trade before a permit may issue authorizing him to teach the barber trade in a public school vocational department. OAG June 19, 1941 (33-A-8).

154.10 CERTIFICATES OF REGISTRATION.

154.11 PERMITS TO PRACTICE.

154.15 CERTIFICATES MUST BE RENEWED ANNUALLY.

A barber whose license had been revoked for cause must pass a new examination as one of the requirements for new license. OAG March 3, 1944 (33-A-3).

154.23 OFFICERS; COMPENSATION.

The salary increases permitted under L. 1945, c. 609, s. 49, subdivisions 1 and 2, do not apply to officers or employees of the board of barber examiners. OAG July 10, 1946 (33-a-3).

154.24 RULES AND REGULATIONS.

Barber's license may be revoked for failing to comply with reasonable order given by the barber inspector. OAG April 19, 1933 (33-A-3).

Rules proposed by the state board of barber examiners must receive the approval of the state board of health before adoption. OAG June 10, 1946 (33-A-3).
