Licenses issued under sections 32.09 and 32.23 do not lapse upon the death of the licensee but pass to the legally appointed representative who continues to operate the business. OAG Sept. 30, 1946 (292-C).

32.21 MILK AND CREAM

The fact that a farmer processes the raw milk produced on his farm does not preclude it being a farm and dairy product within the meaning of the above section; and the product may be transported for sale or delivery in a truck under a "T" license, and irrespective of zoning provisions. OAG Feb. 10, 1948 (622-E-35).

Fines collected under section 32.21 are payable to the county treasurer and not to the state treasurer. OAG May 10, 1951 (135-A-4).

The council of the city of Pipestone has authority to enact an ordinance requiring a license from vendors of milk; but would have no authority to prohibit the sale of milk by dairies because they had no retail establishment in the city nor could they refuse to grant a license for such reason. If the product of the outside dairy meets the requirements of the state board of health, they are permitted to sell within the city even though their place of business is outside the city limits. OAG June 6, 1950 (292-C).

City ordinance prohibiting sale of milk not pasteurized within five miles of the city as a discriminatory burden on interstate commerce. 35 MLR 489.

An ordinance providing that all milk sold in the city must be pasteurized within the city limits is unconstitutional. OAG Jan. 14, 1948 (292-C).

The department of health has authority to employ milk sanitarian for the purpose of cooperating with the department of agriculture in certifying to other states the quality of export milk. OAG March 22, 1950 (292-F).

Under the provisions relating to standards for milk purchased for manufacturing purposes a processor must adhere to the grades established by the commissioner. He has the right to require higher standards and specifications and to pay a premium price for the same. OAG Aug. 30, 1949 (292).

Fines collected under section 32.491 shall be paid to the treasurer of the county where incurred, and not to the state treasurer. OAG Aug. 15, 1950 (199-B-4).

When a resident of Minnesota purchases cream in Iowa, he is not required to follow the provisions of section 32.491 or regulations of the department of agriculture adopted pursuant thereto. OAG Nov. 19, 1952 (135-A-3).
