Generally statutes take precedence and control over charter provisions. The provisions or sections 197.45 and 197.46 control and create in a veteran applicant for the position, a veteran's right and preference. OAG Feb. 3, 1948 (85.A) (120).

Pensions and retirement allowances to municipal employees are not gratuities to those who rendered service to the city after the enactment of the law creating such grants. State ex rel v City of Minneapolis, 174 M 594, 219 NW 924.

The Pension Act is applicable to the city of Minneapolis, insofar as it requires compulsory retirement of certain city employees at the age of 65, is subject to the terms and conditions of the veterans preference law, and veterans can only be

separated from the service of the city in conformance with the veterans preference law. OAG May 19, 1953 (85-A).

Employment by the Minneapolis-St. Paul Sanitary District is covered by the veterans preference law and notwithstanding the retirement provisions of section 422.01 of the Pension Act applicable to them, cannot be compelled to retire against their wishes regardless of age and can only be separated from their employment in conformity with the veterans preference law. OAG June 17, 1953 (85-A).
