### TABLE I. LOCAL AND SPECIAL ACTS

Special laws, now in effect, relating to courts or governmental units, and laws appearing to relate to local governmental units, enacted at regular or extra sessions from 1955 to 1965.

Except for acts coded in Minnesota Statutes 1965, this table includes the following categories of acts:

1. Acts relating to courts enacted pursuant to Minnesota Constitution, Article VI. (Acts relating to courts which contain a local approval clause are included regardless of whether local approval has been filed with the secretary of state);
2. Acts appearing to apply to local governmental units which do not contain a local approval clause;
3. Acts applying to local governmental units which contain a local approval clause if:
  - (a) The law was passed in the 1959 regular legislative session before the passage of Laws 1959, Chapter 368, regardless of whether local approval has been filed with the secretary of state; or if
  - (b) The law was passed in the 1959 regular or extra session after the passage of Laws 1959, Chapter 368, and all local approvals required by the particular act have been filed with the secretary of state; or if
  - (c) The law was passed in the 1965 session.
