(3) Sufficient copies of the agreement, certified as prescribed by clause (2), shall be furnished to enable the secretary of state to comply with the provisions of this chapter with respect to filing the agreement of merger or consolidation.

317.37 Time effective

Upon the issuance of the certificate of merger or the certificate of consolidation and incorporation by the secretary of state, the merger or consolidation is effective, or shall become effective upon such later date, or date and hour, not more than 31 days after the issuance of the certificate of merger or the certificate of consolidation and incorporation by the secretary of state, as may be specified in the agreement of merger or consolidation.

319A.01 Professional Corporations Act; citation

Sections 319A.01 to 319A.22 may be cited as "The Minnesota Professional Corporations Act".

319A.02 Definitions

Subdivision 1. For the purposes of sections 319A.01 to 319A.22 the terms defined in this section have the meanings given them.

Subd. 2. "Professional service" means personal service rendered by a professional pursuant to a license or certificate issued to him by the state of Minnesota pursuant to sections 147.01 to 147.29, 148.01 to 148.101, 148.52 to 148.62, 150A.01 to 150A.12, 156.001 to 156.14, 326.17 to 326.23, or 481.01 to 481.17, or a license or certificate issued to him by another state pursuant to similar laws.

Subd. 3. "Professional" means a natural person who is licensed by the laws of the state of Minnesota or similar laws of another state to render professional service.

Subd. 4. "Professional corporation" means a corporation organized under sections 319A.01 to 319A.22 for the purpose of rendering professional service.

Subd. 5. "Foreign professional corporation" means a corporation organized under laws other than the laws of this state for a purpose for which a professional corporation may be organized hereunder.

Subd. 6. "Board" means an agency of the state of Minnesota which has jurisdiction to grant a license to render professional service of a type which a professional corporation is authorized to render. In the case of a professional corporation formed to practice law, "board" means the board of professional responsibility.

319A.03 Formation of corporation

One or more natural professional persons may form a corporation pursuant to chapters 301 or 317 for the purposes hereinafter set forth.
