CHAPTER 341. BOXING COMMISSION

341.01 Creation

There is hereby created the state boxing commission, to consist of seven commissioners, citizens of this state, two of whom shall be public members as defined for purposes of Laws 1973, Chapter 638, who shall be appointed by the governor and hold office for a term of three years, except as hereinafter provided, and until their successors are appointed and have qualified.

341.02 Governor to appoint

The governor shall appoint as members of this commission one commissioner for a term of one year, two commissioners for a term of two years, and two commissioners for a term of three years, such term to commence on the first day of the month following such appointments. The initial public members appointed to the board shall serve two and three year terms respectively, such terms to commence on the first day of the month following such appointment. Any vacancy in office shall be filled by appointment by the governor for the unexpired portion of the term. No commissioner shall directly or indirectly promote any boxing or sparring exhibition or directly or indirectly engage in the managing of any boxer or be interested in any manner in any proceeds from any boxing match.

341.03 Compensation; expenses

Each commissioner shall receive \$35 for each meeting of the commission he attends, plus ordinary and necessary expenses in the same amount and manner as state employees, but he shall not be paid for attending more than 22 such meetings in any calendar year.

The commission shall pay into the state treasury all moneys collected by it. The expenses of administering sections 341.01 to 341.15 shall be paid for from appropriations made to the state boxing commission.

CHAPTER 343. PREVENTION OF CRUELTY

343.11 Acquisition of property, appropriations

Every county society for the prevention of cruelty to children and animals may acquire, by purchase, gift, grant, or devise, and hold, use, or convey, real estate and personal property, and lease, mortgage, sell, or use the same in any manner conducive to its interest, to the same extent as natural persons.

MINNESOTA STATE RETIREMENT SYSTEM 352.01

The county board of any county, or the council of any city or village, in which such societies exist, may, in its discretion, appropriate for the maintenance and support of such societies in the transaction of the work for which they are organized, any sums of money not otherwise appropriated, not exceeding \$4,800 in any one year; provided, that no part of the appropriation shall be expended for the payment of the salary of any officer of the society.

352.01 Definitions

[For text of subds. 1 to 2A, see M.S.1971]

Subd. 2B. Excluded employees. The following persons are excluded from the meaning of state employee:

- (1) Elective state officers;
- (2) Students employed by the University of Minnesota, the state colleges, and state junior colleges unless approved for coverage by the board of regents, the state college board or the state junior college board, as the case may be;
- (3) Employees who are eligible to membership in the state teachers retirement association except employees of the department of education who have elected or may elect to be covered by the Minnesota state retirement system instead of the teachers retirement association;
- (4) Employees of the University of Minnesota who are excluded from coverage by action of the board of regents;
- (5) Officers and enlisted men in the national guard and the naval militia and such as are assigned to permanent peacetime duty who pursuant to federal law are or are required to be members of a federal retirement system;
 - (6) Election officers;
- (7) Persons engaged in public work for the state but employed by contractors when the performance of such contract is authorized by the legislature or other competent authority;
- (8) Officers and employees of the senate and house of representatives who are temporarily employed and those employees of the legislative research committee who are intermittently employed when needed;
- (9) All courts and all employees thereof, referees, receivers, jurors, and notaries public, except employees of the supreme court and referees and adjusters employed by the department of labor and industry;
- (10) Patient and inmate help in state charitable, penal and correctional institutions including the Minnesota veterans home;
