Minnesota Statutes 2013 Supplement supplements Minnesota Statutes 2012. It contains the laws of a general and permanent nature enacted at the 2013 Regular Session of the 88th legislature. No laws of a general and permanent nature were enacted at the 2013 First Special Session of the 88th legislature.

Laws that amend sections or subdivisions in Minnesota Statutes 2012 are published with the numbers of the amended sections and subdivisions. When all subdivisions of a particular section are not included in this supplement, their omission is indicated in the following manner: [*For text of subds 3 and 4, see M.S. 2012*]. New laws have been classified and numbered in conformity with the numbering system of Minnesota Statutes. Repeals of sections and subdivisions of Minnesota Statutes 2012 are shown. In addition, revisor's instructions enacted in the 2013 session have been implemented and those sections are added to the supplement. Finally, notes have been updated where necessary. At the beginning of each chapter of the supplement is a list of the sections that are included.

A table of allocation of 2013 acts is included in Volume 13 listing section numbers of enactments published for the first time in this supplement. If the coding of a section has been changed from the coding shown in Laws 2013, or an uncoded section in Laws 2013 has been coded, an asterisk following the section number indicates that the coding is different from that shown in the session laws.

New statutory text in this supplement is indexed in Volumes 13 and 14.

Changes or additions to court rules since publication in Minnesota Statutes 2012 have been supplemented in Volume 15. Sentencing guidelines have been printed in their entirety.

The text of all laws and resolutions passed at the 2012 First Special Session of the 87th Legislature and the 2013 Regular Session of the 88th legislature has been published by the Office of the Revisor of Statutes in Laws of Minnesota 2013. The text of all laws and resolutions passed at the 2013 First Special Session of the 88th legislature will be published with Laws of Minnesota 2014.
